1 AMEND House Bill No. 1687, Page 1, Section 227.475, Line 5, by inserting after all of said section  
2 and line the following:

4 "227.774. The portion of State Highway 94 from State Highway TT to State Highway F in  
5 St. Charles County shall be designated as "George Washington Highway". The department of  
6 transportation shall erect and maintain appropriate signs designating such highway, with the costs to  
7 be paid by private donations.

8 227.775. The portion of State Highway F from State Highway 94 continuing west to Femme  
9 Osage Creek Road in St. Charles County shall be designated as "Daniel Boone Highway". The  
10 department of transportation shall erect and maintain appropriate signs designating such highway,  
11 with the costs to be paid by private donations.

12 227.785. The bridge on State Highway 21 crossing over the Current River in Ripley County  
13 shall be designated as "Ripley County Veterans Memorial Bridge". The department of  
14 transportation shall erect and maintain appropriate signs designating such bridge, with the costs to  
15 be paid by private donations.

16 227.787. The portion of Interstate 70 from Shreve Road continuing to Kingshighway  
17 Boulevard shall be designated as "Captain David Dorn Memorial Highway". The department of  
18 transportation shall erect and maintain appropriate signs designating such highway, with the costs to  
19 be paid by private donations.

20 227.796. The bridge on State Highway P crossing over Lindley Creek in Polk County shall  
21 be designated the "WWII Henry Archie Black Memorial Bridge". The department of transportation  
22 shall erect and maintain appropriate signs designating such bridge, with the costs to be paid by  
23 private donations.

24 227.808. The portion of Interstate 435 from the Kansas/Missouri state line continuing to  
25 Holmes Road in Jackson County shall be designated the "Police Officer Richard C Fleming  
26 Memorial Highway". The department of transportation shall erect and maintain appropriate signs  
27 designating such highway, with the costs to be paid by private donations.

28 227.809. The portion of State Highway 171 from State Highway Z continuing to State  
29 Highway 43 in Jasper County shall be designated the "Atomic Veterans Memorial Highway". The  
30 department of transportation shall erect and maintain appropriate signs designating such highway,

2 227.810. The portion of State Highway J from CST Service Road continuing west to State  
3 Highway U in Pemiscot County shall be designated the "Annistyn Kate Rackley Memorial  
4 Highway". The department of transportation shall erect and maintain appropriate signs designating  
5 such highway, with the costs to be paid by private donations.

6 227.811. The portion of State Highway 19 from Strube Road continuing north to Kimmich  
7 Road in Montgomery County shall be designated the "Russell Lee Burton Memorial Highway".  
8 The department of transportation shall erect and maintain appropriate signs designating such  
9 highway, with the costs to be paid by private donations.

10 227.812. The portion of State Highway P from State Highway 30 continuing north to State  
11 Highway 366 in St. Louis County shall be designated the "Firefighter Benjamin J Polson Memorial  
12 Highway". The department of transportation shall erect and maintain appropriate signs designating  
13 such highway, with the costs to be paid by private donations.

14 227.813. The portion of State Highway 291 from N.E. Cookingham Drive continuing south  
15 to Kansas Street in Clay County shall be designated the "Samuel C Houston Memorial Highway".  
16 The department of transportation shall erect and maintain appropriate signs designating such  
17 highway, with the costs to be paid by private donations.

18 227.814. The portion of U.S. 67 from Maple Street continuing to Perrine Road through the  
19 city of Farmington in St. Francois County shall be designated the "SP5 Billy J Meador Memorial  
20 Highway". The department of transportation shall erect and maintain appropriate signs designating  
21 such highway, with the costs to be paid by private donations.

22 227.815. The portion of U.S. 67 from Perrine Road continuing to Highway H through the  
23 city of Farmington in St. Francois County shall be designated the "WO1 Reginald D Cleve  
24 Memorial Highway". The department of transportation shall erect and maintain appropriate signs  
25 designating such highway, with the costs to be paid by private donations.

26 227.817. The portion of U.S. Highway 169 from State Highway VV continuing to State  
27 Highway DD in Clinton and Clay Counties shall be designated the "Championship Way". The  
28 department of transportation shall erect and maintain appropriate signs designating such highway,  
29 with the costs to be paid by private donations. This designation shall expire on December 31,  
30 2022."; and
