FISCAL ANALYSIS

ASSUMPTION

Officials from the Attorney General's Office, Department of Elementary and Secondary Education, and Department of Higher Education and Workforce Development each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **University of Missouri System** state Section 170.353 will have a minimal fiscal impact on the University of Missouri System, in the form of cost increases under \$100,000.

Officials from the **University of Central Missouri** state there is the potential for an indeterminate fiscal impact.

Oversight assumes this proposal limits the use of certain curriculums (including the 1619 Project) in school districts and institutions of higher education. If a school district fails to comply with this proposal, DESE is to withhold a maximum of ten percent of the monthly distribution of state formula funding to the education entity.

Oversight notes, per an <u>article</u> in the St. Louis Post-Dispatch, the University City School District utilized the 1619 Project in the Advanced Placement language arts class curriculum. Oversight notes the following monthly payment of state monies to the University City School District in the table below. If the school district failed to comply with the proposal, the state funding withheld is estimated at \$498,177 per fiscal year.

Oversight is uncertain if any institutions of higher education are utilizing the curriculums prohibited by the proposal. Oversight notes the following state appropriations for institutions of higher education in FY 2020:

Oversight assumes there could be a loss to colleges and universities that fail to comply with the requirements in the proposal. The penalty withheld would be ten percent of the distribution of state funding to the institution. Based amounts appropriated, a 10% penalty could exceed \$250,000.

Oversight received a limited number of responses from school districts, colleges and universities related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other school districts, colleges and universities were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in Oversight's database is available upon request.

FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill defines "curriculum implementing critical race theory" and prohibits public schools, state departments, or online instruction funded in any manner by the General Assembly from teaching, using, or providing students curriculum, instructional material, or assignments designed to teach components of critical race theory.

The bill directs the State Board of Education to monitor and inform publicly funded local education agencies and online programs of violations. Subsequent violations shall result in a withholding of funds from the entity.

The bill directs the Attorney General to determine if two or four year institutions of higher education that receive state funding are in compliance with the prohibition on the use of curriculum as outlined, with penalties for violation including the loss of funding.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
