HCS HBs 1657 & 1588 -- BREED-SPECIFIC REGULATIONS

SPONSOR: Hicks

COMMITTEE ACTION: Voted "Do Pass with HCS" by the Standing Committee on Local Government by a vote of 9 to 1.

The following is a summary of the House Committee Substitute for HB 1657 and 1588.

The bill specifies that the General Assembly occupies and preempts the entire field of legislation touching in any way the control or regulation of specific breeds of dogs. However, a village, town, city, or county can still prohibit dogs from running at large or to further control or regulate dogs within its boundaries so long as the ordinance, order, policy, or regulation is not breed specific. Any village, town, city, or county with a breed-specific order, ordinance, policy, or regulation in effect on August 28, 2022, will have until February 28, 2024, to bring it into compliance with these provisions. After that date, all such orders, ordinances, policies, or regulations are unenforceable.

This bill is the same as HCS HBs 2241 & 2244 (2020).

The following is a summary of the public testimony from the committee hearing. The testimony was based on the introduced version of the bill.

PROPONENTS: Supporters say that breed bans result in forceful separation of dogs from their loving families. Breed bans also result in loving dogs being stuck in shelters because they cannot be adopted in certain cities. Breeds are blamed when it should be owners who are blamed. These local ordinances essentially prohibit consumers from being able to own the breed of their choice.
