ASSUMPTION

§208.152 - MO HealthNet coverage of anti-obesity medications

Officials from the **Department of Social Services (DSS), MO HealthNet Division (MHD)** state this legislation applies to MO HealthNet however, the fiscal impact of this bill is unknown.

There are several limitations impacting the Department's ability to accurately estimate the fiscal note of this bill, including:

- It is unknown how many participants would begin utilizing an anti-obesity agent
- It is unknown how many participants may switch using a GLP-1 for diabetes to a GLP-1 for anti-obesity
- It is unknown how many participants would continue to utilize an anti-obesity agent long term
- It is unknown what rebates may be negotiated with the manufacturers of anti-obesity agents

The current bill is not needed to allow the Department to begin covering anti-obesity agents. The Department has the authority necessary to cover anti-obesity agents. Requiring the Department to cover anti-obesity agents may reduce the Department's ability to negotiate with manufacturers and make decisions necessary for the long term sustainability of the program.

FISCAL DESCRIPTION

This bill adds medically necessary anti-obesity medications to the list of covered services for which MO HealthNet payments will be made on behalf of all MO HealthNet participants, regardless of age. (§208.152)

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
