FISCAL ANALYSIS

ASSUMPTION

Section 227.867 – Memorial Highway

Officials from the **Missouri Department of Transportation (MoDOT)** state HB 2797 is estimated to have a total negative impact on the State Road Fund of \$4,000. This would be a one-time expense as the language requires MoDOT to fund this designation with no costs for sign fabrication and installation recouped through the participation fee. The estimated cost is \$2,000 per sign, with 2 total signs for this designation.

Oversight has no information to the contrary. Therefore, Oversight will present the fiscal impact of this proposal as provided by MoDOT.


FISCAL DESCRIPTION

This act designates "Patrolman Lane A. Burns Memorial Highway" in St. Francois County. Costs for the designation shall be paid by the Department of Transportation.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
