#### **ASSUMPTION**

§§195.417 and 579.060 – Limits on selling or purchasing specific drugs

Officials from the Department of Commerce and Insurance, the Department of Elementary and Secondary Education, the Department of Health and Senior Services, the Department of Public Safety - Missouri Highway Patrol, the Office of the State Public Defender, the Phelps County Sheriff's Department, the Kansas City Police Department, the St. Louis County Police Department, the Missouri Office of Prosecution Services and the Office of the State Courts Administrator each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other sheriffs and police departments were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

Oversight notes, per information from the Office of the State Courts Administrator, there were no guilty dispositions (class A misdemeanor) for Section 579.060 for the FY 2023 – FY 2020.
