**ASSUMPTION**

**§206.110 - Provisions relating to the powers of a hospital district board of trustees**

Officials from the **Department of Health and Senior Services**, the **Department of Higher Education and Workforce Development**, the **Office of the Secretary of State**, the **Kansas City Board of Elections**, the **Platte County Board of Elections**, the **St. Louis City Board of Election Commissioners** and the **St. Louis County Board of Elections** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

In response to similar legislation from the current session (SB 798), officials from the **Jackson County Board of Election Commissioners** assumed the proposal would have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other local election authorities, county commissioners and hospitals were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
