### ASSUMPTION

#### §311.660 – Persons found guilty of criminal offenses

Officials from the **Department of Public Safety - Division of Alcohol and Tobacco Control**, the **City of Kansas City**, the **City of La Monte**, the **City of O’Fallon**, the **City of Springfield**, and the **City of St. Louis** each assume the proposal will have no fiscal impact on their respective organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other cities and counties were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.




