## **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from the **Missouri Consolidated Health Care Plan (MCHCP)** state the language in the bill would affect MCHCP in that Express Scripts provides the utilization management of the MCHCP's prescription benefit. Based on the broadness of the language and lack of regulatory guidance, the step therapy programs currently in place for MCHCP could be negatively impacted. In CY 2020, step therapy saved MCHCP \$7.7 million and without an effective program, MCHCP estimates the fiscal impact to be up to a \$5.235 million cost in FY23 (6 months of CY2023), and \$11.83 million in FY24.

Since it is unknown if this legislation will impact MCHCP's step therapy programs, **Oversight** will range the fiscal impact as \$0 (step therapy programs are not impacted) or a cost split between the General Revenue Fund, Federal Funds and Other State Funds as listed below (step therapy programs are impacted).

Officials from the Department of Commerce and Insurance, the Department of Health and Senior Services, the Department of Social Services, the Missouri Department of Conservation, the Missouri Department of Transportation, Kansas City and the City of Springfield each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **Department of Public Safety - Missouri Highway Patrol** defer to the Missouri Department of Transportation for the potential fiscal impact of this proposal.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other cities and counties were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

## FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

## FISCAL DESCRIPTION

This act specifies additional circumstances under which a patient shall be granted an exception to a step therapy protocol required by a health carrier for coverage of a prescription drug. Under the act, a step therapy override exception determination shall be granted if:

- A delay in treatment would lead to severe or irreversible consequences, and the treatment otherwise required under the step therapy protocol is reasonably expected to be ineffective based upon patient and treatment characteristics;
- Any treatments otherwise required under the step therapy protocol are contraindicated for the patient or have caused or are likely to cause an adverse reaction or other physical harm to the patient;
- Any treatment otherwise required under the step therapy protocol has prevented, will prevent, or is likely to prevent a patient from achieving or maintaining reasonable and safe functional ability in performing occupational responsibilities or activities of daily living, as defined by federal law; or
- The patient is stable for his or her disease or condition on the prescription drug or drugs selected by the prescribing health care provider and has previously received approval for coverage of the relevant drug or drugs under his or her current or previous health coverage.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
