ASSUMPTION

Officials from the **Department of Health and Senior Services**, the **City of Kansas City**, the **City of Springfield**, the **City of Wildwood**, **Boone County**, **Greene County**, the **Cole Camp Ambulance District**, the **Nodaway County Ambulance District** and the **Pettis County Ambulance District** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other cities, counties and ambulance districts were requested to respond to this proposed legislation but did not.
