AN ACT

To repeal sections 386.510 and 386.515, RSMo, and to enact in lieu thereof two new sections relating to the public service commission.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 386.510 and 386.515, RSMo, are repealed and two new sections
2 enacted in lieu thereof, to be known as sections 386.510 and 386.515, to read as follows:

386.510. With respect to commission orders or decisions issued on and after July 1,
2 2011, within thirty days after the application for a rehearing is denied, or, if the application is
3 granted, then within thirty days after the rendition of the decision on rehearing, the applicant may
4 file a notice of appeal with ~~[the commission, which shall also be served on the parties to the~~
5 ~~commission proceeding in accordance with section 386.515, and which the commission shall~~
6 ~~forward to]~~ the appellate court with the territorial jurisdiction over the county where the hearing
7 was held or in which the commission has its principal office for the purpose of having the
8 reasonableness or lawfulness of the original order or decision or the order or decision on
9 rehearing inquired into or determined. **Such notice of appeal shall be served on the**
10 **commission and each party to the commission proceeding in accordance with section**
11 **386.515.** Except with respect to a stay or suspension pursuant to subsection 1 of section
12 386.520, no new or additional evidence may be introduced in the appellate court but the cause
13 shall be heard by the court without the intervention of a jury on the evidence and exhibits
14 introduced before the commission and certified to by it. The notice of appeal shall include the
15 appellant's application for rehearing, a copy of the reconciliation required by subsection 4 of

16 section 386.420, a concise statement of the issues being appealed, a full and complete list of the
17 parties to the commission proceeding, and any other information specified by the rules of the
18 court. Unless otherwise ordered by the court of appeals, the commission shall, within thirty days
19 of the filing of the notice of appeal, certify its record in the case to the court of appeals. The
20 commission and each party to the action or proceeding before the commission shall have the
21 right to intervene and participate fully in the review proceedings. Upon the submission of the
22 case to the court of appeals, the court of appeals shall render its opinion either affirming or
23 setting aside, in whole or in part, the order or decision of the commission under review. In case
24 the order or decision is reversed by reason of the commission failing to receive testimony
25 properly proffered, the court shall remand the cause to the commission, with instructions to
26 receive the testimony so proffered and rejected, and enter a new order or render a new decision
27 based upon the evidence theretofore taken, and such as it is directed to receive. The court may,
28 in its discretion, remand any cause which is reversed by it to the commission for further action.
29 No court in this state, except the supreme court or the court of appeals, shall have jurisdiction
30 or authority to review, reverse, correct or annul any order or decision of the commission or to
31 suspend or delay the executing or operation thereof, or to enjoin, restrain or interfere with the
32 commission in the performance of its official duties. The appellate courts of this state shall
33 always be deemed open for the trial of suits brought to review the orders and decisions of the
34 commission as provided in the public service commission law and the same shall where
35 necessary be tried and determined as suits in equity.

386.515. With respect to commission orders or decisions issued on and after July 1,
2 2011, an application for rehearing is required to be served on all parties and is a prerequisite to
3 the filing of an appeal under section 386.510. The application for rehearing puts the parties to
4 the proceeding before the commission on notice that an appeal can follow and any such review
5 under the appeal may proceed provided that a copy of the notice of appeal is served on said
6 parties. With respect to commission orders or decisions issued on and after July 1, 2011, the
7 review procedure provided for in section 386.510 continues to be exclusive except that a copy
8 of the notice of appeal required by section 386.510 shall be served on **the commission and** each
9 party to the proceeding before the commission by the appellant according to the rules established
10 by the court in which the appeal is filed.
