AN ACT

To amend chapter 650, RSMo, by adding thereto one new section relating to the law enforcement terrorism-prevention activity commission.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 650, RSMo, is amended by adding thereto one new section, to be known as section 650.580, to read as follows:

650.580. 1. As used in this section, the following terms shall mean:

(1) "Primary members", members of the law enforcement terrorism-prevention activity commission who may cast a vote on matters before the law enforcement terrorism-prevention activity commission;

(2) "Regions", the nine regions of the state designated by the Missouri state highway patrol;

(3) "Secondary members", members of the law enforcement terrorism-prevention activity commission who may cast a vote on matters before the law enforcement terrorism-prevention activity commission in the absence of the primary member.

2. There is hereby established within the department of public safety a "Law Enforcement Terrorism-Prevention Activity Commission", which shall consist of eighteen primary members and eighteen secondary members representing the nine regions of the state:

(1) The eighteen primary members of the commission shall consist of:

(a) Nine sheriffs, one from each region, selected by the Missouri Sheriffs' Association, who shall serve until replaced by the Missouri Sheriffs' Association; and

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in bold-face type in the above bill is proposed language.

17 **(b) Nine chiefs of police, one from each region, selected by the Missouri Police**
18 **Chiefs Association, who shall serve until replaced by the Missouri Police Chiefs**
19 **Association;**

20 **(2) The eighteen secondary members of the commission shall consist of:**

21 **(a) Nine sheriffs, one from each region, selected by the Missouri Sheriffs'**
22 **Association, who shall serve until replaced by the Missouri Sheriffs' Association; and**

23 **(b) Nine chiefs of police, one from each region, selected by the Missouri Police**
24 **Chiefs Association, who shall serve until replaced by the Missouri Police Chiefs**
25 **Association.**

26 **3. Both primary and secondary members of the law enforcement terrorism-**
27 **prevention activity commission shall annually elect a member to serve as chair. The law**
28 **enforcement terrorism-prevention activity commission shall meet at least twice a year at**
29 **a time determined by the director of the department of public safety or by a majority vote**
30 **of both primary and secondary members. Ten primary members of the law enforcement**
31 **terrorism-prevention activity commission shall constitute a quorum.**

32 **4. The names of the members of the law enforcement terrorism-prevention activity**
33 **commission shall be submitted to the director of the department of public safety for the**
34 **sole purpose of acknowledgment of the members of the law enforcement terrorism-**
35 **prevention activity commission.**

36 **5. The law enforcement terrorism-prevention activity commission shall make**
37 **recommendations as to the appropriation of twenty-five percent of any grant the state**
38 **receives from the United States Department of Homeland Security.**

39 **6. No member of the commission shall receive any compensation for the**
40 **performance of his or her official duties but shall be entitled to reimbursement for actual**
41 **and necessary expenses incurred in the performance of his or her official duties.**
