AN ACT

To repeal sections 67.1421 and 67.1422, RSMo, and to enact in lieu thereof two new sections relating to community improvement districts.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 67.1421 and 67.1422, RSMo, are repealed and two new sections enacted in lieu thereof, to be known as sections 67.1421 and 67.1422, to read as follows:

67.1421. 1. Upon receipt of a proper petition filed with its municipal clerk, the governing body of the municipality in which the proposed district is located shall hold a public hearing in accordance with section 67.1431 and may adopt an ordinance to establish the proposed district.

2. A petition is proper if, based on the tax records of the county clerk, or the collector of revenue if the district is located in a city not within a county, as of the time of filing the petition with the municipal clerk, it meets the following requirements:

(1) It has been signed by property owners collectively owning more than fifty percent by assessed value of the real property within the boundaries of the proposed district;

(2) It has been signed by more than fifty percent per capita of all owners of real property within the boundaries of the proposed district; and

(3) It contains the following information:

(a) The legal description of the proposed district, including a map illustrating the district boundaries;

(b) The name of the proposed district;

(c) A notice that the signatures of the signers may not be withdrawn later than seven days after the petition is filed with the municipal clerk;

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

18 (d) A five-year plan stating a description of the purposes of the proposed district, the
19 services it will provide, the improvements it will make and an estimate of costs of these services
20 and improvements to be incurred;

21 (e) A statement as to whether the district will be a political subdivision or a not-for-profit
22 corporation and if it is to be a not-for-profit corporation, the name of the not-for-profit
23 corporation;

24 (f) If the district is to be a political subdivision, a statement as to whether the district will
25 be governed by a board elected by the district or whether the board will be appointed by the
26 municipality, and, if the board is to be elected by the district, the names and terms of the initial
27 board may be stated;

28 (g) If the district is to be a political subdivision, the number of directors to serve on the
29 board;

30 (h) The total assessed value of all real property within the proposed district;

31 (i) A statement as to whether the petitioners are seeking a determination that the
32 proposed district, or any legally described portion thereof, is a blighted area;

33 (j) The proposed length of time for the existence of the district;

34 (k) The maximum rates of real property taxes, and, business license taxes in the county
35 seat of a county of the first classification without a charter form of government containing a
36 population of at least two hundred thousand, that may be submitted to the qualified voters for
37 approval;

38 (l) The maximum rates of special assessments and respective methods of assessment that
39 may be proposed by petition;

40 (m) The limitations, if any, on the borrowing capacity of the district;

41 (n) The limitations, if any, on the revenue generation of the district;

42 (o) Other limitations, if any, on the powers of the district;

43 (p) A request that the district be established; and

44 (q) Any other items the petitioners deem appropriate;

45 (4) The signature block for each real property owner signing the petition shall be in
46 substantially the following form and contain the following information:

69 (5) Alternatively, the governing body of [any home rule city with more than four hundred
70 thousand inhabitants and located in more than one county] **any municipality** may file a petition
71 to initiate the process to establish a district [in the portion of the city located in any county of the
72 first classification with more than two hundred thousand but fewer than two hundred sixty
73 thousand inhabitants containing] . **Any petition filed under this subdivision shall be signed**
74 **by the chief elected officer of the municipality and contain** the information required in
75 subdivision (3) of this subsection[; provided that the only funding methods for the services and
76 improvements will be a real property tax].

77 3. Upon receipt of a petition the municipal clerk shall, within a reasonable time not to
78 exceed ninety days after receipt of the petition, review and determine whether the petition
79 substantially complies with the requirements of subsection 2 of this section. In the event the
80 municipal clerk receives a petition which does not meet the requirements of subsection 2 of this
81 section, the municipal clerk shall, within a reasonable time, return the petition to the submitting
82 party by hand delivery, first class mail, postage prepaid or other efficient means of return and
83 shall specify which requirements have not been met.

84 4. After the close of the public hearing required pursuant to subsection 1 of this section,
85 the governing body of the municipality may adopt an ordinance approving the petition and
86 establishing a district as set forth in the petition and may determine, if requested in the petition,
87 whether the district, or any legally described portion thereof, constitutes a blighted area. If the
88 petition was filed by the governing body of a municipality pursuant to subdivision (5) of
89 subsection 2 of this section, after the close of the public hearing required pursuant to subsection

90 1 of this section, the petition may be approved by the governing body and an election shall be
91 called pursuant to section 67.1422.

92 5. Amendments to a petition may be made which do not change the proposed boundaries
93 of the proposed district if an amended petition meeting the requirements of subsection 2 of this
94 section is filed with the municipal clerk at the following times and the following requirements
95 have been met:

96 (1) At any time prior to the close of the public hearing required pursuant to subsection
97 1 of this section; provided that, notice of the contents of the amended petition is given at the
98 public hearing;

99 (2) At any time after the public hearing and prior to the adoption of an ordinance
100 establishing the proposed district; provided that, notice of the amendments to the petition is
101 given by publishing the notice in a newspaper of general circulation within the municipality and
102 by sending the notice via registered certified United States mail with a return receipt attached to
103 the address of record of each owner of record of real property within the boundaries of the
104 proposed district per the tax records of the county clerk, or the collector of revenue if the district
105 is located in a city not within a county. Such notice shall be published and mailed not less than
106 ten days prior to the adoption of the ordinance establishing the district;

107 (3) At any time after the adoption of any ordinance establishing the district a public
108 hearing on the amended petition is held and notice of the public hearing is given in the manner
109 provided in section 67.1431 and the governing body of the municipality in which the district is
110 located adopts an ordinance approving the amended petition after the public hearing is held.

111 6. Upon the creation of a district, the municipal clerk shall report in writing the creation
112 of such district to the Missouri department of economic development.

67.1422. 1. Notwithstanding sections 67.1531, 67.1545, and 67.1551, if the petition was
2 filed pursuant to subdivision (5) of subsection 2 of section 67.1421 by a governing body of the
3 [city] **municipality**, the governing body may adopt an ordinance approving the petition and
4 submit a ballot to the qualified voters of the district; the question shall be in substantially the
5 following form:

18 **If a majority of the qualified voters voting on the proposition vote in favor of the**
19 **proposition, then the district shall be created and the tax may be imposed by the district’s**
20 **board of directors as provided in sections 67.1531, 67.1545, or 67.1551, as applicable,**
21 **without further approval of the qualified voters of the district. If the majority of qualified**
22 **voters voting on the proposition reject the proposition, then the governing body of the [city]**
23 **municipality shall not [submit] resubmit the question to the qualified voters of the district [on**
24 **more than one occasion] for a period of at least one year.**

25 2. A district levying a [real property] tax pursuant to this section may repeal or amend
26 such [real property] tax or lower the tax rate of such tax if such repeal, amendment or lower rate
27 will not impair the district's ability to repay any liabilities which it has incurred, money which
28 it has borrowed or obligations that it has issued to finance any improvements or services
29 rendered within the district.

30 3. An election conducted under this section may be conducted in accordance with the
31 provisions of chapter 115 or by mail-in ballot.
