AN ACT

To repeal sections 568.060 and 578.421, RSMo, and to enact in lieu thereof three new sections relating to gender reassignment, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 568.060 and 578.421, RSMo, are repealed and three new sections enacted in lieu thereof, to be known as sections 191.1180, 568.060, and 578.421, to read as follows:

191.1180. 1. Any physician or surgeon licensed under chapter 334, any person licensed to practice professional or practical nursing under chapter 335, or any other health personnel licensed by a state licensing board in this state shall be prohibited from administering any hormonal treatment or performing any surgical treatment for the purpose of gender reassignment for a child. As used in this section, "child" means a person under eighteen years of age.

2. Any licensed physician or surgeon, any person licensed to practice professional or practical nursing, or any other licensed health personnel who willfully and knowingly does or assists any prohibited action under subsection 1 of this section shall be subject to having his or her license, application for license, or authority to practice his or her profession as a physician, surgeon, nurse, or other health personnel in the state of Missouri rejected or revoked by the appropriate state licensing board.

568.060. 1. As used in this section, the following terms shall mean:

(1) "Abuse", the infliction of physical, sexual, or mental injury against a child by any person eighteen years of age or older. For purposes of this section, abuse shall not include injury inflicted on a child by accidental means by a person with care, custody, or control of the child,

5 or discipline of a child by a person with care, custody, or control of the child, including spanking,
6 in a reasonable manner;

7 (2) "Abusive head trauma", a serious physical injury to the head or brain caused by any
8 means, including but not limited to shaking, jerking, pushing, pulling, slamming, hitting, or
9 kicking;

10 (3) "Mental injury", an injury to the intellectual or psychological capacity or the
11 emotional condition of a child as evidenced by an observable and substantial impairment of the
12 ability of the child to function within his or her normal range of performance or behavior;

13 (4) "Neglect", the failure to provide, by those responsible for the care, custody, and
14 control of a child under the age of eighteen years, the care reasonable and necessary to maintain
15 the physical and mental health of the child, when such failure presents a substantial probability
16 that death or physical injury or sexual injury would result;

17 (5) "Physical injury", physical pain, illness, or any impairment of physical condition,
18 including but not limited to bruising, lacerations, hematomas, welts, or permanent or temporary
19 disfigurement and impairment of any bodily function or organ;

20 (6) "Serious emotional injury", an injury that creates a substantial risk of temporary or
21 permanent medical or psychological damage, manifested by impairment of a behavioral,
22 cognitive, or physical condition. Serious emotional injury shall be established by testimony of
23 qualified experts upon the reasonable expectation of probable harm to a reasonable degree of
24 medical or psychological certainty;

25 (7) "Serious physical injury", a physical injury that creates a substantial risk of death or
26 that causes serious disfigurement or protracted loss or impairment of the function of any part of
27 the body.

28 2. A person commits the offense of abuse or neglect of a child if such person knowingly
29 causes a child who is less than eighteen years of age:

30 (1) To suffer physical or mental injury as a result of abuse or neglect; or

31 (2) To be placed in a situation in which the child may suffer physical or mental injury
32 as the result of abuse or neglect.

33 3. A person commits the offense of abuse or neglect of a child if such person recklessly
34 causes a child who is less than eighteen years of age to suffer from abusive head trauma.

35 4. **A person commits the offense of abuse or neglect of a child if such person coerces**
36 **a child who is under eighteen years of age to undergo any surgical or hormonal treatment**
37 **for the purpose of gender reassignment.**

38 5. A person does not commit the offense of abuse or neglect of a child by virtue of the
39 sole fact that the person delivers or allows the delivery of a child to a provider of emergency
40 services.

41 ~~[5-]~~ **6.** The offense of abuse or neglect of a child is:

42 (1) A class D felony, without eligibility for probation, parole, or conditional release until
43 the defendant has served no less than one year of such sentence, unless the person has previously
44 been found guilty of a violation of this section or of a violation of the law of any other
45 jurisdiction that prohibits the same or similar conduct or the injury inflicted on the child is a
46 serious emotional injury or a serious physical injury, in which case abuse or neglect of a child
47 is a class B felony, without eligibility for probation or parole until the defendant has served not
48 less than five years of such sentence; or

49 (2) A class A felony if the child dies as a result of injuries sustained from conduct
50 chargeable under the provisions of this section.

51 ~~[6-]~~ **7.** Notwithstanding subsection ~~[5]~~ **6** of this section to the contrary, the offense of
52 abuse or neglect of a child is a class A felony, without eligibility for probation, parole, or
53 conditional release until the defendant has served not less than fifteen years of such sentence, if:

54 (1) The injury is a serious emotional injury or a serious physical injury;

55 (2) The child is less than fourteen years of age; and

56 (3) The injury is the result of sexual abuse or sexual abuse in the first degree as defined
57 under section 566.100 or sexual exploitation of a minor as defined under section 573.023.

58 ~~[7-]~~ **8.** The circuit or prosecuting attorney may refer a person who is suspected of abuse
59 or neglect of a child to an appropriate public or private agency for treatment or counseling so
60 long as the agency has consented to taking such referrals. Nothing in this subsection shall limit
61 the discretion of the circuit or prosecuting attorney to prosecute a person who has been referred
62 for treatment or counseling pursuant to this subsection.

63 ~~[8-]~~ **9.** Nothing in this section shall be construed to alter the requirement that every
64 element of any crime referred to herein must be proven beyond a reasonable doubt.

65 ~~[9-]~~ **10.** Discipline, including spanking administered in a reasonable manner, shall not
66 be construed to be abuse under this section.

578.421. As used in sections 578.421 to 578.437, the following terms mean:

2 (1) "Criminal street gang", any ongoing organization, association, or group of three or
3 more persons, whether formal or informal, having as one of its primary activities the commission
4 of one or more of the criminal acts enumerated in subdivision (2) of this section, which has a
5 common name or common identifying sign or symbol, whose members individually or
6 collectively engage in or have engaged in a pattern of criminal gang activity;

7 (2) "Pattern of criminal street gang activity", the commission, attempted commission,
8 or solicitation of two or more of the following offenses, provided at least one of those offenses
9 occurred after August 28, 1993, and the last of those offenses occurred within three years after
10 a prior offense, and the offenses are committed on separate occasions, or by two or more persons:

- 11 (a) Assault with a deadly weapon or by means of force likely to cause serious physical
12 injury, as provided in sections 565.050 and 565.052;
- 13 (b) Robbery, arson and those offenses under chapter 569 which are related to robbery
14 and arson;
- 15 (c) Murder or manslaughter, as provided in sections 565.020 to 565.024;
- 16 (d) Any violation of the provisions of chapter 579 which involves the distribution,
17 delivery or manufacture of a substance prohibited by chapter 579;
- 18 (e) Unlawful use of a weapon which is a felony pursuant to section 571.030;
- 19 (f) Tampering with witnesses and victims, as provided in section 575.270;
- 20 (g) Promoting online sexual solicitation, as provided in section 566.103;
- 21 (h) Sexual trafficking of a child in the first degree, as provided in section 566.210;
- 22 (i) Sexual trafficking of a child in the second degree, as provided in section 566.211;
- 23 (j) Patronizing prostitution, as provided in subsection 4 of section 567.030;
- 24 (k) Promoting prostitution in the first degree, as provided in section 567.050;
- 25 (l) Promoting prostitution in the second degree, as provided in section 567.060;
- 26 (m) Abuse or neglect of a child, as provided in subsection [6] 7 of section 568.060;
- 27 (n) Sexual exploitation of a minor, as provided in section 573.023;
- 28 (o) Child used in sexual performance, as provided in section 573.200; or
- 29 (p) Promoting sexual performance by a child, as provided in section 573.205.
