**AN ACT**

To repeal section 227.299, RSMo, and to enact in lieu thereof three new sections relating to bridge and highway designations.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Section 227.299, RSMo, is repealed and three new sections enacted in lieu thereof, to be known as sections 227.299, 227.810, and 227.813, to read as follows:

227.299. 1. Except as provided in subsection 7 of this section, an organization or person that seeks a bridge or highway designation on the state highway system to honor an event, place, organization, or person who has been deceased for more than two years shall petition the department of transportation by submitting the following:

(1) An application in a form prescribed by the director, describing the bridge or segment of highway for which designation is sought and the proposed name of the bridge or relevant portion of highway. The application shall include the name of at least one current member of the general assembly who will sponsor the bridge or highway designation. The application may contain written testimony for support of the bridge or highway designation;

(2) A list of at least one hundred signatures of individuals who support the naming of the bridge or highway; and

(3) A fee to be determined by the commission to cover the costs of constructing and maintaining the proposed signs. The fee shall not exceed the cost of constructing and maintaining each sign.

2. All moneys received by the department of transportation for the construction and maintenance of bridge or highway signs on the state highway system shall be deposited in the state treasury to the credit of the state road fund.

EXPLANATION — Matter enclosed in bold-faced brackets **[thus]** in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

18           3. The documents and fees required under this section shall be submitted to the  
19 department of transportation no later than November first prior to the next regular session of  
20 the general assembly to be approved or denied by the joint committee on transportation  
21 oversight during such legislative session.

22           4. The department of transportation shall give notice of any proposed bridge or  
23 highway designation on the state highway system in a manner reasonably calculated to advise  
24 the public of such proposal. Reasonable notice shall include posting the proposal for the  
25 designation on the department's official public website, and making available copies of the  
26 sign designation application to any representative of the news media or public upon request  
27 and posting the application on a bulletin board or other prominent public place which is easily  
28 accessible to the public and clearly designated for that purpose at the principal office.

29           5. If the memorial highway designation requested by the organization is not approved  
30 by the joint committee on transportation oversight, ninety-seven percent of the application fee  
31 shall be refunded to the requesting organization.

32           6. Two highway signs shall be erected for each bridge and highway designation on  
33 the state highway system processed under this ~~[section]~~ **chapter**. When a named section of a  
34 highway crosses two or more county lines, consideration shall be given by the department of  
35 transportation to allow additional signage at the county lines or major intersections.

36           7. (1) Highway or bridge designations on the state highway system honoring fallen  
37 law enforcement officers, members of the Armed Forces killed in the line of duty, Missouri  
38 recipients of the medal of honor, emergency personnel killed while performing duties relating  
39 to their employment, or state employees killed while serving the state shall not be subject to  
40 the provisions of this section.

41           (2) Notwithstanding any provision of law to the contrary, beginning August 28, 2021,  
42 for designations honoring Missouri medal of honor recipients, no fees shall be assessed and  
43 all costs associated with such designations shall be funded by the department of  
44 transportation.

45           8. **Highway or bridge designations on the state highway system passed by the**  
46 **general assembly shall not be subject to the provisions of this section.**

47           9. No bridge or portion of a highway on the state highway system may be named or  
48 designated after more than one event, place, organization, or person. Each event, place,  
49 organization, or person shall only be eligible for one bridge or highway designation.

50           ~~[9-]~~ 10. Any highway signs erected for any bridge or highway designation on the state  
51 highway system under the provisions of this section shall be erected and maintained for a  
52 twenty-year period. After such period, the signs shall be subject to removal by the  
53 department of transportation and the bridge or highway may be designated to honor events,  
54 places, organizations, or persons other than the current designee. An existing highway or

55 bridge designation processed under the provisions of this section may be retained for  
56 additional twenty-year increments if, at least one year before the designation's expiration, an  
57 application to the department of transportation is made to retain the designation along with  
58 the required documents and all applicable fees required under this section.

59 ~~[10.]~~ **11.** For persons honored with designations on the state highway system under  
60 this chapter after August 28, 2021, the department of transportation shall post a link on its  
61 website to biographical information of such persons.

62 ~~[11.]~~ **12.** The provisions of this section shall apply to bridge or highway designations  
63 sought after August 28, 2006.

**227.810. The portion of State Highway J from CST Service Road continuing  
2 west to State Highway U in Pemiscot County shall be designated the "Annistyn Kate  
3 Rackley Memorial Highway". The department of transportation shall erect and  
4 maintain appropriate signs designating such highway, with the costs to be paid by  
5 private donations.**

**227.813. The portion of State Highway 291 from N.E. Cookingham Drive  
2 continuing south to Kansas Street in Clay County shall be designated the "Samuel C  
3 Houston Memorial Highway". The department of transportation shall erect and  
4 maintain appropriate signs designating such highway, with the costs to be paid by  
5 private donations.**
