AN ACT

To repeal sections 50.327 and 57.317, RSMo, and to enact in lieu thereof two new sections relating to compensation for county officials.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 50.327 and 57.317, RSMo, are repealed
2 and two new sections enacted in lieu thereof, to be known as
3 sections 50.327 and 57.317, to read as follows:

50.327. 1. Notwithstanding any other provisions of
2 law to the contrary, the salary schedules contained in
3 sections 49.082, 50.334, 50.343, 51.281, 51.282, 52.269,
4 53.082, 53.083, 54.261, 54.320, 55.091, 56.265, **57.317**,
5 58.095, and 473.742 shall be set as a base schedule for
6 those county officials. Except when it is necessary to
7 increase newly elected or reelected county officials'
8 salaries, in accordance with Section 13, Article VII,
9 Constitution of Missouri, to comply with the requirements of
10 this section, the salary commission in all counties except
11 charter counties in this state shall be responsible for the
12 computation of salaries of all county officials; provided,
13 however, that any percentage salary adjustments in a county
14 shall be equal for all such officials in that county.

15 2. Upon majority approval of the salary commission,
16 the annual compensation of part-time prosecutors contained
17 in section 56.265 and the county offices contained in
18 sections 49.082, 50.334, 50.343, 51.281, 51.282, 52.269,

19 53.082, 53.083, 54.261, 54.320, 55.091, 58.095, and 473.742
20 may be increased by up to two thousand dollars greater than
21 the compensation provided by the salary schedules; provided,
22 however, that any vote to increase compensation be effective
23 for all county offices in that county [subject to the salary
24 commission].

25 3. Upon the majority approval of the salary commission,
26 the annual compensation of a county coroner of any county of
27 the second classification as provided in section 58.095 may
28 be increased up to fourteen thousand dollars greater than
29 the compensation provided by the salary schedule of such
30 section.

31 4. Upon majority approval of the salary commission,
32 the annual compensation of a county sheriff as provided in
33 section 57.317 may be increased by up to six thousand
34 dollars greater than the compensation provided by the salary
35 schedule of such section.

36 5. The salary commission of any county of the third
37 classification may amend the base schedules for the
38 computation of salaries for county officials referenced in
39 subsection 1 of this section to include assessed valuation
40 factors in excess of three hundred million dollars; provided
41 that the percentage of any adjustments in assessed valuation
42 factors shall be equal for all such officials in that county.

57.317. 1. [(1)] The county sheriff in any county
2 [of the first or second classification], other than in a
3 chartered county, shall receive an annual salary [equal to
4 eighty percent of the compensation of an associate circuit
5 judge of the county.

6 (2) The county sheriff in any county of the third or
7 fourth classification shall receive an annual salary]
8 computed as set forth in the following [percentages of the

9 compensation of an associate circuit judge of the county.
 10 If there is an increase in salary of less than ten thousand
 11 dollars, the increase shall take effect on January 1, 2022.
 12 If there is an increase of ten thousand dollars or more, the
 13 increase shall be paid over a period of five years in twenty
 14 percent increments per year] **schedule**. The assessed
 15 valuation factor shall be the amount thereof as shown for
 16 the year next preceding the computation. The provisions of
 17 this section shall not permit or require a reduction in the
 18 amount of compensation being paid for the office of sheriff
 19 [from the prior year] **on January 1, 1997**.

45 2. Two thousand dollars of the salary authorized in
 46 this section shall be payable to the sheriff only if the
 47 sheriff has completed at least twenty hours of classroom
 48 instruction each calendar year relating to the operations of
 49 the sheriff's office when approved by a professional
 50 association of the county sheriffs of Missouri unless
 51 exempted from the training by the professional association.
 52 The professional association approving the program shall
 53 provide a certificate of completion to each sheriff who
 54 completes the training program and shall send a list of
 55 certified sheriffs to the treasurer of each county.
 56 Expenses incurred for attending the training session may be
 57 reimbursed to the county sheriff in the same manner as other
 58 expenses as may be appropriated for that purpose.

59 3. The county sheriff in any county, other than a
 60 **first classification** charter county, shall not, **except upon**
 61 **two-thirds vote of all the members of the salary commission,**
 62 receive an annual compensation less than the **total**
 63 compensation [described under this section] **being received**
 64 **for the office of county sheriff in the particular county**

65 for services rendered or performed on the date the salary
66 commission votes.
