AN ACT

To amend chapter 10, RSMo, by adding thereto six new sections relating to state designations.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 10, RSMo, is amended by adding thereto six new sections, to be known as sections 10.105, 10.190, 10.200, 185.070, 227.549, and 1, to read as follows:

10.105. The pawpaw tree (*asimina triloba*) is designated as the state fruit tree of Missouri.

10.190. The Missouri "Show Me" tartan is selected for and shall be known as the official tartan of the state of Missouri. The tartan colors of blue, brown, and silver are derived from the eastern bluebird, the Missouri mule and bear on the state flag, and the crescent moon, representing vigilance and justice, valor, purity, steadfastness, hope, and strength. The thread count for the official tartan is G6, DT4, G4, DT4, B4, DT4, B6, A6, R4, W4, G8, W4, R4, A6, B6, DT4, B4, DT4, G4, DT4, G6, DT4, G16, DT12, G16, A4, G16, DT12, G16, DT4, where A = Aegean Blue, R = Garnet, DB = Admiral, DT = Umber, G = Bottle Green, W = White. The thread count for the official dress version of the Show Me tartan is G6, DT4, G4, DT4, B4, DT4, B6, A6, R4, W4, G8, W4, R4, A6, B6, DT4, B4, DT4, G4, DT4, G6, DT4, G16, DT12, W16, A4, W16, DT12, G16, DT4.

10.200. The *Cryptobranchus alleganiensis*, also known as the hellbender salamander, snot otter, or lasagna lizard, is selected for and shall be known as the official endangered species for the state of

4 Missouri.

185.070. 1. There is hereby established the designation of
2 "Missouri Historical Theater".

3 2. As used in this section, the following terms mean:

4 (1) "Missouri state council on the arts" or "council", as established
5 in section 185.010;

6 (2) "Theater", a 501(c)(3) organization that produces plays,
7 musicals, and other dramatic performances.

8 3. The council shall administer the Missouri historical theater
9 program including, but not limited to, creating application forms,
10 establishing a time line for applications, announcing theaters receiving
11 the designation, creating a process to ensure theaters who receive the
12 designation maintain eligibility, and establishing an application fee to
13 cover the costs of administering the program and providing the
14 certificate in subsection 5.

15 4. The council shall use the following criteria to determine which
16 theaters should receive the state historical theater designation:

17 (1) The theater is a 501(c)(3) not-for-profit organization;

18 (2) The theater produces a minimum of three shows open to the
19 public each year;

20 (3) The extent to which the theater contributes to tourism in
21 Missouri;

22 (4) The extent to which the theater promotes the arts in its
23 community and throughout Missouri; and

24 (5) The theater has been operational for a minimum of fifty
25 years.

26 5. All theaters selected for the state historical theater
27 designation shall receive a certificate, suitable for framing, from the
28 council.

29 6. Each year, the council shall provide a list of theaters that have
30 the state historical theater designation to the division of tourism.

31 7. With the advice of the Missouri state council on the arts, the
32 director of the department of economic development may promulgate
33 all necessary rules and regulations for the administration of this
34 section. Any rule or portion of a rule, as that term is defined in section
35 536.010, that is created under the authority delegated in this section
36 shall become effective only if it complies with and is subject to all of

37 the provisions of chapter 536 and, if applicable, section 536.028. This
38 section and chapter 536 are nonseverable, and if any of the powers
39 vested with the general assembly pursuant to chapter 536 to review, to
40 delay the effective date, or to disapprove and annul a rule are
41 subsequently held unconstitutional, then the grant of rulemaking
42 authority and any rule proposed or adopted after August 28, 2019, shall
43 be invalid and void.

227.549. The portion of State Highway P from Dove Nest Lane
2 continuing east to State Highway M in St. Charles County shall be
3 designated as "Waylon Jennings Memorial Highway". Costs for such
4 designation shall be paid by private donations.

Section 1. The St. Louis Blues is selected for and shall be known
2 as the official state hockey team of Missouri.
