AN ACT

**30.266. 1. For purposes of this section, the term "specie" has the same meaning
2 as in section 408.010.**

**3 2. The state treasurer may keep in the custody of the state treasury an amount of
4 specie less than or equal to one percent of total state investment holdings, as required by
5 Article IV, Section 15 of the Constitution of Missouri.**

**6 3. Nothing in this section shall require the state treasurer to invest any state
7 funds and funds received from the United States government in a manner inconsistent
8 with Article IV, Section 15 of the Constitution of Missouri or Article I, Section 10 of the
9 Constitution of the United States.**

**10 4. The treasurer may promulgate all necessary rules and regulations for the
11 administration of this section including, but not limited to, providing secure storage of
12 gold and silver under subsection 2 of this section without additional cost to the state.
13 Any rule or portion of a rule, as that term is defined in section 536.010, that is created
14 under the authority delegated in this section shall become effective only if it complies
15 with and is subject to all of the provisions of chapter 536 and, if applicable, section
16 536.028. This section and chapter 536 are nonseverable and if any of the powers vested**

17 with the general assembly pursuant to chapter 536 to review, to delay the effective date,
18 or to disapprove and annul a rule are subsequently held unconstitutional, then the grant
19 of rulemaking authority and any rule proposed or adopted after January 1, 2025, shall
20 be invalid and void.

21 5. This section shall become effective on January 1, 2025.

30.267. 1. Beginning July 1, 2025, there is hereby established the "Task Force on
2 Gold and Silver", which shall be composed of the following members:

3 (1) Two members of the senate from the majority party and one member of the
4 senate from the minority party, appointed by the president pro tempore of the senate;

5 (2) Two members of the house from the majority party and one member of the
6 house from the minority party, appointed by the speaker of the house of representatives;

7 (3) The state treasurer, or his or her designee, who shall serve as chair of the task
8 force;

9 (4) The commissioner of the division of finance, or his or her designee, who shall
10 serve as the vice chair; and

11 (5) The director of revenue, or his or her designee.

12 2. The task force shall examine the practicality of issuing gold and silver coinage
13 as specie in a manner consistent with Article I, Section 10 of the Constitution of the
14 United States and examine the possibility of the state accepting gold and silver in
15 payment of obligations to the state.

16 3. The task force shall provide a preliminary report of its findings to the general
17 assembly by December 31, 2025, and provide a final report to the general assembly no
18 later than June 30, 2026. The task force may, in its discretion, provide additional
19 information to the general assembly; however, no such information shall be provided
20 after June 30, 2026.

21 4. This section shall expire on July 1, 2027.

34.700. 1. A public entity shall not:

2 (1) Accept a payment using central bank digital currency; or

3 (2) Participate in any test of central bank digital currency by any Federal
4 Reserve branch.

5 2. For purposes of this section, the following terms mean:

6 (1) "Central bank digital currency" has the same meaning as in section 400.1-
7 201;

8 (2) "Public entity", the state of Missouri or any political subdivision thereof,
9 including all boards, commissions, agencies, institutions, authorities, and bodies politic
10 and corporate of the state created by or in accordance with state law or regulations.

34.710. 1. The state, any agency of the state, any political subdivision of the state, or any instrumentality thereof, when engaged in procuring or letting contracts for any purpose shall ensure that bidders, offerors, or vendors are not discriminated against or given preferential treatment based on an environmental, social, and governance score as the motivating factor.

2. For purposes of this section, the term "environmental, social, and governance score" means an evaluation conducted by an entity that takes into consideration one or more of the following:

(1) The use of energy and raw materials by the bidder, offeror, or vendor;

(2) Whether the bidder, offeror, or vendor spends funds on social welfare or makes charitable donations; and

(3) The environmental policies of the bidder, offeror, or vendor.

67.2800. 1. Sections 67.2800 to 67.2840 shall be known and may be cited as the "Property Assessment Clean Energy Act".

2. As used in sections 67.2800 to 67.2840, the following words and terms shall mean:

(1) "Assessment contract", a contract entered into between a clean energy development board and a property owner under which the property owner agrees to pay an annual assessment for a period of up to ~~twenty~~ **thirty** years not to exceed the weighted average useful life of the qualified improvements in exchange for financing of an energy efficiency improvement or a renewable energy improvement;

(2) "Authority", the state environmental improvement and energy resources authority established under section 260.010;

(3) "Bond", any bond, note, or similar instrument issued by or on behalf of a clean energy development board;

(4) "Clean energy conduit financing", the financing of energy efficiency improvements or renewable energy improvements for a single parcel of property or a unified development consisting of multiple adjoining parcels of property under section 67.2825;

(5) "Clean energy development board", a board formed by one or more municipalities under section 67.2810;

(6) "Director", the director of the division of finance within the department of commerce and insurance;

(7) "Division", the division of finance within the department of commerce and insurance;

(8) "Energy efficiency improvement", any acquisition, installation, or modification on or of publicly or privately owned property designed to reduce the energy consumption of such property, including but not limited to:

26 (a) Insulation in walls, roofs, attics, floors, foundations, and heating and cooling
27 distribution systems;

28 (b) Storm windows and doors, multiglazed windows and doors, heat-absorbing or
29 heat-reflective windows and doors, and other window and door improvements designed to
30 reduce energy consumption;

31 (c) Automatic energy control systems;

32 (d) Heating, ventilating, or air conditioning distribution system modifications and
33 replacements;

34 (e) Caulking and weatherstripping;

35 (f) Replacement or modification of lighting fixtures to increase energy efficiency of
36 the lighting system without increasing the overall illumination of the building unless the
37 increase in illumination is necessary to conform to applicable state or local building codes;

38 (g) Energy recovery systems; and

39 (h) Daylighting systems;

40 (9) "Municipality", any county, city, or incorporated town or village of this state;

41 (10) "Program administrator", an individual or entity selected by the clean energy
42 development board to administer the PACE program, but this term does not include an
43 employee of a county or municipal government assigned to a clean energy development board
44 or a public employee employed by a clean energy development board who is paid from
45 appropriated general tax revenues;

46 (11) "Project", any energy efficiency improvement or renewable energy
47 improvement;

48 (12) "Property assessed clean energy local finance fund", a fund that may be
49 established by the authority for the purpose of making loans to clean energy development
50 boards to establish and maintain property assessed clean energy programs;

51 (13) "Property assessed clean energy program" or "PACE program", a program
52 established by a clean energy development board to finance energy efficiency improvements
53 or renewable energy improvements under section 67.2820;

54 (14) "Renewable energy improvement", any acquisition and installation of a fixture,
55 product, system, device, or combination thereof on publicly or privately owned property that
56 produces energy from renewable resources, including, but not limited to photovoltaic
57 systems, solar thermal systems, wind systems, biomass systems, or geothermal systems.

58 3. All projects undertaken under sections 67.2800 to 67.2840 are subject to the
59 applicable municipality's ordinances and regulations, including but not limited to those
60 ordinances and regulations concerning zoning, subdivision, building, fire safety, and historic
61 or architectural review.

62 **4. Sections 67.2800 to 67.2840 shall not apply to any assessment contract,**
63 **project, or PACE program entered into, undertaken, or established for any residential**
64 **property.**

67.2810. 1. One or more municipalities may form clean energy development boards
2 for the purpose of exercising the powers described in sections 67.2800 to 67.2840. Each
3 clean energy development board shall consist of not less than three members, as set forth in
4 the ordinance or order establishing the clean energy development board. Members shall serve
5 terms as set forth in the ordinance or order establishing the clean energy development board
6 and shall be appointed:

7 (1) If only one municipality is participating in the clean energy development board,
8 by the chief elected officer of the municipality with the consent of the governing body of the
9 municipality; or

10 (2) If more than one municipality is participating, in a manner agreed to by all
11 participating municipalities.

12 2. A clean energy development board shall be a political subdivision of the state and
13 shall have all powers necessary and convenient to carry out and effectuate the provisions of
14 sections 67.2800 to 67.2840, including but not limited to the following:

15 (1) To adopt, amend, and repeal bylaws, which are not inconsistent with sections
16 67.2800 to 67.2840;

17 (2) To adopt an official seal;

18 (3) To sue and be sued;

19 (4) To make and enter into contracts and other instruments with public and private
20 entities;

21 (5) To accept grants, guarantees, and donations of property, labor, services, and other
22 things of value from any public or private source, **including the acquisition of loans or**
23 **assessment contracts from other states or their municipalities and political subdivisions**
24 **to serve a common purpose of providing financing support or credit enhancement for**
25 **any project;**

26 (6) To employ or contract for such managerial, legal, technical, clerical, accounting,
27 or other assistance it deems advisable;

28 (7) To levy and collect special assessments under an assessment contract with a
29 property owner and to record such special assessments as a lien on the property;

30 (8) To borrow money from any public or private source and issue bonds and provide
31 security for the repayment of the same;

32 (9) To finance a project under an assessment contract;

33 (10) To collect reasonable fees and charges in connection with making and servicing
34 assessment contracts and in connection with any technical, consultative, or project assistance
35 services offered;

36 (11) To invest any funds not required for immediate disbursement in obligations of
37 the state of Missouri or of the United States or any agency or instrumentality thereof, or in
38 bank certificates of deposit; provided, however, the limitations on investments provided in
39 this subdivision shall not apply to proceeds acquired from the sale of bonds which are held by
40 a corporate trustee; and

41 (12) To take whatever actions necessary to participate in and administer a clean
42 energy conduit financing or a property assessed clean energy program.

43 3. No later than July first of each year, the clean energy development board shall file
44 with each municipality that participated in the formation of the clean energy development
45 board and with the director of the department of natural resources an annual report for the
46 preceding calendar year that includes:

47 (1) A brief description of each project financed by the clean energy development
48 board during the preceding calendar year, which shall include the physical address of the
49 property, the name or names of the property owner, an itemized list of the costs of the project,
50 and the name of any contractors used to complete the project;

51 (2) The amount of assessments due and the amount collected during the preceding
52 calendar year;

53 (3) The amount of clean energy development board administrative costs incurred
54 during the preceding calendar year;

55 (4) The estimated cumulative energy savings resulting from all energy efficiency
56 improvements financed during the preceding calendar year; and

57 (5) The estimated cumulative energy produced by all renewable energy
58 improvements financed during the preceding calendar year.

59 4. No lawsuit to set aside the formation of a clean energy development board or to
60 otherwise question the proceedings related thereto shall be brought after the expiration of
61 sixty days from the effective date of the ordinance or order creating the clean energy
62 development board. No lawsuit to set aside the approval of a project, an assessment contract,
63 or a special assessment levied by a clean energy development board, or to otherwise question
64 the proceedings related thereto shall be brought after the expiration of sixty days from the
65 date that the assessment contract is executed.

67.2815. 1. A clean energy development board shall not enter into an assessment
2 contract or levy or collect a special assessment for a project without making a finding that
3 there are sufficient resources to complete the project and that the estimated economic benefit

4 expected from the project during the financing period is equal to or greater than the cost of the
5 project.

6 2. An assessment contract shall be executed by the clean energy development board
7 and the benefitted property owner or property owners and shall provide:

8 (1) A description of the project, including the estimated cost of the project and details
9 on how the project will either reduce energy consumption or create energy from renewable
10 sources;

11 (2) A mechanism for:

12 (a) Verifying the final costs of the project upon its completion; and

13 (b) Ensuring that any amounts advanced or otherwise paid by the clean energy
14 development board toward costs of the project will not exceed the final cost of the project;

15 (3) An acknowledgment by the property owner that the property owner has received
16 or will receive a special benefit by financing a project through the clean energy development
17 board that equals or exceeds the total assessments due under the assessment contract;

18 (4) An agreement by the property owner to pay annual special assessments for a
19 period not to exceed ~~twenty~~ **thirty** years, as specified in the assessment contract;

20 (5) A statement that the obligations set forth in the assessment contract, including the
21 obligation to pay annual special assessments, are a covenant that shall run with the land and
22 be obligations upon future owners of such property; and

23 (6) An acknowledgment that no subdivision of property subject to the assessment
24 contract shall be valid unless the assessment contract or an amendment thereof divides the
25 total annual special assessment due between the newly subdivided parcels pro rata to the
26 special benefit realized by each subdivided parcel.

27 3. The total special assessments levied against a property under an assessment
28 contract shall not exceed the sum of the cost of the project, including any required energy
29 audits and inspections, or portion thereof financed through the participation in a property
30 assessed clean energy program or clean energy conduit financing, including the costs of any
31 audits or inspections required by the clean energy development board, plus such
32 administration fees, interest, and other financing costs reasonably required by the clean
33 energy development board.

34 4. The clean energy development board shall provide a copy of each signed
35 assessment contract to the local assessor and collector for the county, or city not within a
36 county, and shall cause a copy of such assessment contract to be recorded in the real estate
37 records of the recorder of deeds for the county, or city not within a county.

38 5. Special assessments agreed to under an assessment contract shall be a lien on the
39 property against which it is assessed on behalf of the applicable clean energy development
40 board from the date that each annual assessment under the assessment contract becomes due.

41 Such special assessments shall be collected by the collector for the county, or city not within a
42 county, in the same manner and with the same priority as ad valorem real property taxes[
43 ~~subject to the provisions of subsection 8 of this section~~]. Once collected, the collector for the
44 county, or city not within a county, shall pay over such special assessment revenues to the
45 clean energy development board in the same manner in which revenues from ad valorem real
46 property taxes are paid to other taxing districts. Such special assessments shall be collected
47 as provided in this subsection from all subsequent property owners, including the state and all
48 political subdivisions thereof, for the term of the assessment contract.

49 6. Any clean energy development board that contracts for outside administrative
50 services to provide financing origination for a project shall offer the right of first refusal to
51 enter into such a contract to a federally insured depository institution with a physical presence
52 in Missouri upon the same terms and conditions as would otherwise be approved by the clean
53 energy development board. Such right of first refusal shall not be applicable to the
54 origination of any transaction that involves the issuance of bonds by the clean energy
55 development board.

56 7. **Except as otherwise provided in section 67.2840**, sections 67.2816, 67.2817,
57 67.2818, and 67.2819 shall apply only to PACE programs for projects to improve residential
58 properties of four or fewer units. Notwithstanding any provision of law to the contrary, any
59 clean energy development board formed to improve commercial properties, properties owned
60 by nonprofit or not-for-profit entities, governmental properties, or nonresidential properties in
61 excess of four residential units shall be exempt from the provisions of sections 67.2816,
62 67.2817, 67.2818, and 67.2819, nor shall such sections apply to the commercial PACE
63 programs and commercial PACE assessment contracts of any clean energy development
64 board engaged in both commercial and residential property programs. Notwithstanding any
65 provision of law to the contrary, any clean energy development board that ceases to finance
66 new projects to improve residential properties of four or fewer units before January 1, 2022,
67 shall be exempt from the provisions of sections 67.2816, 67.2817, 67.2818, and 67.2819.

67.2817. 1. Notwithstanding any other contractual agreement to the contrary, each
2 assessment contract shall be reviewed, approved, and executed by the clean energy
3 development board and these duties shall not be delegated. Any attempted delegations of
4 these duties shall be void.

5 2. An assessment contract shall not be approved, executed, submitted, or otherwise
6 presented for recording unless a clean energy development board verifies that the following
7 criteria are satisfied:

8 (1) The PACE assessments are assessed in equal annual installments;

9 (2) The PACE assessment may be paid in full at any time without prepayment
10 penalty. The pay-off letter shall specify the amount of any fee or charge by a lender or loan

11 service agent to obtain the total balance due. The release of the assessment shall be recorded
12 within thirty days of the receipt of the amounts identified in the pay-off letter;

13 (3) The assessment contract shall disclose applicable penalties, interest penalties, or
14 late fees under the contract and describe generally the interest and penalties imposed under
15 chapter 140 relating to the collection of delinquent property taxes;

16 (4) The clean energy development board shall provide a separate statement to the
17 owner of the residential property of the penalties or late fees authorized under the assessment
18 contract and of the penalties and interest penalties under chapter 140 for the applicable tax
19 collector as of the date of the assessment contract;

20 (5) The clean energy development board has confirmed that the property owner is
21 current on property taxes for the project property;

22 (6) The property that shall be subject to the assessment contract has no recorded and
23 outstanding involuntary liens in excess of one thousand dollars;

24 (7) The property owner shall not currently be a party to any bankruptcy proceeding
25 where any existing lien holder of the property is named as a creditor;

26 (8) The term of the assessment contract shall not exceed the weighted average useful
27 life of the qualified improvements to which the greatest portion of funds disbursed under the
28 assessment contract is attributable, not to exceed ~~twenty~~ **thirty** years. The clean energy
29 development board shall determine useful life for purposes of this subdivision based upon
30 credible third-party standards or certification criteria that have been established by
31 appropriate government agencies or nationally recognized standards and testing
32 organizations;

33 (9) The property owner is current on all mortgage debt on the subject property and
34 has no more than one late payment during the twelve months immediately preceding the
35 application date on any mortgage debt; and

36 (10) The clean energy development board shall not enter into an assessment contract
37 or levy or collect a special assessment for a project without making a finding that there are
38 sufficient resources to complete the project and that the estimated economic benefit expected
39 from the project during the financing period is equal to or greater than the cost of the project.

40 3. Any assessment contract for a project that, combined with any existing and
41 outstanding indebtedness secured by the benefitted property, results in a loan-to-value ratio
42 between eighty percent and ninety-seven percent of the true value in money, as determined by
43 the assessor pursuant to chapter 137, plus ten percent of such amount, of the benefitted
44 property prior to the project as determined by reference to the assessment records for tax
45 purposes for the most recent completed assessment by the county, or city not within a county,
46 shall include provision of an insurance policy providing coverage for any remaining cost of
47 fulfilling the assessment contract, including any accumulated interest, in the event the

48 property is foreclosed upon, if such product exists. Such insurance policy shall run with the
49 land in the same manner as the other obligations set forth in the assessment contract.

50 4. The property owner executing the PACE assessment contract shall have a three-day
51 right to cancel the qualifying improvements proposed for financing under the PACE
52 assessment contract. The three-day right to cancel shall expire at midnight of the third
53 business day after a property owner signs the assessment contract. The clean energy
54 development board shall be required to provide a printed form that is presented to the
55 property owner no later than the time of signing of the assessment contract detailing the
56 property owner's right to cancel. An electronic form may be provided if the owner consents
57 electronically to receiving an electronic form.

58 5. Prior to the execution of an assessment contract, the clean energy development
59 board shall advise the property owner in writing that any delinquent assessment shall be a lien
60 on the property subject to the assessment contract and that the obligations under the PACE
61 assessment contract continue as an obligation against the improved property if the property
62 owner sells or refinances the property and that a purchaser or lender may require that before
63 the owner may sell or refinance the property that the owner may be required to pay the
64 assessment contract in full.

65 6. Prior to the execution of an assessment contract, the clean energy development
66 board shall advise the property owner in writing that if the property owner pays his or her
67 property taxes and special assessments via a lender or loan servicer's escrow program, the
68 special assessment will cause the owner's monthly escrow requirements to increase and
69 increase the owner's total monthly payment to the lender or the loan servicer. The clean
70 energy development board shall further advise the property owner that if the special
71 assessment results in an escrow shortage that the owner will be required to pay the shortage in
72 a lump-sum payment or catch up the shortage over twelve months.

73 7. The clean energy development board, within three days of entering an assessment
74 contract, shall provide any holder of a first mortgage loan a copy of the assessment contract
75 and a statement that includes a brief description of the project, the cost of the project, the

15 biological crop protection or drip-irrigation, environmentally sustainable fishery and
16 aquaculture, environmentally sustainable forestry including, but not limited to,
17 afforestation or reforestation, and preservation or restoration of natural landscapes;

18 (5) Terrestrial and aquatic biodiversity conservation including, but not limited
19 to, the protection of coastal, marine, and watershed environments;

20 (6) Clean transportation, such as electric, hybrid, public, rail, nonmotorized,

83 nonpartisan court plan, such committee shall be formed no later than thirty days prior to the
84 election for which the committee receives contributions or makes expenditures, and which

87 engage in any other activities in support of a measure for which the committee was formed;

2 subsection 10 of this section, shall be a resident of this state and reside in the district or county

No contribution shall be made or accepted and no expenditure shall be made or incurred, directly or indirectly, in a fictitious name, in the name of another person, or by or through another person in such a manner as to conceal the identity of the actual source of the contribution or the actual recipient and purpose of the expenditure. Any person who receives contributions for a committee shall disclose to that committee's treasurer, deputy treasurer or candidate the recipient's own name and address and the name and address of the actual source of each contribution such person has received for that committee. Any person who makes expenditures for a committee shall disclose to that committee's treasurer, deputy treasurer or candidate such person's own name and address, the name and address of each person to whom an expenditure has been made and the amount and purpose of the expenditures the person has made for that committee.

No anonymous contribution of more than twenty-five dollars shall be made by any person, and no anonymous contribution of more than twenty-five dollars shall be accepted by any candidate or committee. If any anonymous contribution of more than twenty-five dollars is received, it shall be returned immediately to the contributor, if the contributor's identity can be ascertained, and if the contributor's identity cannot be ascertained, the candidate, committee treasurer or deputy treasurer shall immediately transmit that portion of the contribution which exceeds twenty-five dollars to the state treasurer and it shall escheat to the state.

38 5. The maximum aggregate amount of anonymous contributions which shall be
39 accepted in any calendar year by any committee shall be the greater of five hundred dollars or
40 one percent of the aggregate amount of all contributions received by that committee in the
41 same calendar year. If any anonymous contribution is received which causes the aggregate
42 total of anonymous contributions to exceed the foregoing limitation, it shall be returned
43 immediately to the contributor, if the contributor's identity can be ascertained, and, if the
44 contributor's identity cannot be ascertained, the committee treasurer, deputy treasurer or
45 candidate shall immediately transmit the anonymous contribution to the state treasurer to
46 escheat to the state.

47 6. Notwithstanding the provisions of subsection 5 of this section, contributions from
48 individuals whose names and addresses cannot be ascertained which are received from a
49 fund-raising activity or event, such as defined in section 130.011, shall not be deemed
50 anonymous contributions, provided the following conditions are met:

51 (1) There are twenty-five or more contributing participants in the activity or event;

52 (2) The candidate, committee treasurer, deputy treasurer or the person responsible for
53 conducting the activity or event makes an announcement that it is illegal for anyone to make
54 or receive a contribution in excess of one hundred dollars unless the contribution is
55 accompanied by the name and address of the contributor;

56 (3) The person responsible for conducting the activity or event does not knowingly
57 accept payment from any single person of more than one hundred dollars unless the name and
58 address of the person making such payment is obtained and recorded pursuant to the record-
59 keeping requirements of section 130.036;

60 (4) A statement describing the event shall be prepared by the candidate or the
61 treasurer of the committee for whom the funds were raised or by the person responsible for
62 conducting the activity or event and attached to the disclosure report of contributions and
63 expenditures required by section 130.041. The following information to be listed in the
64 statement is in addition to, not in lieu of, the requirements elsewhere in this chapter relating to
65 the recording and reporting of contributions and expenditures:

66 (a) The name and mailing address of the person or persons responsible for conducting
67 the event or activity and the name and address of the candidate or committee for whom the
68 funds were raised;

69 (b) The date on which the event occurred;

70 (c) The name and address of the location where the event occurred and the
71 approximate number of participants in the event;

72 (d) A brief description of the type of event and the fund-raising methods used;

73 (e) The gross receipts from the event and a listing of the expenditures incident to the
74 event;

75 (f) The total dollar amount of contributions received from the event from participants
76 whose names and addresses were not obtained with such contributions and an explanation of
77 why it was not possible to obtain the names and addresses of such participants;

78 (g) The total dollar amount of contributions received from contributing participants in
79 the event who are identified by name and address in the records required to be maintained
80 pursuant to section 130.036.

81 7. No candidate or committee in this state shall accept contributions from any out-of-
82 state committee unless the out-of-state committee from whom the contributions are received
83 has filed a statement of organization pursuant to section 130.021 or has filed the reports
84 required by sections 130.049 and 130.050, whichever is applicable to that committee.

85 8. Any person publishing, circulating, or distributing any printed matter relative to
86 any candidate for public office or any ballot measure shall on the face of the printed matter
87 identify in a clear and conspicuous manner the person who paid for the printed matter with the
88 words "Paid for by" followed by the proper identification of the sponsor pursuant to this
89 section. For the purposes of this section, "printed matter" shall be defined to include any
90 pamphlet, circular, handbill, sample ballot, advertisement, including advertisements in any
91 newspaper or other periodical, sign, including signs for display on motor vehicles, or other
92 imprinted or lettered material; but "printed matter" is defined to exclude materials printed and
93 purchased prior to May 20, 1982, if the candidate or committee can document that delivery
94 took place prior to May 20, 1982; any sign personally printed and constructed by an
95 individual without compensation from any other person and displayed at that individual's
96 place of residence or on that individual's personal motor vehicle; any items of personal use
97 given away or sold, such as campaign buttons, pins, pens, pencils, book matches, campaign
98 jewelry, or clothing, which is paid for by a candidate or committee which supports a candidate
99 or supports or opposes a ballot measure and which is obvious in its identification with a
100 specific candidate or committee and is reported as required by this chapter; and any news
101 story, commentary, or editorial printed by a regularly published newspaper or other periodical
102 without charge to a candidate, committee or any other person.

103 (1) In regard to any printed matter paid for by a candidate from the candidate's
104 personal funds, it shall be sufficient identification to print the first and last name by which the
105 candidate is known.

106 (2) In regard to any printed matter paid for by a committee, it shall be sufficient
107 identification to print the name of the committee as required to be registered by subsection 5
108 of section 130.021 and the name and title of the committee treasurer who was serving when
109 the printed matter was paid for.

110 (3) In regard to any printed matter paid for by a corporation or other business entity,
111 labor organization, or any other organization not defined to be a committee by subdivision (7)

112 of section 130.011 and not organized especially for influencing one or more elections, it shall
113 be sufficient identification to print the name of the entity, the name of the principal officer of
114 the entity, by whatever title known, and the mailing address of the entity, or if the entity has
115 no mailing address, the mailing address of the principal officer.

116 (4) In regard to any printed matter paid for by an individual or individuals, it shall be
117 sufficient identification to print the name of the individual or individuals and the respective
118 mailing address or addresses, except that if more than five individuals join in paying for
119 printed matter it shall be sufficient identification to print the words "For a list of other
120 sponsors contact:" followed by the name and address of one such individual responsible for
121 causing the matter to be printed, and the individual identified shall maintain a record of the
122 names and amounts paid by other individuals and shall make such record available for review
123 upon the request of any person. No person shall accept for publication or printing nor shall
124 such work be completed until the printed matter is properly identified as required by this
125 subsection.

126 9. Any broadcast station transmitting any matter relative to any candidate for public
127 office or ballot measure as defined by this chapter shall identify the sponsor of such matter as
128 required by federal law.

129 10. The provisions of subsection 8 or 9 of this section shall not apply to candidates for
130 elective federal office, provided that persons causing matter to be printed or broadcast
131 concerning such candidacies shall comply with the requirements of federal law for
132 identification of the sponsor or sponsors.

133 11. It shall be a violation of this chapter for any person required to be identified as
134 paying for printed matter pursuant to subsection 8 of this section or paying for broadcast
135 matter pursuant to subsection 9 of this section to refuse to provide the information required or
136 to purposely provide false, misleading, or incomplete information.

137 12. It shall be a violation of this chapter for any committee to offer chances to win
138 prizes or money to persons to encourage such persons to endorse, send election material by
139 mail, deliver election material in person or contact persons at their homes; except that, the
140 provisions of this subsection shall not be construed to prohibit hiring and paying a campaign
141 staff.

130.036. 1. The candidate, treasurer or deputy treasurer of a committee shall
2 maintain accurate records and accounts on a current basis. The records and accounts shall be
3 maintained in accordance with accepted normal bookkeeping procedures and shall contain the
4 bills, receipts, deposit records, cancelled checks, **credit card statements, and records** and
5 other detailed information necessary to prepare and substantiate any statement or report
6 required to be filed pursuant to this chapter. Every person who acts as an agent for a
7 committee in receiving contributions, making expenditures or incurring indebtedness for the

8 committee shall, on request of that committee's treasurer, deputy treasurer or candidate, but in
9 any event within five days after any such action, render to the candidate, committee treasurer
10 or deputy treasurer a detailed account thereof, including names, addresses, dates, exact
11 amounts and any other details required by the candidate, treasurer or deputy treasurer to
12 comply with this chapter. Notwithstanding the provisions of subsection 4 of section 130.021
13 prohibiting commingling of funds, an individual, trade or professional association, business
14 entity, or labor organization which acts as an agent for a committee in receiving contributions
15 may deposit contributions received on behalf of the committee to the agent's account within a
16 financial institution within this state, for purposes of facilitating transmittal of the
17 contributions to the candidate, committee treasurer or deputy treasurer. Such contributions
18 shall not be held in the agent's account for more than five days after the date the contribution
19 was received by the agent, and shall not be transferred to the account of any other agent or
20 person, other than the committee treasurer.

21 2. Unless a contribution is rejected by the candidate or committee and returned to the
22 donor or transmitted to the state treasurer within ten business days after its receipt, it shall be
23 considered received and accepted on the date received, notwithstanding the fact that it was
24 not deposited by the closing date of a reporting period.

25 3. Notwithstanding the provisions of section 130.041 that only contributors of more
26 than one hundred dollars shall be reported by name and address for all committees, the
27 committee's records shall contain a listing of each contribution received by the committee,

30 recorded by date received, name and address of the contributor and the amount of the
31 contribution, except that any contributions from unidentifiable persons which are received

34 with information contained in statements required by subsection 6 of section 130.031. The

49 expenditures made, were cash transactions or in-kind transactions.

50 7. Any candidate who, pursuant to section 130.016, is exempt from the requirements
51 to form a committee shall maintain records of each contribution received or expenditure made
52 in support of his candidacy. Any other person or combination of persons who, although not
53 deemed to be a committee according to the definition of the term "committee" in section
54 130.011, accepts contributions or makes expenditures, other than direct contributions from the
55 person's own funds, for the purpose of supporting or opposing the election or defeat of any
56 candidate or for the purpose of supporting or opposing the qualifications, passage or defeat of
57 any ballot measure shall maintain records of each contribution received or expenditure made.
58 The records shall include name, address and amount pertaining to each contribution received

11 (2) The amount of money, including cash on hand at the beginning of the reporting

16 committee shall make a reasonable effort to obtain and report the employer, or occupation if
17 self-employed or notation of retirement, of each person from whom the committee received
18 one or more contributions which in the aggregate total in excess of one hundred dollars and
19 shall make a reasonable effort to obtain and report a description of any contractual
20 relationship over five hundred dollars between the contributor and the state if the candidate is
21 seeking election to a state office or between the contributor and any political subdivision of
22 the state if the candidate is seeking election to another political subdivision of the state;

23 (b) Total amount of all anonymous contributions accepted;

24 (c) Total amount of all monetary contributions received through fund-raising events
25 or activities from participants whose names and addresses were not obtained with such
26 contributions, with an attached statement or copy of the statement describing each fund-

28 (d) Total dollar value of all in-kind contributions received;

29 (e) A separate listing by name and address and employer, or occupation if self-
30 employed or notation of retirement, of each person from whom the committee received

33 (f) A listing of each loan received by name and address of the lender and date and
34 amount of the loan. For each loan of more than one hundred dollars, a separate statement

4 (1) The amount of any federal income tax refund received for a prior year which
5 resulted in a Missouri income tax benefit. The amount added pursuant to this subdivision
6 shall not include any amount of a federal income tax refund attributable to a tax credit
7 reducing a taxpayer's federal tax liability pursuant to Public Law 116-136 or 116-260, enacted
8 by the 116th United States Congress, for the tax year beginning on or after January 1, 2020,
9 and ending on or before December 31, 2020, and deducted from Missouri adjusted gross

10 income pursuant to section 143.171. The amount added under this subdivision shall also not
11 include any amount of a federal income tax refund attributable to a tax credit reducing a
12 taxpayer's federal tax liability under any other federal law that provides direct economic
13 impact payments to taxpayers to mitigate financial challenges related to the COVID-19
14 pandemic, and deducted from Missouri adjusted gross income under section 143.171;

15 (2) Interest on certain governmental obligations excluded from federal gross income
16 by 26 U.S.C. Section 103 of the Internal Revenue Code, as amended. The previous sentence
17 shall not apply to interest on obligations of the state of Missouri or any of its political
18 subdivisions or authorities and shall not apply to the interest described in subdivision (1) of
19 subsection 3 of this section. The amount added pursuant to this subdivision shall be reduced

34 amended, for a net operating loss the taxpayer claims in the tax year in which the net

36 backward for more than two years. Any amount of net operating loss taken against federal
37 taxable income but disallowed for Missouri income tax purposes pursuant to this subdivision
38 after June 18, 2002, may be carried forward and taken against any income on the Missouri
39 income tax return for a period of not more than twenty years from the year of the initial loss;

41 (5) For nonresident individuals in all taxable years ending on or after December 31,
42 2006, the amount of any property taxes paid to another state or a political subdivision of
43 another state for which a deduction was allowed on such nonresident's federal return in the

45 allows a subtraction from income for property taxes paid to this state for purposes of

87 January 1, 2002, to the extent that amount relates to property purchased on or after July 1,
88 2002, but before July 1, 2003, and to the extent that amount exceeds the amount actually
89 deducted pursuant to 26 U.S.C. Section 168 of the Internal Revenue Code as amended by the
90 Job Creation and Worker Assistance Act of 2002;

91 (8) For all tax years beginning on or after January 1, 2005, the amount of any income
92 received for military service while the taxpayer serves in a combat zone which is included in
93 federal adjusted gross income and not otherwise excluded therefrom. As used in this section,
94 "combat zone" means any area which the President of the United States by Executive Order

43 modifiers such as "plus" or "minus" for Standard and Poor's or the equivalent for any
44 other eligible rating service;

45 (9) "Eligible rating service", any nationally recognized statistical rating
46 organization (NRSRO) as defined by the United States Securities and Exchange
47 Commission and any other organization designated by rule or order;

48 (10) "Federally insured depository financial institution", a bank, credit union,

57 is in this state by relying on other information provided by the person regarding the
58 location of the individual's residential address or a business entity's principal place of
59 business or other physical address location, and any records associated with the person
60 that the provider of money transmission may have that indicate such location including,
61 but not limited to, an address associated with an account;

62 (12) "Individual", a natural person;

63 (13) "Key individual", any individual ultimately responsible for establishing or
64 directing policies and procedures of the licensee, such as an executive officer, manager,
65 director, or trustee;

66 (14) "Licensee", a person licensed under sections 361.900 to 361.1035;

67 (15) "Material litigation", litigation that, according to United States generally
68 accepted accounting principles, is significant to a person's financial health and would be
69 required to be disclosed in the person's annual audited financial statements, report to
70 shareholders, or similar records;

71 (16) "Monetary value", a medium of exchange, regardless of whether
72 redeemable in money;

73 (17) "Money", a medium of exchange that is authorized or adopted by the
74 United States or a foreign government. The term includes a monetary unit of account
75 established by an intergovernmental organization or by agreement between two or more
76 governments;

77 (18) "Money transmission", any of the following:

78 (a) Selling or issuing payment instruments to a person located in this state;

79 (b) Selling or issuing stored value to a person located in this state; or

80 (c) Receiving money for transmission from a person located in this state.

82 The term includes payroll processing services. The term does not include the provision
83 solely of online or telecommunications services or network access;

84 (19) "Multistate licensing process", any agreement entered into by and among
85 state regulators relating to coordinated processing of applications for money
86 transmission licenses, applications for the acquisition of control of a licensee, control
87 determinations, or notice and information requirements for a change of key individuals;

88 (20) "NMLS", the Nationwide Multistate Licensing System and Registry
89 developed by the Conference of State Bank Supervisors and the American Association
90 of Residential Mortgage Regulators and owned and operated by the State Regulatory
91 Registry LLC or any successor or affiliated entity for the licensing and registration of
92 persons in financial services industries;

93 (21) "Outstanding money transmission obligations":

94 (a) Any payment instrument or stored value issued or sold by the licensee to a
95 person located in the United States or reported as sold by an authorized delegate of the
96 licensee to a person that is located in the United States that has not yet been paid or
97 refunded by or for the licensee or escheated in accordance with applicable abandoned
98 property laws; or

99 (b) Any money received for transmission by the licensee or an authorized
100 delegate in the United States from a person located in the United States that has not
101 been received by the payee or refunded to the sender, or escheated in accordance with
102 applicable abandoned property laws.

104 For purposes of this subdivision, "in the United States" shall include, to the extent
105 applicable, a person in any state, territory, or possession of the United States; the
106 District of Columbia; the Commonwealth of Puerto Rico; or a U.S. military installation
107 that is located in a foreign country;

109 (a) Does not have the power to elect a majority of key individuals or executive
110 officers, managers, directors, trustees, or other persons exercising managerial authority

113 or person in control of a licensee;

114 (c) Does not have the power to exercise, directly or indirectly, a controlling
115 influence over the management or policies of a licensee or person in control of a licensee;

117 (d) Either:

118 a. Attests to paragraphs (a), (b), and (c) of this subdivision, in a form and in a
119 medium prescribed by the director; or

120 b. Commits to the passivity characteristics of paragraphs (a), (b), and (c) of this
121 subdivision in a written document;

122 (23) "Payment instrument", a written or electronic check, draft, money order,
123 traveler's check, or other written or electronic instrument for the transmission or
124 payment of money or monetary value, regardless of whether negotiable. The term does
125 not include stored value or any instrument that:

126 (a) Is redeemable by the issuer only for goods or services provided by the issuer
127 or its affiliate or franchisees of the issuer or its affiliate, except to the extent required by
128 applicable law to be redeemable in cash for its cash value; or

129 (b) Is not sold to the public but issued and distributed as part of a loyalty,
130 rewards, or promotional program;

131 (24) "Payroll processing services", receiving money for transmission under a
132 contract with a person to deliver wages or salaries, make payment of payroll taxes to
133 state and federal agencies, make payments relating to employee benefit plans, or make
134 distributions of other authorized deductions from wages or salaries. The term does not
135 include an employer performing payroll processing services on its own behalf or on
136 behalf of its affiliate or a professional employer organization subject to regulation under
137 sections 285.700 to 285.750;

138 (25) "Person", any individual, general partnership, limited partnership, limited
139 liability company, corporation, trust, association, joint stock corporation, or other
140 corporate entity identified by the director;

141 (26) "Receiving money for transmission" or "money received for transmission",
142 receiving money or monetary value in the United States for transmission within or
143 outside the United States by electronic or other means;

144 (27) "Stored value", monetary value representing a claim against the issuer
145 evidenced by an electronic or digital record and that is intended and accepted for use as
146 a means of redemption for money, or monetary value, or payment for goods or services.
147 The term includes, but is not limited to, "prepaid access" as defined under 31 CFR
148 Section 1010.100, as amended or recodified from time to time. Notwithstanding the
149 provisions of this subdivision, the term does not include a payment instrument or closed
150 loop stored value, or stored value not sold to the public but issued and distributed as
151 part of a loyalty, rewards, or promotional program;

152 **(28) "Tangible net worth", the aggregate assets of a licensee excluding all**
153 **intangible assets, less liabilities, as determined in accordance with United States**
154 **generally accepted accounting principles.**

361.909. Sections 361.900 to 361.1035 shall not apply to:

2 **(1) An operator of a payment system to the extent that it provides processing,**
3 **clearing, or settlement services between or among persons exempted under this section**
4 **or licensees in connection with wire transfers, credit card transactions, debit card**
5 **transactions, stored value transactions, automated clearinghouse transfers, or similar**

38 **Corporation Act, 12 U.S.C. Sections 1861-1867, as amended or recodified from time**
39 **to time; or corporation organized under the Edge Act, 12 U.S.C. Sections 611-633, as**
40 **amended or recodified from time to time, under the laws of a state or the United States;**

41 **(8) Electronic funds transfer of governmental benefits for a federal, state,**
42 **county, or governmental agency by a contractor on behalf of the United States or a**
43 **department, agency, or instrumentality thereof, or on behalf of a state or governmental**
44 **subdivision, agency, or instrumentality thereof;**

45 **(9) A board of trade designated as a contract market under the federal**
46 **Commodity Exchange Act, 7 U.S.C. Sections 1-25, as amended or recodified from time**
47 **to time, or a person that, in the ordinary course of business, provides clearance and**
48 **settlement services for a board of trade to the extent of its operation as or for such a**
49 **board;**

50 **(10) A registered futures commission merchant under the federal commodities**
51 **laws to the extent of its operation as such a merchant;**

52 **(11) A person registered as a securities broker-dealer under federal or state**
53 **securities laws to the extent of its operation as such a broker-dealer;**

54 **(12) An individual employed by a licensee, authorized delegate, or any person**
55 **exempted from the licensing requirements under sections 361.900 to 361.1035 if acting**
56 **within the scope of employment and under the supervision of the licensee, authorized**
57 **delegate, or exempted person as an employee and not as an independent contractor;**

58 **(13) A person expressly appointed as a third-party service provider to or agent**
59 **of an entity exempt under subdivision (7) of this subsection solely to the extent that:**

60 **(a) Such service provider or agent is engaging in money transmission on behalf**

361.912. The director may require that any person claiming to be exempt from

(2) Recover the cost of administering and enforcing sections 361.900 to 361.1035 by imposing and collecting proportionate and equitable fees and costs associated with applications, examinations, investigations, and other actions required to achieve the purpose of sections 361.900 to 361.1035.

3. The director shall promulgate all necessary rules and regulations for the administration of sections 361.900 to 361.1035. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2024, shall be invalid and void.

361.918. 1. Except as otherwise provided in subsection 2 of this section, all information or reports obtained by the director from an applicant, licensee, or authorized delegate and all information contained in or related to an examination, investigation, operating report, or condition report prepared by, on behalf of, or for the use of the director, or financial statements, balance sheets, or authorized delegate information, shall be confidential and held in accordance with section 361.080.

7 **2. The director may disclose information not otherwise subject to disclosure**
8 **under subsection 1 of this section to representatives of state or federal agencies who**
9 **shall confirm in writing that they will maintain the confidentiality of the information.**

10 **3. This section does not prohibit the director from disclosing to the public a list**

(5) A list of other states in which the applicant is licensed to engage in money transmission and any license revocations, suspensions, or other disciplinary action taken against the applicant in another state;

(6) Information concerning any bankruptcy or receivership proceedings affecting the licensee or a person in control of a licensee;

(7) A sample form of contract for authorized delegates, if applicable;

(8) A sample form of payment instrument or stored value, as applicable;

(9) The name and address of any federally insured depository financial institution through which the applicant plans to conduct money transmission;

(10) A list of any material litigation in which the applicant has been involved in the ten-year period next preceding the submission of the application; and

(11) Any other information the director reasonably requires with respect to the applicant.

2. If an applicant is a corporation, limited liability company, partnership, or other legal entity, the applicant shall also provide:

(1) The date of the applicant's incorporation or formation and state or country of incorporation or formation;

(2) If applicable, a certificate of good standing from the state or country in which the applicant is incorporated or formed;

18 **2. If the individual has resided outside of the United States at any time in the last**
19 **ten years, the individual shall also provide an investigative background report prepared**
20 **by an independent search firm that meets the following requirements:**

22 **(a) Demonstrate that it has sufficient knowledge and resources and employs**
23 **accepted and reasonable methodologies to conduct the research for the background**
24 **report; and**

25 **(b) Not be affiliated with or have an interest with the individual it is researching;**

27 **(2) At a minimum, the investigative background report shall be written in the**
28 **English language and shall contain the following:**

29 **(a) If available in the individual's current jurisdiction of residency, a**
30 **comprehensive credit report, or any equivalent information obtained or generated by**
31 **the independent search firm to accomplish such report, including a search of the court**
32 **data in the countries, provinces, states, cities, towns, and contiguous areas where the**
33 **individual resided and worked;**

34 **(b) Criminal records information for the past ten years including, but not**
35 **limited to, felonies, misdemeanors, or similar convictions for violations of law in the**
36 **countries, provinces, states, cities, towns, and contiguous areas where the individual**
37 **resided and worked;**

38 **(c) Employment history;**

39 **(d) Media history, including an electronic search of national and local**
40 **publications, wire services, and business applications; and**

41 **(e) Financial services-related regulatory history including but not limited to,**
42 **money transmission, securities, banking, insurance, and mortgage-related industries.**

361.942. 1. If an application for an original license under sections 361.900 to
2 **361.1035 appears to include all the items and addresses and all of the matters that are**
3 **required, the application is complete and the director shall promptly notify the**
4 **applicant in a record of the date on which the application is determined to be complete,**
5 **and:**

6 **(1) The director shall approve or deny the application within one hundred**
7 **twenty days after the completion date; or**

8 **(2) If the application is not approved or denied within one hundred twenty days**

4 **2. The report of condition shall include:**

 361.981. 1. The circuit court in an action brought by a licensee shall have
2 jurisdiction to grant appropriate equitable or legal relief, including without limitation
3 prohibiting the authorized delegate from directly or indirectly acting as an authorized
4 delegate for any licensee in this state and the payment of restitution, damages, or other
5 monetary relief, if the circuit court finds that an authorized delegate failed to remit
6 money in accordance with the written contract required by subsection 2 of section
7 361.1275 or as otherwise directed by the licensee or required by law.

8 2. If the circuit court issues an order prohibiting a person from acting as an
9 authorized delegate for any licensee under subsection 1 of this section, the licensee that
10 brought the action shall report the order to the director within thirty days and shall

13 and knowingly fails to remit more than one thousand dollars of such money is guilty of a
14 class E felony.

15 4. An authorized delegate who holds money in trust for the benefit of a licensee
16 and knowingly fails to remit no more than one thousand dollars of such money is guilty
17 of a class A misdemeanor.

 361.984. 1. Every licensee shall forward all money received for transmission in
2 accordance with the terms of the agreement between the licensee and the sender unless
3 the licensee has a reasonable belief or a reasonable basis to believe that the sender may

6 **2. If a licensee fails to forward money received for transmission in accordance**
7 **with this section, the licensee shall respond to inquiries by the sender with the reason for**
8 **the failure unless providing a response would violate a state or federal law, rule, or**
9 **regulation.**

361.987. 1. This section shall not apply to:

2 **(1) Money received for transmission subject to the federal Remittance Rule, 12**
3 **CFR Part 1005, Subpart B, as amended or recodified from time to time; or**

4 **(2) Money received for transmission under a written agreement between the**
5 **licensee and payee to process payments for goods or services provided by the payee.**

6 **2. Every licensee shall refund to the sender, within ten days of receipt of the**
7 **sender's written request for a refund, any and all money received for transmission**
8 **unless any of the following occurs:**

9 **(1) The money has been forwarded within ten days of the date on which the**
10 **money was received for transmission;**

11 **(2) Instructions have been given committing an equivalent amount of money to**
12 **the person designated by the sender within ten days of the date on which the money was**
13 **received for transmission;**

14 **(3) The agreement between the licensee and the sender instructs the licensee to**
15 **forward the money at a time that is beyond ten days of the date on which the money was**
16 **received for transmission. If funds have not yet been forwarded in accordance with the**
17 **terms of the agreement between the licensee and the sender, the licensee shall issue a**
18 **refund in accordance with the other provisions of this section;**

19 **(4) The refund is requested for a transaction that the licensee has not completed**
20 **based on a reasonable belief or a reasonable basis to believe that a crime or violation of**
21 **law, rule, or regulation has occurred, is occurring, or may occur; or**

22 **(5) The refund request does not enable the licensee to:**

23 **(a) Identify the sender's name and address or telephone number; or**

24 **(b) Identify the particular transaction to be refunded in the event the sender has**
25 **multiple transactions outstanding.**

361.990. 1. This section shall not apply to:

2 **(1) Money received for transmission subject to the federal Remittance Rule, 12**
3 **CFR Part 1005, Subpart B, as amended or recodified from time to time;**

4 **(2) Money received for transmission that is not primarily for personal, family, or**
5 **household purposes;**

6 **(3) Money received for transmission under a written agreement between the**
7 **licensee and payee to process payments for goods or services provided by the payee; or**

8 **(4) Payroll processing services.**

9 2. For purposes of this section, "receipt" means a paper receipt, electronic
10 record, or other written confirmation. For a transaction conducted in person, the
11 receipt may be provided electronically if the sender requests or agrees to receive an
12 electronic receipt. For a transaction conducted electronically or by phone, a receipt may
13 be provided electronically. All electronic receipts shall be provided in a retainable form.

14 3. (1) Every licensee or its authorized delegate shall provide the sender a receipt
15 for money received for transmission. The receipt shall contain the following
16 information, as applicable:

17 (a) The name of the sender;

18 (b) The name of the designated recipient;

19 (c) The date of the transaction;

20 (d) The unique transaction or identification number;

21 (e) The name of the licensee, NMLS unique identifier, the licensee's business
22 address, and the licensee's customer service telephone number;

23 (f) The amount of the transaction in United States dollars;

24 (g) Any fee charged by the licensee to the sender for the transaction; and

25 (h) Any taxes collected by the licensee from the sender for the transaction.

26 (2) The receipt required by this section shall be in English and in the language
27 principally used by the licensee or authorized delegate to advertise, solicit, or negotiate,
28 either orally or in writing, for a transaction conducted in person, electronically, or by
29 phone, if other than English.

 361.996. 1. A licensee that provides payroll processing services shall:

2 (1) Issue reports to clients detailing client payroll obligations in advance of the
3 payroll funds being deducted from an account; and

4 (2) Make available worker paystubs or an equivalent statement to workers.

5 2. Subsection 1 of this section shall not apply to a licensee providing payroll
6 processing services if the licensee's client designates the intended recipients to the
7 licensee and is responsible for providing the disclosures required by subdivision (2) of
8 subsection 1 of this section.

 361.999. 1. A licensee under sections 361.900 to 361.1035 shall maintain at all
2 times a tangible net worth of the greater of one hundred thousand dollars or three
3 percent of total assets for the first one hundred million dollars, two percent of additional
4 assets for one hundred million dollars to one billion dollars, and one-half of one percent
5 of additional assets for over one billion dollars.

6 2. Tangible net worth shall be demonstrated at initial application by the
7 applicant's most recent audited or unaudited financial statements under subdivision (6)
8 of subsection 2 of section 361.936.

9 **3. Notwithstanding the provisions of this section, the director shall have the**
10 **authority, for good cause shown, to exempt, in part or in whole, from the requirements**
11 **of this section any applicant or licensee.**

361.1002. 1. An applicant for a money transmission license shall provide, and a
2 **licensee at all times shall maintain, security consisting of a surety bond in a form**
3 **satisfactory to the director.**

4 **2. The amount of the required security shall be:**

5 **(1) The greater of one hundred thousand dollars or an amount equal to one**
6 **hundred percent of the licensee's average daily money transmission liability in this state**
7 **calculated for the most recently completed three-month period, up to a maximum of five**
8 **hundred thousand dollars; or**

19 **under this subsection shall be subject to attachment, levy of execution, or sequestration**
20 **by order of any court, except for a beneficiary of the statutory trust.**

21 **4. Upon the establishment of a statutory trust in accordance with subsection 3 of**
22 **this section or when any funds are drawn on a letter of credit under subdivision (4) of**
23 **subsection 1 of section 361.1008, the director shall notify the applicable regulator of each**
24 **state in which the licensee is licensed to engage in money transmission, if any, of the**
25 **establishment of the trust or the funds drawn on the letter of credit, as applicable.**
26 **Notice shall be deemed satisfied if performed under a multistate agreement or through**
27 **NMLS. Funds drawn on a letter of credit, and any other permissible investments held**
28 **in trust for the benefit of the purchasers and holders of the licensee's outstanding money**
29 **transmission obligations, are deemed held in trust for the benefit of such purchasers and**
30 **holders on a pro rata and equitable basis in accordance with statutes under which**
31 **permissible investments are required to be held in this state, and other states, as**
32 **applicable. Any statutory trust established under this subsection shall be terminated**
33 **upon extinguishment of all of the licensee's outstanding money transmission obligations.**

34 **5. The director by rule or by order may allow other types of investments that the**
35 **director determines are of sufficient liquidity and quality to be a permissible investment.**
36 **The director is authorized to participate in efforts with other state regulators to**
37 **determine that other types of investments are of sufficient liquidity and quality to be a**

361.1008. 1. The following investments are permissible under section 361.1005:

9 **equivalent from any eligible rating service;**

10 **(2) Certificates of deposit or senior debt obligations of an insured depository**
11 **institution, as defined under the Federal Deposit Insurance Act, 12 U.S.C. Section 1813,**
12 **as amended or recodified from time to time, or as defined under the federal Credit**
13 **Union Act, 12 U.S.C. Section 1781, as amended or recodified from time to time;**

14 **(3) An obligation of the United States or a commission, agency, or**
15 **instrumentality thereof; an obligation that is guaranteed fully as to principal and**
16 **interest by the United States; or an obligation of a state or a governmental subdivision,**
17 **agency, or instrumentality thereof;**

18 **(4) One hundred percent of the surety bond provided for under section 361.1002**
19 **that exceeds the average daily money transmission liability in this state; and**

20 **(5) The full drawable amount of an irrevocable standby letter of credit for which**
21 **the stated beneficiary is the director that stipulates that the beneficiary need draw only**
22 **a sight draft under the letter of credit and present it to obtain funds up to the letter of**
23 **credit amount within seven days of presentation of the items required by paragraph (d)**
24 **of this subdivision. The letter of credit shall:**

25 **(a) Be issued by a federally insured depository financial institution, a foreign**
26 **bank that is authorized under federal law to maintain a federal agency or federal**
27 **branch office in a state or states, or a foreign bank that is authorized under state law to**
28 **maintain a branch in a state that:**

29 **a. Bears an eligible rating or whose parent company bears an eligible rating; and**

30 **b. Is regulated, supervised, and examined by United States federal or state**
31 **authorities having regulatory authority over banks, credit unions, and trust companies;**

42 **2. In the event of any notice of expiration or nonextension of a letter of credit**

44 **shall be required to demonstrate to the satisfaction of the director, fifteen days prior to**
45 **expiration, that the licensee maintains and will maintain permissible investments in**

- 73 **4. The director may designate an agent to serve on the director's behalf as**
74 **beneficiary to a letter of credit so long as the agent and letter of credit meet**
75 **requirements established by the director. The director's agent may serve as agent for**
76 **multiple licensing authorities for a single irrevocable letter of credit if the proceeds of**
77 **the drawable amount for the purposes of this subsection are assigned to the director.**

- 82 **6. Unless permitted by the director by rule or by order to exceed the limit as set**

100 (e) Money market mutual funds rated less than "AAA" and equal to or higher
101 than "A-" by Standard & Poor's, or the equivalent from any other eligible rating
102 service; and

103 (f) A mutual fund or other investment fund composed solely and exclusively of
104 one or more permissible investments listed in subdivisions (1) to (3) of subsection 1 of
105 this section; and

106 (3) Cash, including demand deposits, savings deposits, and funds in such
107 accounts held for the benefit of the licensee's customers, at foreign depository
108 institutions to ten percent of the aggregate value of the licensee's total permissible
109 investments if the licensee has received a satisfactory rating in its most recent
110 examination and the foreign depository institution:

111 (a) Has an eligible rating;

112 (b) Is registered under the Foreign Account Tax Compliance Act;

113 (c) Is not located in any country subject to sanctions from the Office of Foreign
114 Asset Control; and

115 (d) Is not located in a high risk or noncooperative jurisdiction as designated by
116 the Financial Action Task Force.

361.1011. 1. The director may suspend or revoke a license or order a licensee to
2 revoke the designation of an authorized delegate if:

3 (1) The licensee violates sections 361.900 to 361.1035 or a rule adopted or an
4 order issued under sections 361.900 to 361.1035;

5 (2) The licensee does not cooperate with an examination or investigation by the
6 director;

7 (3) The licensee engages in fraud, intentional misrepresentation, or gross
8 negligence;

9 (4) An authorized delegate is convicted of, or enters a plea of guilty or nolo
10 contendere to a felony involving an act of fraud, dishonesty, a breach of trust, or money
11 laundering, or violates a rule adopted or an order issued under sections 361.900 to
12 361.1035 as a result of the licensee's willful misconduct or willful blindness;

13 **(5) The competence, experience, character, or general fitness of the licensee,**
14 **authorized delegate, person in control of a licensee, key individual, or responsible**
15 **person of the authorized delegate indicates that it is not in the public interest to permit**
16 **the person to provide money transmission;**

17 **(6) The licensee engages in an unsafe or unsound practice;**

18 **(7) The licensee is insolvent, suspends payment of its obligations, or makes a**
19 **general assignment for the benefit of its creditors; or**

20 **(8) The licensee does not remove an authorized delegate after the director issues**
21 **and serves upon the licensee a final order including a finding that the authorized**
22 **delegate has violated sections 361.900 to 361.1035.**

23 **2. In determining whether a licensee is engaging in an unsafe or unsound**
24 **practice, the director may consider the size and condition of the licensee's money**
25 **transmission, the magnitude of the loss, the gravity of the violation of sections 361.900 to**
26 **361.1035, and the previous conduct of the person involved.**

361.1014. 1. The director may issue an order suspending or revoking the
2 **designation of an authorized delegate, if the director finds that:**

3 **(1) The authorized delegate violated sections 361.900 to 361.1035 or a rule**
4 **adopted or an order issued under sections 361.900 to 361.1035;**

5 **(2) The authorized delegate did not cooperate with an examination or**
6 **investigation by the director;**

7 **(3) The authorized delegate engaged in fraud, intentional misrepresentation, or**
8 **gross negligence;**

9 **(4) The authorized delegate has been convicted of, or pled guilty or nolo**
10 **contendere to a felony involving an act of fraud, dishonesty, a breach of trust, or money**
11 **laundering;**

12 **(5) The competence, experience, character, or general fitness of the authorized**
13 **delegate or a person in control of the authorized delegate indicates that it is not in the**
14 **public interest to permit the authorized delegate to provide money transmission; or**

15 **(6) The authorized delegate is engaging in an unsafe or unsound practice.**

16 **2. In determining whether an authorized delegate is engaging in an unsafe or**
17 **unsound practice, the director may consider the size and condition of the authorized**
18 **delegate's provision of money transmission, the magnitude of the loss, the gravity of the**
19 **violation of sections 361.900 to 361.1035 or a rule adopted or order issued under sections**
20 **361.900 to 361.1035, and the previous conduct of the authorized delegate.**

21 **3. An authorized delegate may apply for relief from a suspension or revocation**
22 **of designation as an authorized delegate according to procedures prescribed by the**
23 **director.**

361.1017. 1. If the director determines that a violation of sections 361.900 to 361.1035 or of a rule adopted or an order issued under sections 361.900 to 361.1035 by a licensee or authorized delegate is likely to cause immediate and irreparable harm to the licensee, its customers, or the public as a result of the violation, or cause insolvency or significant dissipation of assets of the licensee, the director may issue an order requiring the licensee or authorized delegate to cease and desist from the violation. The order becomes effective upon service to the licensee or authorized delegate.

2. The director may issue an order against a licensee to cease and desist from providing money transmission through an authorized delegate that is the subject of a separate order by the director.

3. An order to cease and desist remains effective and enforceable pending the completion of an administrative proceeding under chapter 536.

4. A licensee or an authorized delegate that is served with an order to cease and desist may petition the circuit court with jurisdiction for a judicial order setting aside, limiting, or suspending the enforcement, operation, or effectiveness of the order pending the completion of an administrative proceeding under chapter 536.

5. An order to cease and desist expires unless the director commences an administrative proceeding under chapter 536 within ten days after it is issued.

361.1020. The director may enter into a consent order at any time with a person to resolve a matter arising under sections 361.900 to 361.1035 or a rule adopted or order issued under sections 361.900 to 361.1035. A consent order shall be signed by the person to whom it is issued or by the person's authorized representative and shall indicate agreement with the terms contained in the order. A consent order may provide that it does not constitute an admission by a person that sections 361.900 to 361.1035 or a rule adopted or an order issued under sections 361.900 to 361.1035 has been violated.

361.1023. 1. A person that intentionally makes a false statement, misrepresentation, or false certification in a record filed or required to be maintained under sections 361.900 to 361.1035 or that intentionally makes a false entry or omits a material entry in such a record is guilty of a class E felony.

2. A person that knowingly engages in an activity for which a license is required under sections 361.900 to 361.1035 without being licensed under sections 361.900 to 361.1035 and that receives more than five hundred dollars in compensation within a thirty-day period for this activity is guilty of a class E felony.

3. A person that knowingly engages in an activity for which a license is required under sections 361.900 to 361.1035 without being licensed under sections 361.900 to 361.1035 and that receives no more than five hundred dollars in compensation within a thirty-day period for this activity is guilty of a class A misdemeanor.

2 **361.1026.** The director may assess a civil penalty against a person that violates
3 sections 361.900 to 361.1035 or a rule adopted or an order issued under sections 361.900
4 to 361.1035 in an amount not to exceed one thousand dollars per day for each day the
5 violation is outstanding, plus this state's costs and expenses for the investigation and
6 prosecution of the matter, including reasonable attorney's fees.

2 **361.1029. 1.** If the director has reason to believe that a person has violated or is
3 violating section 361.930, the director may issue an order to show cause why an order to
4 cease and desist shall not be issued requiring that the person cease and desist from the
5 violation of section 361.930.

6 **2.** In an emergency, the director may petition the circuit court with jurisdiction
7 for the issuance of a temporary restraining order under the rules of civil procedure.

8 **3.** An order to cease and desist becomes effective upon service to the person.

9 **4.** An order to cease and desist remains effective and enforceable pending the
10 completion of an administrative proceeding under chapter 536.

11 **5.** A person that is served with an order to cease and desist for violating section
12 361.930 may petition the circuit court with jurisdiction for a judicial order setting aside,
13 limiting, or suspending the enforcement, operation, or effectiveness of the order pending
14 the completion of an administrative proceeding under chapter 536.

15 **6.** An order to cease and desist expires unless the director commences an
administrative proceeding within ten days after it is issued.

2 **361.1032.** In applying and construing sections 361.900 to 361.1035, consideration
3 shall be given to the need to promote uniformity of the law with respect to its subject
4 matter among states that enact it.

5 **361.1035. 1.** A person licensed in this state to engage in the business of money
6 transmission shall not be subject to the provisions of sections 361.900 to 361.1035 to the
7 extent that they conflict with current law or establish new requirements not imposed
8 under current law, until such time as the licensee renews the licensee's current license.

9 **2.** Notwithstanding subsection 1 of this section, a licensee shall be required only
10 to amend its authorized delegate contracts for contracts entered into or amended after
the effective date or the completion of any transition period contemplated under
subsection 1 of this section. Nothing herein shall be construed as limiting an authorized
delegate's obligations to operate in full compliance with sections 361.900 to 361.1035 as
required by subsection 3 of section 361.975.

2 **362.245. 1.** The affairs and business of the corporation shall be managed by a board
3 of directors, consisting of not less than five nor more than thirty-five stockholders who shall
4 be elected annually; except, that trust companies in existence on October 13, 1967, may
continue to divide the directors into three classes of equal number, as near as may be, and to

5 elect one class each year for three-year terms. Notwithstanding any provision of this chapter
6 to the contrary, a director who is not a stockholder shall have all the rights, privileges, and
7 duties of a director who is a stockholder.

8 2. Each director shall be a citizen of the United States, and **except for a private trust**
9 **company as described under section 361.160**, at least a majority of the directors must be
10 residents of this state at the time of their election and during their continuance in office;
11 provided, however, that if a director actually resides within a radius of one hundred miles of
12 the banking house of said bank or trust company, even though his or her residence be in
13 another state adjoining and contiguous to the state of Missouri, he or she shall for the
14 purposes of this section be considered as a resident of this state and in the event such director

22 shall cease to be a resident of this state or adjoining state as ~~[defined]~~ **described** in subsection

24 and his or her office shall be vacant.

25 4. No person shall be a director in any bank or trust company against whom such
26 bank or trust company shall hold a judgment.

3 notice of charges if the **[secretary] director** or the **[secretary's] director's** designee has reason
4 to believe that the family trust company affiliated party is engaging or has engaged in conduct
5 that:

- 6 (1) Demonstrates that the family trust (1) company does not satisfy the requirements of a
7 family trust company or of a foreign family trust company under sections 362.1010 to
8 362.1117;
- 9 (2) Is a prohibited act or practice under section 362.1065;
- 10 (3) Violates section 362.1035, 362.1040, 362.1050, 362.1055, 362.1060, or 362.1080;
- 11 (4) Violates any other law involving fraud or moral turpitude that constitutes a felony;
- 12 (5) Violates a state or federal law related to anti-money laundering, customer
13 identification, or any related rule or regulation;
- 14 (6) Is a willful violation of a rule of the **[secretary] director**;
- 15 (7) Is a willful violation of an order of the **[secretary] director**;
- 16 (8) Is a willful breach of a written agreement with the **[secretary] director**; or
- 17 (9) Is an act of commission or omission or a practice that the **[secretary] director** or
18 the **[secretary's] director's** designee has reason to believe is a breach of trust or fiduciary
19 duty.

20 2. The notice of charges shall contain a statement of facts and notice of opportunity
21 for a hearing.

22 3. If no hearing is requested within thirty days after the date of service of the notice of
23 charges or if a hearing is held and the ~~[secretary]~~ **director** or ~~[secretary's]~~ **director's** designee
24 finds that any of the charges in the notice of charges are true, the ~~[secretary]~~ **director** or
25 ~~[secretary's]~~ **director's** designee may enter an order that removes the family trust company
26 affiliated party from the family trust company or that restricts or prohibits the family trust
27 company affiliated party from participating in the affairs of the family trust company.

28 4. A contested or default order of removal is effective when reduced to writing and

35 (2) If a family trust company affiliated party is charged with a felony in a state or
36 federal court or, in a court of a foreign country with which the United States maintains
37 diplomatic relations, is charged with an offense that involves a violation of law relating to
38 fraud, currency transaction reporting, money laundering, theft, or moral turpitude and such
39 offense is equivalent to a felony charge under state or federal law, then the ~~[secretary]~~
40 **director** or the ~~[secretary's]~~ **director's** designee may enter an emergency order that suspends
41 the family trust company affiliated party or that restricts or prohibits participation by such
42 party in the affairs of the family trust company effective upon service of the order on the
43 company and such family trust company affiliated party.

44 (3) The order shall contain notice of opportunity for a hearing, at which the family
45 trust company affiliated party may request a postsuspension hearing to show that continued
46 service to or participation in the affairs of the family trust company does not pose a threat to
47 the interests of the family trust company. In accordance with applicable rules, the ~~[secretary]~~
48 **director** or ~~[secretary's]~~ **director's** designee shall notify the family trust company affiliated
49 party whether the order suspending or prohibiting the family trust company affiliated party

57 charged is convicted or pleads guilty or nolo contendere, regardless of adjudication, the

59 6. No family trust company affiliated party removed from office under this section
60 shall be eligible for reinstatement to such office or to any other official position in a family
61 trust company or financial institution in this state except with the written consent of the
62 ~~[secretary]~~ **director**. A family trust company affiliated party who is removed, restricted, or
63 prohibited from participation in the affairs of a family trust company under this section may
64 petition the ~~[secretary]~~ **director** for modification or termination of such removal, restriction,
65 or prohibition.

66 7. The resignation, termination of employment or participation, or separation from a
67 family trust company of the family trust company affiliated party shall not affect the

362.1105. 1. The books and records of a family trust company are confidential and
2 shall be made available for inspection and examination only:

5 (2) To any person authorized to act for the family trust company;

6 (3) As compelled by a court, pursuant to a subpoena issued in accordance with state
7 or federal law. Before the production of the books and records, the party seeking production
8 shall agree to reimburse the company for the reasonable costs and fees incurred in compliance
9 with the production. If the parties disagree on the amount of reimbursement, the party
10 seeking the records may request the court that issued the subpoena to set the amount of
11 reimbursement;

12 (4) Pursuant to a subpoena held by any federal or state law enforcement or
13 prosecutorial instrumentality authorized to investigate suspected criminal activity;

14 (5) As authorized by, if a corporation, the board of directors or, if a limited liability
15 company, the managers; or

16 (6) As provided under subsection 2 of this section.

17 2. (1) If a corporation, each customer and stockholder, or if a limited liability
18 company, each member has the right to inspect the books and records of a family trust
19 company as they pertain to such person's accounts or the determination of such person's
20 voting rights.

21 (2) The books and records pertaining to customers, members, and stockholders of a
22 family trust company shall be kept confidential by the company and its directors, managers,
23 officers, and employees. The books and records of customers, members, and stockholders
24 shall not be released except upon the express authorization of the customer as to his or her

25 own accounts or a stockholder or member regarding his or her voting rights. However,
26 information may be released without the authorization of a customer, member, or shareholder
27 in a manner prescribed by the board of directors of a corporation or managers of a limited
28 liability company for the purposes of verifying or corroborating the existence or amount of a
29 customer's account if such information is reasonably provided to meet the needs of commerce
30 and to ensure accurate credit information. Notwithstanding this subdivision, this subsection
31 shall not prohibit a family trust company from disclosing financial information as permitted
32 under 15 U.S.C. Section 6802, as amended.

33 (3) The willful unlawful disclosure of confidential information in violation of this
34 section shall be a class E felony.

35 (4) This subsection shall not apply to a foreign family trust company. The laws of the
36 jurisdiction in which a foreign family trust company was incorporated or organized govern
37 the rights of its customers, members, and stockholders to inspect its books and records.

38 3. For purposes of this section, the term "books and records" shall include, but is not
39 limited to, the initial registration documents of a family trust company under section
40 362.1030 and the annual registration report made by a family trust company under section
41 362.1055.

362.1110. 1. A family trust company shall keep at its principal place of business or
2 principal place of operations:

3 (1) Full and complete records of the names and residences of all its shareholders or
4 members;

5 (2) The number of shares or membership units held by each, as applicable; and

8 The records are subject to inspection by all shareholders or members of the family trust

17 (3) The organizational instrument of a family trust company; and

18 (4) The annual registration reports filed by a family trust company.

19 3. A copy of any document on file with the **[secretary] director** that is certified by the
20 **[secretary] director** as a true copy may be introduced in evidence as if it were the original.

21 The [secretary] **director** shall establish a schedule of fees for preparing true copies of
22 documents.

23 4. Orders issued by courts or administrative law judges for the production of
24 confidential records or information shall provide for inspection in camera by the court or the
25 administrative law judge. If the court or administrative law judge determines that the
26 documents requested are relevant or would likely lead to the discovery of admissible
27 evidence, the documents shall be subject to further orders by the court or the administrative
28 law judge to protect the confidentiality thereof. An order directing the release of information
29 shall be immediately reviewable, and a petition by the [secretary] **director** for review of the
30 order shall automatically stay any further proceedings in a trial court or administrative
31 hearing until the disposition of the petition by the reviewing court. If any other party files a
32 petition for review, such filing shall stay proceedings only upon an order of the reviewing

362.1115. 1. The following information held by the [secretary] **director** is
2 confidential and exempt from chapter 610:

3 (1) Any personal identifying information appearing in records relating to a
4 registration or an annual certification of a family trust company;

5 (2) Any personal identifying information appearing in records relating to an
6 examination of a family trust company;

7 (3) Any personal identifying information appearing in reports of examinations,
8 operations, or conditions of a family trust company, including working papers;

9 (4) Any portion of a list of names of the shareholders or members of a family trust

11 (5) Information received by the [secretary] **director** from a person from another state
12 or nation or the federal government that is otherwise confidential or exempt under the laws of
13 such state or nation or under federal law; and

14 (6) An emergency cease and desist order issued under section 362.1090 until the

16 confidentiality will result in substantial risk of financial loss to the public.

17 2. Information made confidential and exempt under subsection 1 of this section may
18 be disclosed by the [secretary] **director** to:

19 (1) The authorized representative or representatives of the family trust company
20 under examination. The authorized representative or representatives shall be identified in a
21 resolution or by written consent of the board of directors if a corporation or the managers if a
22 limited liability company;

23 (2) A fidelity insurance company upon written consent of the family trust company's
24 board of directors if a corporation or its managers if a limited liability company;

25 (3) An independent auditor upon written consent of the family trust company's board
26 of directors if a corporation or its managers if a limited liability company;

27 (4) A liquidator, receiver, or conservator if appointed. However, any portion of the
28 information that discloses the identity of a bondholder, customer, family member, member, or

30 (5) Any other state, federal, or foreign agency responsible for the regulation or
31 supervision of family trust companies;

32 (6) A law enforcement agency in the furtherance of such agency's official duties and

34 (7) The appropriate law enforcement or prosecutorial agency for the purpose of
35 reporting any suspected criminal activity; or

36 (8) Comply with a legislative subpoena. A legislative body or committee that
37 receives records or information pursuant to such subpoena shall maintain the confidential
38 status of such records or information. However, in a case involving the investigation of
39 charges against a public official subject to impeachment or removal, records or information
40 may be disclosed to the extent necessary as determined by the legislative body or committee.

44 4. The willful disclosure of information made confidential and exempt by this section
45 is a class E felony.

362.1117. 1. Except as otherwise provided in sections 362.1010 to 362.1117, any

11 reimbursement, or remit any other form of remuneration to the health carrier or any entity
12 acting on behalf of the health carrier in order to redeem the amount of its claim for

45 inform the provider or third party of the health care service, date of service, and patient for

379.1640. 1. As used in this section, the following terms shall mean:

- 2 (1) "Department", the department of commerce and insurance;
- 3 (2) "Director", the director of the department of commerce and insurance;
- 4 (3) "Limited lines self-service storage insurance producer", an owner, operator, lessor,
5 or sublessor of a self-service storage facility, or an agent or other person authorized to manage
6 the facility, duly licensed by the department of commerce and insurance;
- 7 (4) "Offer and disseminate", provide general information, including a description of
8 the coverage and price, as well as process the application, collect premiums, and perform
9 other nonlicensable activities permitted by the state;
- 10 (5) "Self-service storage insurance", insurance coverage for the loss of, or damage to,
11 tangible personal property in a self-service storage facility as defined in section 415.405 or in
12 transit during the rental period.

13 2. Notwithstanding any other provision of law:

14 (1) Individuals may offer and disseminate self-service storage insurance on behalf of
15 and under the control of a limited lines self-service storage insurance producer only if the
16 following conditions are met:

17 (a) The limited lines self-service storage insurance producer provides to purchasers of
18 self-service storage insurance:

19 a. A description of the material terms or the actual material terms of the insurance
20 coverage;

21 b. A description of the process for filing a claim;

22 c. A description of the review or cancellation process for the self-service storage
23 insurance coverage; and

24 d. The identity and contact information of the insurer and any third-party
25 administrator or supervising entity authorized to act on behalf of the insurer;

26 (b) At the time of licensure, the limited lines self-service storage insurance producer
27 shall establish and maintain a register on a form prescribed by the director of each individual
28 that offers self-service storage insurance on the limited lines self-service storage insurance
29 producer's behalf. The register shall be maintained and updated annually by the limited lines

30 self-service storage insurance producer and shall include the name, address, and contact
31 information of the limited lines self-service storage insurance producer and an officer or
32 person who directs or controls the limited lines self-service storage insurance producer's
33 operations, and the self-service storage facility's federal tax identification number. The
34 limited lines self-service storage insurance producer shall submit such register within thirty
35 days upon request by the department. The limited lines self-service storage insurance
36 producer shall also certify that each individual listed on the self-service storage register
37 complies with 18 U.S.C. Section 1033;

38 (c) The limited lines self-service storage insurance producer serves as or has
39 designated one of its employees who is a licensed individual producer as a person responsible
40 for the business entity's compliance with the self-service storage insurance laws, rules, and

43 license shall make application to the director on the specified application and declare under
44 penalty of refusal, suspension or revocation of the license that the statements made on the
45 application are true, correct and complete to the best of the knowledge and belief of the
46 applicant. Before approving the application, the director shall find that the individual:

47 a. Is at least eighteen years of age;

48 b. Has not committed any act that is a ground for denial, suspension, or revocation set

84 (a) Evaluate or interpret the technical terms, benefits, and conditions of the offered
85 self-service storage insurance coverage;

86 (b) Evaluate or provide advice concerning a prospective purchaser's existing
87 insurance coverage; or

88 (c) Hold themselves or itself out as a licensed insurer, licensed producer, or insurance
89 expert;

90 (4) If self-service storage insurance is offered to the customer, premium or other
91 charges specifically applicable to self-service storage insurance shall be listed as a separate
92 amount and apart from other charges relating to the lease and/or procurement of a self-service
93 storage unit on all documentation pertinent to the transaction.

94 3. Notwithstanding any other provision of law, a limited lines self-service storage
95 insurance provider whose insurance-related activities, and those of its employees and
96 authorized representatives, are limited to offering and disseminating self-service storage
97 insurance on behalf of and under the direction of a limited lines self-service storage insurance
98 producer meeting the conditions stated in this section is authorized to do so and receive
99 related compensation, upon registration by the limited lines self-service storage insurance
100 producer as described in paragraph (b) of subdivision (1) of subsection 2 of this section.

103 5. Limited lines self-service storage insurance producers, operators, employees and

13 (3) "Director", the director of the department of commerce and insurance, unless the
14 settlement agent's primary regulator is another department. When the settlement agent is
15 regulated by such department, that department shall have jurisdiction over this section and
16 section 381.412;

17 (4) "Financial institution":

18 (a) A person or entity doing business under the laws of this state or the United States
19 relating to banks, trust companies, savings and loan associations, credit unions, commercial
20 and consumer finance companies, industrial loan companies, insurance companies, small
21 business investment corporations licensed under the Small Business Investment Act of 1958,

22 15 U.S.C. Section 661, et seq., as amended, or real estate investment trusts as defined in 26

25 (b) A mortgage loan company or mortgage banker doing business under the laws of

29 Association, or the United States Department of Housing and Urban Development, or a

34 **seized in violation of this subdivision shall have a cause of action in a court of competent**

36 **(2) Enforce or attempt to enforce any federal acts, laws, executive orders,**

47 **transactions involving the use of gold or silver as legal tender, beyond those applicable to**

5 those liens that have been perfected and recorded on personal property. The rental agreement

8 default, and that any proceeds from the sale of the property which remain after satisfaction of
9 the lien will be paid to the state treasurer if unclaimed by the occupant within one year after

23 until such occupant files a sworn affidavit with the operator stating that there are no other
24 valid liens outstanding against the property sold and that he or she, the occupant, shall
25 indemnify the operator for any damages incurred or moneys paid by the operator due to
26 claims arising from other lienholders of the property sold. After the one-year period set in
27 this subsection, any proceeds remaining after satisfaction of the lien shall be considered
28 abandoned property to be reported and paid to the state treasurer in accordance with laws
29 pertaining to the disposition of unclaimed property.

15 **(vii) Arising out of the use of a credit or charge card or information contained on**
16 **or for use with the card; or**
17 **(viii) As winnings in a lottery or other game of chance operated or sponsored by**
18 **a state, governmental unit of a state, or person licensed or authorized to operate the**
19 **game by a state or governmental unit of a state; and**
20 **b. Health care-insurance receivables.**
21 **(b) "Account" does not include:**
22 **a. Rights to payment evidenced by chattel paper or an instrument;**
23 **b. Commercial tort claims;**
24 **c. Deposit accounts;**
25 **d. Investment property;**
26 **e. Letter-of-credit rights or letters of credit; or**

51 statement or may be contained in an application, agreement, or other document signed
52 by the business or the business owner or owners;

53 (6) "Commercial financing facility", a provider's plan for purchasing multiple
54 accounts receivable from the recipient over a period of time pursuant to an agreement
55 that sets forth the terms and conditions governing the use of the facility;

56 (7) "Commercial financing transaction", any commercial loan, accounts
57 receivable purchase transaction, commercial open-end credit plan or each to the
58 extent the transaction is a business purpose transaction;

59 (8) "Commercial loan", a loan to a business, whether secured or unsecured;

60 (9) "Commercial open-end credit plan", commercial financing extended by any
61 provider under a plan in which:

62 (a) The provider reasonably contemplates repeat transactions; and

63 (b) The amount of financing that may be extended to the business during the
64 term of the plan, up to any limit set by the provider, is generally made available to the
65 extent that any outstanding balance is repaid;

66 (10) "Depository institution", any of the following:

67 (a) A bank, trust company, or industrial loan company doing business under the
68 authority of, or in accordance with, a license, certificate, or charter issued by the United
69 States, this state, or any other state, district, territory, or commonwealth of the United
70 States that is authorized to transact business in this state;

71 (b) A federally chartered savings and loan association, federal savings bank, or
72 federal credit union that is authorized to transact business in this state; and

73 (c) A savings and loan association, savings bank, or credit union organized
74 under the laws of this or any other state that is authorized to transact business in this
75 state;

76 (11) "General intangible", any personal property, including things in action,
77 other than accounts, chattel paper, commercial tort claims, deposit accounts,

78 documents, goods, instruments, investment property, letter-of-credit rights, letters of
79 credit, money, and oil, gas, or other minerals before extraction. "General intangible"
80 also includes payment intangibles and software;

81 (12) "Payment intangible", a general intangible under which the account
82 debtor's principal obligation is a monetary obligation;

83 (13) "Provider", a person who consummates more than five commercial
84 financing transactions to a business located in this state in any calendar year.
85 "Provider" also includes a person that enters into a written agreement with a depository
86 institution to arrange for the extension of a commercial financing transaction by the
87 depository institution to a business via an online lending platform administered by the
88 person. The fact that a provider extends a specific offer for a commercial financing
89 transaction on behalf of a depository institution shall not be construed to mean that the
90 provider engaged in lending or financing or originated that loan or financing.

92 disclose the terms of the commercial financing transaction as required by this section.
93 The disclosures shall be provided at or before consummation of the transaction. Only
94 one disclosure is required for each commercial financing transaction, and a disclosure is
95 not required as a result of the modification, forbearance, or change to a consummated
96 commercial financing transaction.

97 (2) A provider shall disclose the following in connection with each commercial
98 financing transaction:

99 (a) The total amount of funds provided to the business under the terms of the
100 commercial financing transaction. This disclosure shall be labeled "Total Amount of
101 Funds Provided";

102 (b) The total amount of funds disbursed to the business under the terms of the
103 commercial financing transaction, if less than the total amount of funds provided, as a
104 result of any fees deducted or withheld at disbursement and any amount paid to a third
105 party on behalf of the business. This disclosure shall be labeled "Total Amount of Funds
106 Disbursed";

107 (c) The total amount to be paid to the provider pursuant to the commercial
108 financing transaction agreement. This disclosure shall be labeled "Total of Payments";

109 (d) The total dollar cost of the commercial financing transaction under the terms
110 of the agreement, derived by subtracting the total amount of funds provided from the
111 total of payments. This calculation shall include any fees or charges deducted by the
112 provider from the "Total Amount of Funds Provided". This disclosure shall be labeled
113 "Total Dollar Cost of Financing";

114 (e) The manner, frequency, and amount of each payment. This disclosure shall
115 be labeled "Payments". If the payments may vary, the provider shall instead disclose
116 the manner, frequency, and the estimated amount of the initial payment labeled
117 "Estimated Payments" and the commercial financing transaction agreement shall
118 include a description of the methodology for calculating any variable payment and the
119 circumstances when payments may vary; and

120 (f) A statement of whether there are any costs or discounts associated with
121 prepayment of the commercial financing transaction including a reference to the
122 paragraph in the agreement that creates the contractual rights of the parties related to
123 prepayment. This disclosure shall be labeled "Prepayment".

124 (3) A provider that consummates a commercial financing facility may provide
125 disclosures required by subdivision (2) of this subsection that are based on an example
126 of a transaction that could occur under the agreement. The example shall be based on
127 an account receivable total face amount owed of ten thousand dollars. Only one
128 disclosure is required for each commercial financing facility, and a disclosure is not
129 required as result of a modification, forbearance, or change to the facility. A new
130 disclosure is not required each time accounts receivable are purchased under the
131 facility.

132 4. This section shall not apply to the following:

133 (1) A provider that is a depository institution or a subsidiary or service
134 corporation that is:

135 (a) Owned and controlled by a depository institution; and

136 (b) Regulated by a federal banking agency;

137 (2) A provider that is a lender regulated under the federal Farm Credit Act, 12

142 (c) A purchase money obligation that is incurred as all or part of the price of the
143 collateral or for value given to enable the business to acquire rights in or the use of the

145 (4) A commercial financing transaction in which the recipient is a motor vehicle
146 dealer or an affiliate of such a dealer, or a vehicle rental company or an affiliate of such
147 a company, pursuant to a commercial loan or commercial open-end credit plan of at
148 least fifty thousand dollars or a commercial financing transaction offered by a person in
149 connection with the sale or lease of products or services that such person manufactures,

150 licenses, or distributes, or whose parent company or any of its directly or indirectly

163 defined in subdivision (3) of section 364.100 offered or entered into by a provider that is

165 5. (1) No person shall engage in business as a broker for commercial financing
166 within this state for compensation, unless prior to conducting such business, the person
167 has filed a registration with the division of finance within the department of commerce
168 and insurance and has on file a good and sufficient bond as specified in this subsection.
169 The registration shall be effective upon receipt by the division of finance of a completed
170 registration form and the required registration fee, and shall remain effective until the
171 time of renewal.

172 (2) After filing an initial registration form, a broker shall file, on or before
173 January thirty-first of each year, a renewal registration form along with the required
