AN ACT

To repeal sections 161.415 and 640.240, RSMo, and to enact in lieu thereof two new sections relating to scholarships to be administered by the department of higher education.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 161.415 and 640.240, RSMo, are repealed and two new
2 sections enacted in lieu thereof, to be known as sections 161.415 and 173.240, to
3 read as follows:

161.415. 1. Within the limits of amounts appropriated therefor, the
2 department of [elementary and secondary] **higher** education shall make available
3 up to one hundred one-year, renewable scholarships in an amount of two
4 thousand dollars to minority students for the purpose of encouraging minority
5 students to enter teaching. Such scholarships shall be available to minority high
6 school graduates and college students who are residents of Missouri, and who
7 enter and make a commitment to pursue a teacher education program approved
8 by the department of elementary and secondary education and offered by a
9 four-year college or university located in Missouri, or who after the completion of
10 their baccalaureate degree enter teacher education and make a commitment to
11 teach science or mathematics, and who have:

12 (1) Achieved scores on an accepted standardized test of academic ability,
13 including, but not limited to, the SAT, ACT, SCAT, which place them at or above

14 the seventy-fifth percentile; and

15 (2) A high school rank at or above the seventy-fifth percentile.

16 2. If the number of applicants exceeds the number of scholarships or
17 revenues available, the department of [elementary and secondary] **higher**
18 education may consider the financial needs of the applicant.

19 3. Any college or university located in Missouri which offers a teacher
20 education program approved by the department of elementary and secondary
21 education, and wishes to have the scholarships provided pursuant to this section
22 made available to eligible applicants for admittance to such college or university,
23 must provide matching funds to match one dollar for every two dollars made
24 available by the state pursuant to this section for students attending the college
25 or university. Such matching funds shall not be taken from money made
26 available to the college or university from state funds. The total scholarship
27 available to any one student from state and from college and university sources
28 pursuant to such match program shall be three thousand dollars per year.

29 4. A recipient shall be eligible for a renewed scholarship for a maximum
30 of three additional years. Eligibility for renewed scholarships shall be based on
31 criteria established by the colleges of education and the department of
32 [elementary and secondary] **higher** education.

33 5. As used in this section the term "minority" includes Asian Americans,
34 Hispanic Americans, Native Americans and African Americans.

35 6. The scholarships provided in subsection 1 of this section shall be
36 available to otherwise eligible students who are currently enrolled in a
37 community college and make a commitment to pursue a teacher education
38 program approved by the department of elementary and secondary education and
39 offered by a four-year college or university located in Missouri.

**173.240. 1. There is hereby established within the department of
2 higher education a "Minority and Underrepresented Environmental
3 Literacy Program". The department of higher education, hereafter
4 referred to as the department, may award scholarships to minority and
5 underrepresented students to pursue environmentally related courses
6 of study. The scholarships shall be administered by the department
7 recruitment and retention program under the supervision of the
8 minority environmental literacy advisory committee established under
9 this section. Those ethnic groups which are most severely
10 underrepresented, as determined by data gathered and maintained by
11 the National Academy of Sciences, shall receive priority in annual
12 selection.**

13 2. For the purpose of increasing the number of minority and
14 underrepresented students, as determined by the National Academy of
15 Sciences, who are enrolled in environmentally related courses of study,
16 there is hereby created a "Recruitment and Retention Scholarship
17 Fund". Any unexpended balance in the recruitment and retention
18 scholarship fund shall not be subject to biennial transfer under the
19 provisions of section 33.080. All interest earned on funds in the
20 recruitment and retention scholarship fund shall accrue to the fund.

21 3. The general assembly may appropriate funds to the
22 department for the purpose of funding scholarships as authorized by
23 this section. Such funds shall be from general revenue, special fees
24 administered by the department, federal funding sources, gifts, or
25 donations, provided that such funds may be used for this purpose. All
26 sums received for this purpose shall be placed in the state treasury and
27 credited to the recruitment and retention scholarship fund.

28 4. The department shall accept, receive and administer grants or
29 other funds, gifts, or donations from the public and individuals,
30 including the federal government, for the purpose of funding
31 scholarships under this section. Such funds shall be deposited in the
32 recruitment and retention scholarship fund.

33 5. The department shall promulgate rules to administer the
34 scholarship program, which shall include qualifications, application
35 forms, annual filing deadlines, and scholarship amounts. Any rule or
36 portion of a rule, as that term is defined in section 536.010 that is
37 created under the authority delegated in this section shall become
38 effective only if it complies with and is subject to all of the provisions
39 of chapter 536, and, if applicable, section 536.028. This section and
40 chapter 536 are nonseverable and if any of the powers vested with the
41 general assembly pursuant to chapter 536, to review, to delay the
42 effective date, or to disapprove and annul a rule are subsequently held
43 unconstitutional, then the grant of rulemaking authority and any rule
44 proposed or adopted after August 28, 2010, shall be invalid and void.

45 6. The scholarship program shall be directed toward students in
46 the following areas of study:

47 (1) Engineering students pursuing an environmental course of
48 study through undergraduate and graduate degrees in civil, chemical,
49 mechanical, environmental, or biological engineering;

50 (2) Environmental sciences students pursuing undergraduate and

51 graduate degrees in geology, biology, wildlife management, planning,
52 natural resources, or a closely related course of study;

53 (3) Chemistry students pursuing undergraduate and graduate
54 degrees in the field of environmental chemistry; and

55 (4) Law enforcement students pursuing undergraduate and
56 graduate degrees in environmental law enforcement.

57 7. There is hereby created a "Minority Environmental Literacy
58 Advisory Committee", hereafter referred to as the committee, to be
59 comprised of:

60 (1) The commissioner of higher education or the commissioner's
61 designee, who will serve as chairperson of the committee;

62 (2) Three representatives of universities and colleges. The
63 universities and colleges shall be selected by the department, with the
64 approval of the director of the department of natural resources. The
65 university and college representatives shall each be appointed by the
66 affirmative action office of the respective institution;

67 (3) The director of the department of natural resources or the
68 director's designee;

69 (4) Five at-large members appointed by the governor, with the
70 advice and consent of the senate, who shall be high school teachers and
71 college professors and who shall be selected to represent the various
72 regions of the state;

73 (5) The state affirmative action officer.

74 8. The committee shall meet at least annually, at a time and
75 place to be determined by the chairperson, to select students to receive
76 scholarships from applications filed with the department retention and
77 recruitment program. The members appointed by the governor shall be
78 reimbursed for their actual and necessary expenses.

79 9. Colleges and universities described in this section shall
80 include public community colleges.

2 [640.240. 1. There is hereby established within the division
3 of environmental quality a "Minority and Underrepresented
4 Environmental Literacy Program". The department of natural
5 resources, hereafter referred to as the department, may award
6 scholarships to minority and underrepresented students to pursue
7 environmentally related courses of study. The scholarships shall
8 be administered by the division of environmental quality
recruitment and retention program under the supervision of the

9 minority environmental literacy advisory committee established
10 under this section. Those ethnic groups which are most severely
11 underrepresented, as determined by data gathered and maintained
12 by the National Academy of Sciences, shall receive priority in
13 annual selection.

14 2. For the purpose of increasing the number of minority and
15 underrepresented students, as determined by the National
16 Academy of Sciences, who are enrolled in environmentally related
17 courses of study, there is hereby created a "Recruitment and
18 Retention Scholarship Fund". Any unexpended balance in the
19 recruitment and retention scholarship fund shall not be subject to
20 biennial transfer pursuant to the provisions of section 33.080,
21 RSMo. All interest earned on funds in the recruitment and
22 retention scholarship fund shall accrue to the fund.

23 3. The general assembly may appropriate funds to the
24 department for the purpose of funding scholarships as authorized
25 by this section. Such funds shall be from general revenue, special
26 fees administered by the department, federal funding sources, gifts

52 7. There is hereby created a "Minority Environmental
53 Literacy Advisory Committee", hereafter referred to as the
54 committee, to be comprised of:

55 (1) The director of the department of natural resources or
56 the director's designee, who will serve as chairperson of the
57 committee;

58 (2) Three representatives of universities and colleges. The
59 university and college representatives shall each be appointed by
60 the affirmative action office of the respective institution;

61 (3) The commissioner of higher education or the
62 commissioner's designee;

63 (4) Five at-large members appointed by the governor, with
64 the advice and consent of the senate, who shall be high school
65 teachers and college professors and who shall be selected to
66 represent the various regions of the state;

67 (5) The state affirmative action officer.

68 8. The committee shall meet at least annually, at a time
69 and place to be determined by the chairperson, to select students
70 to receive scholarships from applications filed with the division of
71 environmental quality retention and recruitment program. The
72 members appointed by the governor shall be reimbursed for their
73 actual and necessary expenses.

74 9. Colleges and universities described in this section shall
75 include public community colleges.]
