10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12	Section 1. Section 28-2-724, MCA, is amended to read:		
13	"28-2-724. Prohibition of contracts that restrict practice applicability exceptions. (1) A		
14	contract that creates or establishes the terms of employment, a partnership, or any other form of professional		
15	relationship with a health care provider described in subsection (2), may not restrict the right of the health care		
16	provider to:		
17	(a) practice or provide services for which the provider is licensed, in any geographic area and for		
18	any period, after the termination of the employment, partnership, or other form of professional relationship;		
19	(b) treat, advise, consult with, or establish a provider-patient relationship with any current patient of		
20	the employer or with a patient affiliated with a partnership or other form of professional relationship; or		
21	(c) solicit or seek to establish a provider-patient relationship with any current patient of the		
22	employer or with a patient affiliated with a partnership or other form of professional relationship.		
23	(2) The requirements of subsection (1) apply to contracts or agreements involving the following		
24	health care providers:		
25	(a) a psychiatrist or addiction medicine physician licensed under Title 37, chapter 3;		
26	(b) a psychologist licensed under Title 37, chapter 17;		
27	(c) a social worker licensed under Title 37, chapter <u>22 39;</u>		
28	(d) a professional counselor licensed under Title 37, chapter <u>23_39;</u>

1	(e)	an addiction counselor licensed under Title 37, chapter <del>35<u>39;</u></del>	
2	(f)	a marriage and family therapist licensed under Title 37, chapter 37 39; and
