20	projects	s and in amounts not to exceed the amounts set out in subsection (2) subject to the	e conditions set forth
21	in [sect	ion 3]. However, any of the projects listed in subsection (2) that have not complete	ed the conditions
22	describ	ed in [section 3(1)] by September 1, 2022, must be reviewed by the next regular le	egislature to determine
23	if the au	uthorized grant should be withdrawn.	
24		(4) If sufficient funds are available, this section constitutes a valid obligation of fu	nds to the grant
25	projects	s listed in subsection (2) for purposes of encumbering the funds in the historic pres	servation grant
26	progran	n account established in 22-3-1307 for the biennium beginning July 1, 2021, pursu	uant to 17-7-302. A

grant recipient's entitlement to receive funds is dependent on the grant recipient's compliance with the

conditions described in [section 3] and on the availability of funds.

1	(5) The legislature, pursuant to 22-3-1305, authorizes the grants for the projects listed in subsection (2)
2	(6) Grant recipients must complete all of the conditions described in [section 3(1)] by September 30,
3	2024, or any obligation to the grant recipient will cease.
4	
5	NEW SECTION. Section 2. Approval of grants completion of biennial appropriation. (1) The
6	legislature, pursuant to 22-3-1305, authorizes grants for the projects identified in [section 1(2)].
7	(2) The authorization of these grants completes a biennial appropriation from the historic preservation
8	grant program account established in 22-3-1307.
9	
10	NEW SECTION. Section 3. Condition of grants disbursement of funds. (1) The disbursement of
11	grant funds for the projects specified in [section 1(2)] is subject to completion of the following conditions:
12	(a) The grant recipient shall document that other matching funds required for the completion of the
13	project are firmly committed.
14	(b) The grant recipient must have a project management plan that is approved by the department of
15	commerce.
16	(c) The grant recipient must be in compliance with the auditing and reporting requirements provided for
17	in 2-7-503 and have established a financial accounting system that the department can reasonably ensure
18	conforms to generally accepted accounting principles. Tribal governments shall comply with auditing and
19	reporting requirements provided for in 2 CFR 200.
20	(d) The grant recipient shall satisfactorily comply with any conditions described in the application
21	(project) summaries section of the Montana historic preservation grant program 2023 biennium report to the
22	67th legislature.
23	(e) The grant recipient shall satisfy other specific requirements considered necessary by the
24	department of commerce to accomplish the purpose of the project as evidenced by the application to the
25	department.
26	(f) The grant recipient shall execute a grant agreement with the department of commerce.
27	(2) Recipients of Montana historic preservation grant program funds are subject to the requirements of
28	the department of commerce as described in the most recent edition of the Montana historic preservation grant



1	program project administration manual adopted by the department through the administrative rulemaking
2	process.
3	
4	NEW SECTION. Section 4. Other powers and duties of the department of commerce. (1) The
5	department of commerce must disburse grant funds on a reimbursement basis as grant recipients incur eligible
6	project expenses.
7	(2) If actual project expenses are lower than the projected expense of the project, the department may,
8	at its discretion reduce the amount of grant funds provided to grant recipients in proportion to all other project
9	funding sources.
10	
11	NEW SECTION. Section 5. Notification to tribal governments. The secretary of state shall send a
12	copy of [this act] to each federally recognized tribal government in Montana.
13	
14	NEW SECTION. Section 6. Effective date. [This act] is effective July 1, 2021.
