15	(c)	monitor the operation of assigned executive branch agencies with specific attention to the				
16	following:					
17	(i)	identification of issues likely to require future legislative attention;				
18	(ii)	opportunities to improve existing law through the analysis of problems experienced with the				
19	application of the law by an agency; and					
20	(iii)	experiences of the state's citizens with the operation of an agency that may be amenable to

(g) review proposed statewide initiatives as defined in 13-27-110 within the interim committee's subject area and vote to either support or not support the placement of the text of the proposed statewide initiative on the ballot in accordance with 13-27-228.

- (2) Each interim committee shall prepare bills and resolutions that, in its opinion, the welfare of the state may require for presentation to the next regular session of the legislature. An interim committee may by vote request four five bill drafts on a partisan basis and an unlimited number of bill drafts on a bipartisan basis.
- (3) The legislative services division shall keep accurate records of the activities and proceedings of each interim committee.
- 10 (4) As used in this section:
- 11 (a) "bipartisan basis" means a vote in which members from more than one party vote to request a 12 bill draft; and
  - (b) "partisan basis" means a vote in which members from only one the majority party vote to request a bill draft."
