21	administrator from the inactive list to the active list of a county if an elector meets the requirements for					
22	registration provided in this chapter and:					
23	(a) appears at a polling place in order to vote, submits an application to vote by absentee ballo	ot in				
24	a polling place election or mail ballot election, or votes in a mail ballot election conducted under Title 13,					
25	chapter 19;					
26	(b) notifies the county election administrator in writing of the elector's current residence, which	1				
27	must be in that county; or					
28	(c) completes a reactivation form provided by the county election administrator that provides
