11	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
12	
13	NEW SECTION. Section 1. Limited liability agricultural vehicles on highway. (1) The owner,
14	lessee, or operator of an agricultural vehicle operated on a highway is not liable in tort action for damages
15	suffered as a result of an act or omission of the owner, lessee, or operator in excess of \$750,000 for each claim
16	and \$1.5 million for each occurrence.
17	(2) An insurer is not liable for excess damages DAMAGES IN EXCESS OF THE AMOUNTS IDENTIFIED IN
18	SUBSECTION (1) unless the insurer agrees by written endorsement to provide coverage to the owner, lessee, or
19	operator of an agricultural vehicle involved in amounts in excess of a limitation stated in this section, in which
20	case the insurer may not claim the benefits of the limitation specifically waived.
21	(3) As used in this section, "agricultural vehicle" means:
22	(a) a farm tractor as defined in 61-9-102;
23	(b) an implement of husbandry as defined in 61-1-101;
24	(c) a self-propelled farm equipment unit;
25	(d) a combination of farm tractor and towed unit of farm equipment or implement of husbandry; or
26	(e) a vehicle used for hauling hay, straw, or both.
27	
28	Section 2. Section 61-1-101, MCA, is amended to read:



"61-1-101. Definitions. As used in this title, unless the context indicates otherwise, the following
 definitions apply:

3 (1) "Agricultural operations" means any aspect of farming or ranching from preparation to sale and
4 transportation.

5 (1)(2) (a) "Authorized agent" means a person who has executed a written agreement with the 6 department and is specifically authorized by the department to electronically access and update the 7 department's motor vehicle titling, registration, or driver records, using an approved automated interface, for 8 specific functions or purposes on behalf of a third party.

17 (3)(4) "Autocycle" means a three-wheeled motorcycle that is equipped with safety belts, roll bars or

roll hoops, a steering wheel, and seating that does not require the operator to straddle or sit astride it.

19 (4)(5) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the

20 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the

21 transportation of persons for compensation.

22 (5)(6) (a) "Business entity" means a corporation, association, partnership, limited liability partnership,

23 limited liability company, or other legal entity recognized under state law.

b) The term does not include an individual.

25 (6)(7) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or

attached to an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not

28 (b) The term does not include a truck canopy cover or topper.

 roadway except at the points and in the manner as determined by the public authority having jurisdiction over
 the highway, street, or roadway.

15 (f) "Crosswalk" means:

(i) that part of a roadway at an intersection included within the connections of the lateral lines of
 the sidewalks on opposite sides of the highway measured from the curbs or, in the absence of curbs, from the
 edges of the traversable roadway; or

(ii) any portion of a roadway at an intersection or elsewhere distinctly indicated for pedestrians
crossing by lines or other markings on the surface.

(g) "Electrically assisted bicycle" means a vehicle on which a person may ride that has two tandem
wheels and an electric motor capable of propelling the vehicle and a rider who weighs 170 pounds no faster
than 20 miles an hour on a paved, level surface.

(h) "Flag person" means a person who directs, controls, or alters the normal flow of vehicular traffic
 on a street or highway as a result of a vehicular traffic hazard then present on that street or highway. This
 person, except a uniformed traffic enforcement officer exercising the officer's duty as a result of a planned
 vehicular traffic hazard, must be equipped as required by the rules of the department of transportation.

28 (i) "Highway" has the meaning provided in 61-1-101, but includes ways that have been or are later



1 dedicated to public use.

2 (j) "Ignition interlock device" means ignition equipment that:

3 (i) analyzes the breath to determine blood alcohol concentration;

4 (ii) is approved by the department pursuant to 61-8-1025; and

5 (iii) is designed to prevent a motor vehicle from being operated by a person who has consumed a
6 specific amount of an alcoholic beverage.

(k) (i) "Intersection" means the area embraced within the prolongation or connection of the lateral
curb lines or if there are no curb lines then the lateral boundary lines of the roadways of two highways that join
one another at or approximately at right angles or the area within which vehicles traveling on different highways
joining at any other angle may come in conflict.

11 (ii) When a highway includes two roadways 30 feet or more apart, then every crossing of each 12 roadway of the divided highway by an intersecting highway must be regarded as a separate intersection. If the 13 intersecting highways also include two roadways 30 feet or more apart, then every crossing of two roadways of 14 the highways must be regarded as a separate intersection.

(I) "Laned roadway" means a roadway that is divided into two or more clearly marked lanes for
vehicular traffic.

(m) "Local authorities" means every county, municipal, and other local board or body having
authority to enact laws relating to traffic under the constitution and laws of this state.

(n) "Moped" means a vehicle equipped with two or three wheels, foot pedals to permit muscular
propulsion, and an independent power source providing a maximum of 2 brake horsepower. The power source
may not be capable of propelling the device, unassisted, at a speed exceeding 30 miles an hour on a level
surface. The device must be equipped with a power drive system that functions directly or automatically only
and does not require clutching or shifting by the operator after the drive system is engaged.

(o) "Noncommercial motor vehicle" or "noncommercial vehicle" means any motor vehicle or
 combination of motor vehicles that is not included in the definition of commercial motor vehicle in 61-1-101 and
 includes but is not limited to the vehicles listed in 61-1-101(10)(b) 61-1-101(11)(b).

(p) "Official traffic control devices" means all signs, signals, markings, and devices not inconsistent
with this title that are placed or erected by authority of a public body or official having jurisdiction for the purpose



1 of regulating, warning, or guiding traffic.

(q) "Pedestrian" means any person on foot or any person in a manually or mechanically propelled
wheelchair or other low-powered, mechanically propelled vehicle designed specifically for use by a physically
disabled person.
(r) "Police vehicle" means a vehicle used in the service of any law enforcement agency.

6 (s) "Private road" or "driveway" means a way or place in private ownership and used for vehicular
7 travel by the owner and those having express or implied permission from the owner, but not by other persons.

8 (t) "Residence district" means the territory contiguous to and including a highway not comprising a 9 business district when the property on the highway for a distance of 300 feet or more is primarily improved with 10 residences or residences and buildings in use for business.

11 (u) "Right-of-way" means the privilege of the immediate use of the roadway.

(v) "Roadway" means the portion of a highway that is improved, designed, or ordinarily used for
vehicular travel, including the paved shoulder.

14 (w) "School bus" has the meaning provided in 20-10-101.

(x) "Sidewalk" means the portion of a street that is between the curb lines or the lateral lines of a
 roadway and the adjacent property lines and that is intended for use by pedestrians.

17 (y) "Traffic control signal" means a device, whether manually, electrically, or mechanically

18 operated, by which traffic is alternately directed to stop and to proceed.

19 (z) "Urban district" means the territory contiguous to and including any street that is built up with

20 structures devoted to business, industry, or dwelling houses situated at intervals of less than 100 feet for a

21 distance of one-fourth mile or more."
