4	A BILL FOR AN ACT ENTITLED: "AN ACT REVISING THE DEFINITION OF STATE DUTY FOR SPECIAL
5	WORK BY MONTANA NATIONAL GUARD PERSONNEL; CLARIFYING THAT THE DUTY MUST BE
6	STATE-FUNDED AND FOR ACTIVITIES WITHIN THE SCOPE OF DUTIES OF THE DEPARTMENT OF
7	MILITARY AFFAIRS BUT NOT FOR DECLARED STATE EMERGENCIES SPECIFIC ACTIVITIES THAT DO
8	NOT REQUIRE A DECLARATION OF A STATE EMERGENCY; AMENDING SECTION 10-1-505, MCA; AND
9	PROVIDING AN EFFECTIVE DATE."

11	WHEREAS, CYBER INCIDENTS HAVE INCREASED SIGNIFICANTLY NATIONWIDE PROVIDING EVIDENCE THAT CYBER
12	SECURITY NEEDS TO BE STRENGTHENED IN MONTANA TO GUARD AGAINST THREATS TO INFORMATION SYSTEMS OF
13	GOVERNMENTS AND OPERATORS OF CRITICAL INFRASTRUCTURE; AND
14	WHEREAS, AS WE WORK TO PROTECT MONTANANS AGAINST CRIMES ON OUR STREETS, WE MUST ALSO WORK
15	TO PROTECT MONTANANS FROM CYBER-SECURITY THREATS; AND
16	WHEREAS, members of the Montana Army and Air National Guard have unique training and
17	EXPERIENCE TO GUARD AGAINST AND RESPOND TO CYBER-SECURITY THREATS AND OTHER THREATS TO PUBLIC SAFETY
18	AND PROSPERITY STATEWIDE; AND
19	WHEREAS, IT IS PRUDENT FOR THE STATE TO BE PROACTIVE, NOT REACTIVE, WHEN PROVIDING FOR THE
20	SECURITY OF THE PEOPLE OF MONTANA; AND
21	WHEREAS, THE USE OF THE MONTANA ARMY AND AIR NATIONAL GUARD TO RESPOND TO COMMUNITY NEEDS
22	THAT DO NOT WARRANT A DECLARATION OF EMERGENCY OR DISASTER, INCLUDING BUT NOT LIMITED TO CYBER-SECURITY
23	VULNERABILITY ASSESSMENTS, WILL BETTER ENABLE THE GOVERNOR, AS COMMANDER IN CHIEF UNDER ARTICLE VI,
24	SECTION 13, OF THE MONTANA CONSTITUTION, TO SAFEGUARD THE PEOPLE OF MONTANA BEFORE IT BECOMES
25	NECESSARY TO DECLARE AN EMERGENCY OR DISASTER.

27	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

29	Section 1. Section 10-1-505, MCA, is amended to read:
30	"10-1-505. State duty for special work definition. (1) To fulfill the department's duties under
	Legislative Services -1 - Division

1	10-1-102, the adjutant general as the department head under 2-15-1201 may use national guard resources and
2	place Montana national guard personnel on state duty for special work.
3	(2) For purposes of this section, "state duty for special work" means any state-funded activity , such as
4	administrative functions, exercises, training, coordination, or planning, that is conducted for the purposes of
5	preparing the Montana national guard for active duty ordered by the governor under Article VI, section 13, of the
6	Montana constitution performed by Montana national guard personnel within the scope of the department's duties,
7	INCLUDING THE RECRUITMENT, MOBILIZATION, ADMINISTRATION, TRAINING, DISCIPLINE, EQUIPMENT, SUPPLY, OR
8	OPERATIONS OF THE NATIONAL GUARD IN SUPPORT OF THE ROLE OF THE GOVERNOR AS COMMANDER-IN-CHIEF PURSUANT
9	TO ARTICLE VI, SECTION 13, OF THE MONTANA CONSTITUTION. State duty for special work does not include active
10	duty ordered by the governor under Article VI, section 13 , of the Montana constitution ."
