5 A BILL FOR AN ACT ENTITLED: "AN ACT EXTENDING THE MONTANA INDIAN LANGUAGE PRESERVATION
6 PROGRAM; AMENDING SECTION 7, CHAPTER 410, LAWS OF 2013, SECTIONS 3 AND 7, CHAPTER 426,
7 LAWS OF 2015, AND SECTIONS 2, 3, 4, AND 9, CHAPTER 232, LAWS OF 2017; AND PROVIDING AN
8 IMMEDIATE EFFECTIVE DATE."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
