8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	NEW SECTION. Section 1. Appropriation. (1) There is appropriated \$600,000 from the general fund
11	to the department of public health and human services in each year of the biennium beginning July 1, 2015.
12	(2) The appropriation must be used to contract for psychiatric treatment beds THAT MAY BE USED FOR
13	TREATMENT SERVICES, as allowed under 53-21-1204.
14	(3) EXPENDITURES FROM THIS APPROPRIATION ARE INTENDED TO BE ONGOING AND MUST BE INCLUDED IN THE
15	BUDGET PREPARED BY THE GOVERNOR FOR THE 2019 BIENNIUM.

17	COORDINATION SECTION. Section 2. Coordination instruction. (1) If BOTH HOUSE BILL NO. 2 AND
18	[THIS ACT] ARE PASSED AND APPROVED AND HOUSE BILL NO. 2 CONTAINS AN APPROPRIATION OF \$815,000 IN EACH YEAR
19	OF THE BIENNIUM BEGINNING JULY 1, 2015, TO THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES TO CONTRACT
20	FOR PSYCHIATRIC TREATMENT BEDS AS ALLOWED UNDER 53-21-1204, THEN [THIS ACT] IS VOID.
21	(2) IF BOTH HOUSE BILL NO. 2 AND [THIS ACT] ARE PASSED AND APPROVED AND HOUSE BILL NO. 2 CONTAINS
