5 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING INFRASTRUCTURE LAWS; CREATING
6 INFRASTRUCTURE POLICY; LIMITING AUTHORITY TO CREATE STATE DEBT; DISTINGUISHING
7 BETWEEN MAJOR REPAIR AND CAPITAL DEVELOPMENT PROJECTS; REQUIRING THE ARCHITECTURE
8 AND ENGINEERING DIVISION OF THE DEPARTMENT OF ADMINISTRATION TO SUBMIT A PRIORITIZED
9 LIST OF ANTICIPATED MAJOR REPAIR PROJECTS PURSUANT TO CRITERIA; REQUIRING THE DIVISION
10 TO REPORT CHANGES OF ALLOCATIONS FOR MAJOR REPAIR PROJECTS; REQUIRING A MINIMUM
11 LEVEL OF FUNDING FOR MAJOR REPAIR PROJECTS PRIOR TO AUTHORIZING CAPITAL
12 DEVELOPMENTS; PROVIDING FOR TRANSFERS FOR CAPITAL DEVELOPMENTS DEPENDING ON
13 ANNUAL DEBT SERVICE; REQUIRING CERTAIN TRANSFERS BE CONSIDERED PRESENT LAW BASE;
14 ESTABLISHING LONG-RANGE BUILDING PROGRAM ACCOUNTS FOR MAJOR REPAIR AND CAPITAL
15 DEVELOPMENTS; REQUIRING INCREASED PROGRAMMATIC AND MAINTENANCE FUNDING BE
16 APPROPRIATED IN CERTAIN CIRCUMSTANCES; PROVIDING DEFINITIONS; AMENDING SECTIONS
17 15-35-108, 16-11-119, 17-5-802, 17-7-111, 17-7-201, 17-7-202, 17-7-203, 17-7-204, 17-7-205, AND 90-4-625,
18 MCA; REPEALING SECTION 17-7-206, MCA; AND PROVIDING AN EFFECTIVE DATE."

20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

21
22 **NEW SECTION. Section 1. Major repair -- submission of list to legislature -- priorities.** (1) By
23 November 15 of the year preceding a regular legislative session, the division shall, on behalf of all state agencies,
24 submit a list of anticipated major repair projects to the governor. The governor shall review the list of anticipated
25 long-range building program eligible major repair projects recommended by the division and submit it to the
26 legislature.

27 (2) The division shall ensure that the list identifies:

28 (a) single projects that cost more than \$150,000;

29 (b) multiple projects within a single building or facility that collectively cost more than \$150,000; and

30 (c) single projects that will be constructed in phases with an aggregate cost of more than \$150,000.

1 (3) Unless otherwise directed by the legislature, the division shall execute major repair projects from the
2 prioritized list submitted to the legislature up to the level of appropriation made by the legislature.

3 (4) In prioritizing major repair projects, the division shall consider the results of the statewide facility
4 inventory and condition assessment prepared pursuant to 17-7-202.

5 (5) In prioritizing major repair projects, the division shall allocate at least 80% of the funds that the
6 legislature appropriates for major repair to:

7 (a) projects that address:

8 (i) any issue that impacts health and safety;

9 (ii) failing building envelopes;

10 (iii) structural deficiencies;

11 (iv) energy, utility, or water savings;

12 (b) projects that upgrade, repair, or replace:

13 (i) mechanical, plumbing, or control systems;

14 (ii) electrical systems;

15 (iii) fixed equipment;

16 (iv) an essential building component; or

17 (v) infrastructure, including a utility tunnel, water line, gas line, sewer line, roof, parking lot, or road; or

18 (c) projects that demolish and replace an existing building or facility that is in extensive disrepair and
19 cannot be fixed by repair or maintenance.

20 (6) In prioritizing major repair projects, the division shall allocate no more than 20% of the funds that the
21 legislature appropriates for major repair to:

22 (a) remodeling and aesthetic upgrades to meet programmatic needs; or

23 (b) construct an addition to an existing building or facility.

24

25 **NEW SECTION. Section 2. Funding for major repair -- emergency funding.** (1) After the legislature
26 approves the list of anticipated major repair projects, if an exigency arises that creates an unforeseen and critical
27 need for a major repair project, the division may reallocate major repair funds to address the project.

28 (2) The division shall report any changes made in major repair allocations approved by the legislature
29 to:

30 (a) the legislative fiscal analyst and the budget director on a quarterly basis; and

1 (b) the legislature at its next regular session.

2

3 **NEW SECTION. Section 3. Minimum funding for major repair -- restriction of capital**
4 **developments -- transfer to satisfy minimum as present law base.** (1) The minimum level of funding for major
5 repair projects is 0.6% of the replacement cost of existing long-range building program eligible buildings for each
6 fiscal year.

7 (2) The legislature may not fund the design or construction of any new capital development projects,
8 except to complete the funding of projects for which partial funding has been previously provided, until the
9 legislature has estimated and appropriated the amount referred to in subsection (1) to fund major repair projects
10 for long-range building program eligible buildings from the account established in 17-7-205 for each fiscal year.

11 (3) Sources for funding the amount referred to in subsection (1) are:

12 (a) revenue allocations into the account established in 17-7-205 of cigarette tax revenue allocated
13 pursuant to 16-11-119 and coal severance taxes allocated pursuant to 15-35-108, as projected in the official
14 revenue estimate provided in 5-5-227; and

15 (b) an appropriated transfer into the account from the general fund in the general appropriations act.

16 (4) The appropriated transfer in subsection (3)(b) to the account established in 17-7-205 to fund major
17 repair projects is part of the present law base for purposes of Title 17, chapter 7, part 1, and must be sufficient
18 to fund the amount referred to in subsection (1) when added to the account's revenue allocations in subsection
19 (3)(a).

20

21 **NEW SECTION. Section 4. Capital development funding -- transfer as present law base.** (1) The
22 legislature may appropriate funds in the general appropriations act for transfer funds into the account established
23 in [section 5] from the general fund for capital development projects. The amount of the transfer on an annual
24 basis is equal to 1% of the amount of the certified unaudited state general fund revenue, including transfers into
25 the general fund, as determined by the state treasurer on or before August 15 of the year preceding a legislative
26 session less the:

27 (a) general fund debt service anticipated by the office of budget and program planning for the biennium
28 for issued general obligation bonds as set forth in the state budget pursuant to 17-5-802, excluding coal
29 severance tax bonds;

30 (b) projected general fund debt service for general obligation bonds proposed in the executive budget,

1 excluding coal severance tax bonds; and

2 (c) revenue bonds whose source of funding impacts the general fund revenues or expenditures.

3 (2) The appropriated transfer to the account established in [section 5] to fund capital developments is
4 part of the present law base for purposes of Title 17, chapter 7, part 1, and must be sufficient to fund the amount
5 referred to in subsection (1).

6 (3) The department of administration shall transfer the annual amount appropriated in subsection (1)
7 from the general fund to the capital developments long-range building program account established in [section
8 5] by August 15 of each fiscal year except as provided in subsection (4).

9 (4) The department of administration may not make the annual transfer if the executive has authorized
10 transfers from the budget stabilization reserve fund established in 17-7-130 in the immediately preceding 12
11 months or if the transfer pursuant to subsection (1) would result in reductions pursuant to 17-7-140.

12

13 **NEW SECTION. Section 5. Capital developments long-range building program account.** (1) There
14 is a capital developments long-range building program account in the capital projects fund type to fund capital
15 developments.

16 (2) Interest earnings, project carryover funds, administrative fees, and miscellaneous revenue must be
17 retained in the account.

18 (3) The legislature may transfer unencumbered funds from the account only to supplement funding local
19 infrastructure.

20 (4) Funds in the account may be loaned to the general fund for cash flow purposes pursuant to 17-2-107.

21

22 **NEW SECTION. Section 6. Required funding for maintenance of newly authorized state buildings.**

23 (1) If construction of a new facility requires an immediate or future increase in state funding for program
24 expansion or operations and maintenance, the legislature may not authorize the new facility unless it also
25 appropriates funds for the increase in state funding for program expansion or operations and maintenance.

26 (2) (a) To the extent allowed by law, at the end of each fiscal year following approval of a new facility,
27 but prior to receipt of its certificate of occupancy, the entirety of the appropriation made pursuant to subsection
28 (1) reverts to its originating fund. The appropriation is not subject to the provisions of 17-7-304.

29 (b) When a certificate of occupancy for a new facility is received prior to the end of the fiscal year, the
30 amount of the appropriation made pursuant to subsection (1) that reverts to its originating fund is prorated for the

1 fiscal year from the day of the receipt of the certificate of occupancy.

2

3 **Section 7.** Section 15-35-108, MCA, is amended to read:

4 **"15-35-108. (Temporary) Disposal of severance taxes.** Severance taxes collected under this chapter
5 must, in accordance with the provisions of 17-2-124, be allocated as follows:

6 (1) Fifty percent of total coal severance tax collections is allocated to the trust fund created by Article IX,
7 section 5, of the Montana constitution. The trust fund money must be deposited in the fund established under
8 17-6-203(6) and invested by the board of investments as provided by law.

9 (2) The amount of 12% of coal severance tax collections is allocated to the major repair long-range
10 building program account established in 17-7-205.

11 (3) The amount of 0.85% in fiscal year 2018 and 0.88% in fiscal year 2019 must be allocated for
12 provision of basic library services for the residents of all counties through library federations and for payment of
13 the costs of participating in regional and national networking and must be deposited in the basic library services
14 account established in 22-1-202.

15 (4) The amount of 3.89% in fiscal year 2018 and 3.83% in fiscal year 2019 must be allocated to the
16 department of natural resources and conservation for conservation districts and deposited in the conservation
17 district account established in 76-15-106.

18 (5) The amount of 0.72% in fiscal year 2018 and 0.75% in fiscal year 2019 must be allocated to the
19 Montana Growth Through Agriculture Act and deposited in the growth through agriculture account established
20 in 90-9-104.

21 (6) The amount of 1.27% must be allocated to a permanent fund account for the purpose of parks
22 acquisition or management. Income from this permanent fund account, excluding unrealized gains and losses,
23 must be appropriated for the acquisition, development, operation, and maintenance of any sites and areas
24 described in 23-1-102.

25 (7) The amount of 0.95% must be allocated to the debt service fund type to the credit of the renewable
26 resource loan debt service fund.

27 (8) The amount of 0.63% must be allocated to a trust fund for the purpose of protection of works of art
28 in the capitol and for other cultural and aesthetic projects. Income from this trust fund account, excluding
29 unrealized gains and losses, must be appropriated for protection of works of art in the state capitol and for other
30 cultural and aesthetic projects.

1 (9) The amount of 5.8% through June 30, 2019, and beginning July 1, 2019, the amount of 2.9% must
2 be credited to the coal natural resource account established in 90-6-1001(2).

3 (10) After the allocations are made under subsections (2) through (9), \$250,000 for the fiscal year must
4 be credited to the coal and uranium mine permitting and reclamation program account established in 82-4-244.

5 (11) (a) Subject to subsection (11)(b), all other revenue from severance taxes collected under the
6 provisions of this chapter must be credited to the general fund of the state.

7 (b) The interest income of the coal severance tax permanent fund that is deposited in the general fund,
8 less the annual transfer of \$1.275 million to the research and commercialization state special revenue account
9 pursuant to 15-1-122(2), is statutorily appropriated, as provided in 17-7-502, on July 1 each year as follows:

10 (i) \$65,000 to the cooperative development center;

11 (ii) \$625,000 for the growth through agriculture program provided for in Title 90, chapter 9;

12 (iii) to the department of commerce:

13 (A) \$125,000 for a small business development center;

14 (B) \$50,000 for a small business innovative research program;

15 (C) \$425,000 for certified regional development corporations;

16 (D) \$200,000 for the Montana manufacturing extension center at Montana state university-Bozeman;

17 and

18 (E) \$300,000 for export trade enhancement. (Terminates June 30, 2019--secs. 2, 3, Ch. 459, L. 2009.)

19 **15-35-108. (Effective July 1, 2019) Disposal of severance taxes.** Severance taxes collected under
20 this chapter must, in accordance with the provisions of 17-2-124, be allocated as follows:

21 (1) Fifty percent of total coal severance tax collections is allocated to the trust fund created by Article IX,
22 section 5, of the Montana constitution. The trust fund money must be deposited in the fund established under
23 17-6-203(6) and invested by the board of investments as provided by law.

24 (2) The amount of 12% of coal severance tax collections is allocated to the major repair long-range
25 building program account established in 17-7-205.

26 (3) The amount of 0.90% in fiscal year 2020 and 0.93% in fiscal year 2021 and in each fiscal year
27 thereafter must be allocated for provision of basic library services for the residents of all counties through library
28 federations and for payment of the costs of participating in regional and national networking and must be
29 deposited in the basic library services account established in 22-1-202.

30 (4) The amount of 3.77% in fiscal year 2020 and 3.71% in fiscal year 2021 and in each fiscal year

1 thereafter must be allocated to the department of natural resources and conservation for conservation districts
2 and deposited in the conservation district account established in 76-15-106.

3 (5) The amount of 0.79% in fiscal year 2020 and 0.82% in fiscal year 2021 and in each fiscal year
4 thereafter must be allocated to the Montana Growth Through Agriculture Act and deposited in the growth through
5 agriculture account established in 90-9-104.

6 (6) The amount of 1.27% must be allocated to a permanent fund account for the purpose of parks
7 acquisition or management. Income from this permanent fund account, excluding unrealized gains and losses,
8 must be appropriated for the acquisition, development, operation, and maintenance of any sites and areas
9 described in 23-1-102.

10 (7) The amount of 0.95% must be allocated to the debt service fund type to the credit of the renewable
11 resource loan debt service fund.

12 (8) The amount of 0.63% must be allocated to a trust fund for the purpose of protection of works of art
13 in the capitol and for other cultural and aesthetic projects. Income from this trust fund account, excluding
14 unrealized gains and losses, must be appropriated for protection of works of art in the state capitol and for other
15 cultural and aesthetic projects.

16 (9) The amount of 2.9% must be credited to the coal natural resource account established in
17 90-6-1001(2).

18 (10) After the allocations are made under subsections (2) through (9), \$250,000 for the fiscal year must
19 be credited to the coal and uranium mine permitting and reclamation program account established in 82-4-244.

20 (11) All other revenue from severance taxes collected under the provisions of this chapter must be
21 credited to the general fund of the state."

22

23 **Section 8.** Section 16-11-119, MCA, is amended to read:

24 **"16-11-119. Disposition of taxes -- statutory appropriation.** (1) A sum equal to the amount necessary
25 to purchase cigarette tax stamps must be deposited to or allocated from the state special revenue fund to the
26 credit of the department from cigarette taxes collected under the provisions of 16-11-111, as provided in
27 subsection (5) of this section.

28 (2) After the deposit or allocation in subsection (1), cigarette taxes collected under the provisions of
29 16-11-111 must, in accordance with the provisions of 17-2-124, be deposited as follows:

30 (a) 8.3% or \$2 million, whichever is greater, in the state special revenue fund to the credit of the

1 department of public health and human services for the operation and maintenance of state veterans' nursing
2 homes;

3 (b) 2.6% in the major repair long-range building program account provided for in 17-7-205;

4 (c) 44% in the state special revenue fund to the credit of the health and medicaid initiatives account
5 provided for in 53-6-1201; and

6 (d) the remainder to the state general fund.

7 (3) If money in the state special revenue fund for the operation and maintenance of state veterans'
8 nursing homes exceeds \$2 million at the end of the fiscal year, the excess must be transferred to the state
9 general fund.

10 (4) The taxes collected on tobacco products other than cigarettes must in accordance with the provisions
11 of 17-2-124 be deposited as follows:

12 (a) one-half in the state general fund; and

13 (b) one-half in the state special revenue fund account for health and medicaid initiatives provided for in
14 53-6-1201.

15 (5) Each fiscal year, a sum equal to the amount of money necessary to purchase cigarette tax stamps
16 is statutorily appropriated, as provided in 17-7-502, from the state special revenue fund allocation in subsection
17 (1) to the department for tax administration responsibilities."

18

19 **Section 9.** Section 17-5-802, MCA, is amended to read:

20 **"17-5-802. Authority to issue general obligation bonds and notes --limitations.** (1) When authorized
21 by and within the limits of a bond act and as provided in this part, the board may issue and sell bonds of the state
22 in the manner that it considers necessary and proper to provide funds for the purpose set forth in the bond act.

23 (2) The full faith and credit and taxing powers of the state must be pledged for the payment of all bonds
24 and notes issued pursuant to this part, with all interest on the bonds and notes and premiums payable upon the
25 redemption of the bonds and notes. All principal, interest, and redemption premium, if any, becoming due during
26 a fiscal year must be included in the state budget for that fiscal year, and sufficient revenue must be appropriated
27 for the payment of principal, interest, and redemption premiums from the general fund and, if the general fund
28 is not sufficient, from any other funds of the state legally available for the payment of principal, interest, and
29 redemption premiums. Bonds may not be issued to cover deficits incurred because appropriations exceeded
30 anticipated revenue. Money transferred for the payment of bonds and notes must be deposited in the debt service

1 account.

2 (3) The legislature may not authorize general obligation bonds if the issuance of those bonds would
3 cause the total amount of the state debt to exceed 0.6% of the fair market value of the taxable property of the
4 state.

5 (4) For purposes of subsection (3):

6 (a) "fair market value of the taxable property of the state" includes all real and personal property subject
7 to ad valorem taxation within the state as enumerated in the department of revenue's biennial report issued
8 pursuant to 15-1-205.

9 (b) (i) "state debt" means:

10 (A) the outstanding portion of issued general obligation bonds as of the beginning of the current fiscal
11 year;

12 (B) the authorized level of all unissued general obligation bonds;

13 (C) bonds issued for the Montana state hospital pursuant to 90-7-221;

14 (D) the total amount of unfunded actuarial accrued liability of the public retirement systems established
15 in Title 19 that does not amortize in 30 years as identified in those systems' most recent actuarial valuation of the
16 assets and liabilities of their plans; and

17 (ii) The term does not include bonds authorized pursuant to:

18 (A) part 7 of this chapter for the issuance of coal severance tax bonds;

19 (B) the Drinking Water State Revolving Fund Act under the provisions of Title 75, chapter 6, part 2;

20 (C) CERCLA under the provisions of Title 75, chapter 10, part 6;

21 (D) the hard rock mining reclamation program under the provisions of Title 82, chapter 4, part 3; and

22 (E) the renewable resource program under the provisions of Title 85, chapter 1, part 6.

23 (5) The legislature may not authorize general obligation bonds, excluding coal severance tax bonds, if
24 the issuance of those bonds would create an obligation for annual debt service on general obligation bonds that
25 have been authorized and issued, excluding coal severance tax bonds, that exceeds 1.5% of the amount of the
26 certified unaudited state general fund revenue, including transfers into the general fund, as determined by the
27 state treasurer on or before August 15 of the year preceding a legislative session."

28

29 **Section 10.** Section 17-7-111, MCA, is amended to read:

30 **"17-7-111. Preparation of state budget -- agency program budgets -- form distribution and**

1 **contents.** (1) (a) To prepare a state budget, the executive branch, the legislature, and the citizens of the state
2 need information that is consistent and accurate. Necessary information includes detailed disbursements by fund
3 type for each agency and program for the appropriate time period, recommendations for creating a balanced
4 budget, and recommended disbursements and estimated receipts by fund type and fund category.

5 (b) Subject to the requirements of this chapter, the budget director and the legislative fiscal analyst shall
6 by agreement:

7 (i) establish necessary standards, formats, and other matters necessary to share information between
8 the agencies and to ensure that information is consistent and accurate for the preparation of the state's budget;
9 and

10 (ii) provide for the collection and provision of budgetary and financial information that is in addition to or
11 different from the information otherwise required to be provided pursuant to this section.

12 (2) In the preparation of a state budget, the budget director shall, not later than the date specified in
13 17-7-112(1), distribute to all agencies the proper forms and instructions necessary for the preparation of budget
14 estimates by the budget director. These forms must be prescribed by the budget director to procure the
15 information required by subsection (3). The forms must be submitted to the budget director by the date provided
16 in 17-7-112(2), or the agency's budget is subject to preparation based upon estimates as provided in 17-7-112(5).
17 The budget director may refuse to accept forms that do not comply with the provisions of this section or the
18 instructions given for completing the forms.

19 (3) The agency budget request must set forth a balanced financial plan for the agency completing the
20 forms for each fiscal year of the ensuing biennium. The plan must consist of:

21 (a) a consolidated agency budget summary of funds subject to appropriation, as provided in 17-8-101,
22 for the current base budget expenditures, including statutory appropriations, and for each present law adjustment
23 and new proposal request setting forth the aggregate figures of the full-time equivalent personnel positions (FTE)
24 and the budget, showing a balance between the total proposed disbursements and the total anticipated receipts,
25 together with the other means of financing the budget for each fiscal year of the ensuing biennium, contrasted
26 with the corresponding figures for the last-completed fiscal year and the fiscal year in progress;

27 (b) a schedule of the actual and projected receipts, disbursements, and solvency of each fund for the
28 current biennium and estimated for the subsequent biennium;

29 (c) a statement of the agency mission and a statement of goals and objectives for each program of the
30 agency. The goals and objectives must include, in a concise form, sufficient specific information and quantifiable

1 information to enable the legislature to formulate an appropriations policy regarding the agency and its programs
2 and to allow a determination, at some future date, on whether the agency has succeeded in attaining its goals
3 and objectives.

4 (d) actual FTE and disbursements for the completed fiscal year of the current biennium, estimated FTE
5 and disbursements for the current fiscal year, and the agency's request for the ensuing biennium, by program;

6 (e) actual disbursements for the completed fiscal year of the current biennium, estimated disbursements
7 for the current fiscal year, and the agency's recommendations for the ensuing biennium, by disbursement
8 category;

9 (f) for agencies with more than 20 FTE, a plan to reduce the proposed base budget for the general
10 appropriations act and the proposed state pay plan to 95% of the current base budget or lower if directed by the
11 budget director. Each agency plan must include base budget reductions that reflect the required percentage
12 reduction by fund type for the general fund and state special revenue fund types. Exempt from the calculations
13 of the 5% target amounts are legislative audit costs, administratively attached entities that hire their own staff
14 under 2-15-121, and state special revenue accounts that do not transfer their investment earnings or fund
15 balances to the general fund. The plan must include:

16 (i) a prioritized list of services that would be eliminated or reduced;

17 (ii) for each service included in the prioritized list, the savings that would result from the elimination or
18 reduction; and

19 (iii) the consequences or impacts of the proposed elimination or reduction of each service.

20 (g) a reference for each new information technology proposal stating whether the new proposal is
21 included in the approved agency information technology plan as required in 2-17-523;

22 (h) energy cost saving information as required by 90-4-616; and

23 (i) other information the budget director feels is necessary for the preparation of a budget.

24 (4) The budget director shall prepare and submit to the legislative fiscal analyst in accordance with
25 17-7-112:

26 (a) detailed recommendations for capital developments for:

27 (i) local infrastructure projects;

28 (ii) funding for energy development-impacted areas; and

29 (iii) the state long-range building program. Each recommendation for the capital developments long-range
30 building program must be presented by institution, agency, or branch, by funding source, with a description of

1 each proposed project.

2 (b) a statewide project budget summary as provided in 2-17-526;

3 (c) the proposed pay plan schedule for all executive branch employees at the program level by fund, with
4 the specific cost and funding recommendations for each agency. Submission of a pay plan schedule under this
5 subsection is not an unfair labor practice under 39-31-401.

6 (d) agency proposals for the use of cultural and aesthetic project grants under Title 22, chapter 2, part
7 3, the renewable resource grant and loan program under Title 85, chapter 1, part 6, the reclamation and
8 development grants program under Title 90, chapter 2, part 11, and the treasure state endowment program under
9 Title 90, chapter 6, part 7.

10 (5) The board of regents shall submit, with its budget request for each university unit in accordance with
11 17-7-112, a report on the university system bonded indebtedness and related finances as provided in this
12 subsection (5). The report must include the following information for each year of the biennium, contrasted with
13 the same information for the last-completed fiscal year and the fiscal year in progress:

14 (a) a schedule of estimated total bonded indebtedness for each university unit by bond indenture;

15 (b) a schedule of estimated revenue, expenditures, and fund balances by fiscal year for each outstanding
