5 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING LAWS RELATED TO THE PUBLIC
6 EMPLOYEE RETIREMENT SYSTEMS ADMINISTERED BY THE PUBLIC EMPLOYEES' RETIREMENT
7 BOARD; PROVIDING FOR RETIREMENT FROM NONLEGISLATIVE EMPLOYMENT; REVISING THE POST-
8 TERMINATION DEADLINE TO APPLY FOR DISABILITY RETIREMENT; PROVIDING THAT DUTY-RELATED
9 DISABILITY RETIREMENT BENEFITS DO NOT CONVERT TO NORMAL RETIREMENT ON REACHING
10 NORMAL RETIREMENT AGE; ASSESSING INTEREST ON PAYROLL REPORTING ERRORS THAT
11 REQUIRE RETROACTIVE CONTRIBUTIONS; PRORATING SERVICE PURCHASES WHEN A MEMBER
12 STOPS MAKING INSTALLMENT PAYMENTS; REMOVING THE PROVISION ALLOWING THE
13 RENOUNCEMENT OF BENEFITS; CLARIFYING THAT DISABILITY RETIREMENT BENEFITS CANNOT
14 BEGIN PRIOR TO THE COMPLETION OF AN APPLICATION; CLARIFYING THE APPLICATION OF EXCESS
15 EARNINGS FOR CALCULATION OF HIGHEST AND FINAL AVERAGE COMPENSATION; REVISING
16 REQUIRED MINIMUM DISTRIBUTION AND INHERITED ACCOUNT REQUIREMENTS TO COMPLY WITH
17 FEDERAL LAW; DEFINING "ALLOWANCE"; REVISING THE DEFINITION OF "COMPENSATION";
18 EXEMPTING RETIRED MEMBERS UNDER SUBPOENA IN LEGAL PROCEEDINGS RELATED TO PRIOR
19 EMPLOYMENT FROM WORKING RETIREE PROVISIONS; REVISING THE EXCLUSION OF BONUSES
20 FROM COMPENSATION IN THE JUDGES' RETIREMENT SYSTEM, THE HIGHWAY PATROL OFFICERS'
21 RETIREMENT SYSTEM, THE GAME WARDENS' AND PEACE OFFICERS' RETIREMENT SYSTEM, THE
22 MUNICIPAL POLICE OFFICERS' RETIREMENT SYSTEM, AND THE FIREFIGHTERS' UNIFIED
23 RETIREMENT SYSTEM; ALIGNING WORKING RETIREE LIMITS IN THE SHERIFFS' RETIREMENT
24 SYSTEM WITH SIMILAR PROVISIONS IN OTHER RETIREMENT SYSTEMS; CLARIFYING THAT
25 TERMINATION OF SERVICE IS NECESSARY PRIOR TO RETIREMENT FROM THE GAME WARDENS'
26 AND PEACE OFFICERS' RETIREMENT SYSTEM; CLARIFYING THE SURVIVORSHIP BENEFIT TO
27 BENEFICIARIES OF INACTIVE MEMBERS OF THE FIREFIGHTERS' UNIFIED RETIREMENT SYSTEM
28 WITH LESS THAN 20 YEARS OF SERVICE; PROVIDING RULEMAKING AUTHORITY; AMENDING

1 SECTIONS 5-2-304, 19-2-303, 19-2-406, 19-2-506, 19-2-704, 19-2-801, 19-2-908, 19-2-1005, 19-2-1007, 19-3-

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

7

8 **Section 1.** Section 5-2-304, MCA, is amended to read:

9 **"5-2-304. Participation in public retirement systems.** (1) The purpose of this section is to allow a
 10 person who is elected or appointed to the Montana legislature and who is also a member of a retirement
 11 system provided for in Title 19, chapter 3, 5, 6, 7, 8, 9, 13, 20, or 21, by virtue of the person's nonlegislative
 12 employment to continue the person's participation in the public retirement system of which the person is a
 13 member.

14 (2) This section is not intended to provide duplicate credit for the same service in two retirement
 15 systems supported wholly or in part by public funds. This section does not affect contribution rates or benefit
 16 payments specifically provided for in the laws governing the operation of individual retirement systems.

17 (3) A person who is an active member of a retirement system provided for in Title 19, chapter 3, 5,
 18 6, 7, 8, 9, or 13, by virtue of the person's nonlegislative employment and who is receiving service credit in that
 19 system pursuant to subsection (4) may elect to retire from that system on termination of service from their
 20 nonlegislative employment, but the person shall make a one-time, irrevocable election to decline further
 21 participation in that system while continuing to be engaged in official duties as a legislator.

22 ~~(3)~~(4) (a) A person who is an inactive or retired member of a retirement system provided for in Title
 23 19, chapter 5, 6, 7, 8, 9, 13, 20, or 21, and who is elected or appointed to be a legislator may:

24 (i) return to active membership in the system of which the person is an inactive or retired member
 25 under the requirements of that system; or

26 (ii) remain an inactive or retired member of the retirement system and become an active member
 27 of the public employees' retirement system pursuant to 19-3-413.

28 (b) A person who is an inactive or retired member of the public employees' retirement system

1 provided for in Title 19, chapter 3, and who is elected or appointed to the legislature may return to active
2 membership in the public employees' retirement system but cannot simultaneously be an inactive or retired
3 member of the system as a result of prior covered terminated employment and an active member of the
4 retirement system under 19-3-413 or this section.

5 ~~(4)~~(5) (a) A person who is an active member of a public retirement system governed by state law and
6 who is elected or appointed to be a legislator may, but is not required to, continue the person's participation in
7 that public retirement system while engaged in official duties as a legislator.

8 (b) To continue participation as an active member in the public retirement system, a legislator
9 shall, within 90 days of taking office and in a manner prescribed by the appropriate board, file an irrevocable
10 written election with the teachers' retirement board or the public employees' retirement board.

11 ~~(5)~~(6) A legislator who elects to continue participation as an active member as provided in ~~subsection~~
12 ~~(4)~~ subsection (5) shall continue the payments into the fund of the retirement system at the rate currently in
13 effect in the system based on the legislator's monthly salary as a member of that system.

14 ~~(6)~~(7) The state contribution must be made by legislative appropriation. It must equal the appropriate
15 employer contribution at the rate currently in effect in the system."

17 **Section 2.** Section 19-2-303, MCA, is amended to read:

18 **"19-2-303. Definitions.** Unless the context requires otherwise, for each of the retirement systems
19 subject to this chapter, the following definitions apply:

20 (1) "Accumulated contributions" means the sum of all the regular and any additional contributions
21 made by a member in a defined benefit plan, together with the regular interest on the contributions.

22 (2) "Active member" means a member who is a paid employee of an employer, is making the
23 required contributions, and is properly reported to the board for the most current reporting period.

24 (3) "Actuarial cost" means the amount determined by the board in a uniform and nondiscriminatory
25 manner to represent the present value of the benefits to be derived from the additional service to be credited
26 based on the most recent actuarial valuation for the system and the age, years until retirement, and current
27 salary of the member.

28 (4) "Actuarial equivalent" means a benefit of equal value when computed upon the basis of the

1 mortality table and interest rate assumptions adopted by the board.

2 (5) "Actuarial liabilities" means the excess of the present value of all benefits payable under a
3 defined benefit retirement plan over the present value of future normal costs in that retirement plan.

4 (6) "Actuary" means the actuary retained by the board in accordance with 19-2-405.

5 (7) "Additional contributions" means contributions made by a member of a defined benefit plan to
6 purchase various types of optional service credit as allowed by the applicable retirement plan.

7 (8) "Allowance" means predetermined remuneration from the employer to the employee for
8 expenses incurred while rendering services or to defray higher than normal costs for necessities, such as
9 housing or travel.

10 (8)(9) "Annuity" means:

11 (a) in the case of a defined benefit plan, equal and fixed payments for life that are the actuarial
12 equivalent of a lump-sum payment under a retirement plan and as such are not benefits paid by a retirement
13 plan and are not subject to periodic or one-time increases; or

14 (b) in the case of the defined contribution plan, a payment of a fixed sum of money at regular
15 intervals.

16 (9)(10) "Banked holiday time" means the hours reported for work performed on a holiday that the
17 employee may use for equivalent time off or that may be paid to the employee as specified by the employer's
18 policy.

19 (10)(11) "Benefit" means:

20 (a) the service retirement benefit, early retirement benefit, or disability retirement or survivorship
21 benefit payment provided by a defined benefit retirement plan; or

22 (b) a payment or distribution under the defined contribution retirement plan, including a disability
23 payment under 19-3-2141, for the exclusive benefit of a plan member or the member's beneficiary or an annuity
24 purchased under 19-3-2124.

25 (11)(12) "Board" means the public employees' retirement board provided for in 2-15-1009.

26 (12)(13) "Contingent annuitant" means:

27 (a) under option 2 or 3 provided for in 19-3-1501, one natural person designated to receive a
28 continuing monthly benefit after the death of a retired member; or

1 (b) under option 4 provided for in 19-3-1501, a natural person, charitable organization, estate, or
2 trust that may receive a continuing monthly benefit after the death of a retired member.

3 ~~(13)~~(14)"Covered employment" means employment in a covered position.

4 ~~(14)~~(15)"Covered position" means a position in which the employee must be a member of the
5 retirement system except as otherwise provided by law.

6 ~~(15)~~(16)"Defined benefit retirement plan" or "defined benefit plan" means a plan within the retirement
7 systems provided for pursuant to 19-2-302 that is not the defined contribution retirement plan.

8 ~~(16)~~(17)"Defined contribution retirement plan" or "defined contribution plan" means the plan within the
9 public employees' retirement system established in 19-3-103 that is provided for in chapter 3, part 21, of this
10 title and that is not a defined benefit plan.

11 ~~(17)~~(18)"Department" means the department of administration.

12 ~~(18)~~(19)"Designated beneficiary" means the person, charitable organization, estate, or trust for the
13 benefit of a natural person designated by a member or payment recipient to receive any survivorship benefits,
14 lump-sum payments, or benefit from a retirement account upon the death of the member or payment recipient,
15 including annuities derived from the benefits or payments.

16 ~~(19)~~(20)"Direct rollover" means a payment by the retirement plan to the eligible retirement plan
17 specified by the distributee or a payment from an eligible retirement plan to the retirement plan specified by the
18 distributee.

19 ~~(20)~~(21)"Disability" or "disabled" means a total inability of the member to perform the member's duties
20 by reason of physical or mental incapacity. The disability must be incurred while the member is an active
21 member and must be one of permanent duration or of extended and uncertain duration, as determined by the
22 board on the basis of competent medical opinion.

23 ~~(21)~~(22)"Distributee" means:

24 (a) a member;

25 (b) a member's surviving spouse;

26 (c) a member's spouse or former spouse who is the alternate payee under a family law order as
27 defined in 19-2-907; or

28 (d) effective January 1, 2007, a member's nonspouse beneficiary who is a designated beneficiary

1 as defined by section 401(a)(9)(E) of the Internal Revenue Code, 26 U.S.C. 401(a)(9)(E).

2 ~~(22)~~(23)"Early retirement benefit" means the retirement benefit payable to a member following early
3 retirement and is the actuarial equivalent of the accrued portion of the member's service retirement benefit.

4 ~~(23)~~(24)"Eligible retirement plan" means any of the following that accepts the distributee's eligible
5 rollover distribution:

6 (a) an individual retirement account described in section 408(a) of the Internal Revenue Code, 26
7 U.S.C. 408(a);

8 (b) an individual retirement annuity described in section 408(b) of the Internal Revenue Code, 26
9 U.S.C. 408(b);

10 (c) an annuity plan described in section 403(a) of the Internal Revenue Code, 26 U.S.C. 403(a);

11 (d) a qualified trust described in section 401(a) of the Internal Revenue Code, 26 U.S.C. 401(a);

12 (e) effective January 1, 2002, an annuity contract described in section 403(b) of the Internal
13 Revenue Code, 26 U.S.C. 403(b);

14 (f) effective January 1, 2002, a plan eligible under section 457(b) of the Internal Revenue Code,
15 26 U.S.C. 457(b), that is maintained by a state, a political subdivision of a state, or any agency or
16 instrumentality of a state or a political subdivision of a state that agrees to separately account for amounts
17 transferred into that plan from a plan under this title; or

18 (g) effective January 1, 2008, a Roth IRA described in section 408A of the Internal Revenue Code,
19 26 U.S.C. 408A.

20 ~~(24)~~(25)"Eligible rollover distribution":

21 (a) means any distribution of all or any portion of the balance from a retirement plan to the credit of
22 the distributee, as provided in 19-2-1011;

23 (b) effective January 1, 2002, includes a distribution to a surviving spouse or to a spouse or former
24 spouse who is an alternate payee under a domestic relations order, as defined in section 414(p) of the Internal
25 Revenue Code, 26 U.S.C. 414(p).

26 ~~(25)~~(26)"Employee" means a person who is employed by an employer in any capacity and whose
27 salary is being paid by the employer or a person for whom an interlocal governmental entity is responsible for
28 paying retirement contributions pursuant to 7-11-105.

1 ~~(26)~~(27)"Employer" means a governmental agency participating in a retirement system enumerated in
2 19-2-302 on behalf of its eligible employees. The term includes an interlocal governmental entity identified as
3 responsible for paying retirement contributions pursuant to 7-11-105.

4 ~~(27)~~(28)"Essential elements of the position" means fundamental job duties. An element may be
5 considered essential because of but not limited to the following factors:

- 6 (a) the position exists to perform the element;
7 (b) there are a limited number of employees to perform the element; or
8 (c) the element is highly specialized.

9 ~~(28)~~(29)"Excess earnings" means the difference, if any, between reported compensation and the limits
10 provided in 19-2-1005(2) used to calculate a member's highest average compensation or final average
11 compensation.

12 ~~(29)~~(30)"Fiscal year" means a plan year, which is any year commencing with July 1 and ending the
13 following June 30.

14 ~~(30)~~(31)"Inactive member" means a member who terminates service and does not retire or take a
15 refund of the member's accumulated contributions.

16 ~~(34)~~(32)"Internal Revenue Code" has the meaning provided in 15-30-2101.

17 ~~(32)~~(33)"Member" means either:

18 (a) a person with accumulated contributions and service credited with a defined benefit retirement
19 plan or receiving a retirement benefit on account of the person's previous service credited in a retirement
20 system; or

21 (b) a person with a retirement account in the defined contribution plan.

22 ~~(33)~~(34)"Membership service" means the periods of service that are used to determine eligibility for
23 retirement or other benefits.

24 ~~(34)~~(35)(a) "Normal cost" or "future normal cost" means an amount calculated under an actuarial cost
25 method required to fund accruing benefits for members of a defined benefit retirement plan during any year in
26 the future.

27 (b) Normal cost does not include any portion of the supplemental costs of a retirement plan.

28 ~~(35)~~(36)"Normal retirement age" means the age at which a member is eligible to immediately receive a

1 retirement benefit based on the member's age or both age and length of service, as specified under the
2 member's retirement system, without disability and without an actuarial or similar reduction in the benefit.

3 ~~(36)~~(37)"Pension" means benefit payments for life derived from contributions to a retirement plan made
4 from state- or employer-controlled funds.

5 ~~(37)~~(38)"Pension trust fund" means a fund established to hold the contributions, income, and assets of
6 a retirement system or plan in public trust.

7 ~~(38)~~(39)"Plan choice rate" means the amount of the employer contribution as a percentage of payroll
8 covered by the defined contribution plan members that is allocated to the public employees' retirement system's
9 defined benefit plan pursuant to 19-3-2117 to actuarially fund the unfunded liabilities and the normal cost rate
10 changes in a defined benefit plan resulting from member selection of the defined contribution plan.

11 ~~(39)~~(40)"Regular contributions" means contributions required from members under a retirement plan.

12 ~~(40)~~(41)"Regular interest" means interest at rates set from time to time by the board.

13 ~~(41)~~(42)"Retirement" or "retired" means the status of a member who has:

14 (a) terminated from service; and

15 (b) received and accepted a retirement benefit from a retirement plan.

16 ~~(42)~~(43)"Retirement account" means an individual account within the defined contribution retirement
17 plan for the deposit of employer and member contributions and other assets for the exclusive benefit of a
18 member of the defined contribution plan or the member's beneficiary.

19 ~~(43)~~(44)"Retirement benefit" means:

20 (a) in the case of a defined benefit plan, the periodic benefit payable as a result of service
21 retirement, early retirement, or disability retirement under a defined benefit plan of a retirement system. With
22 respect to a defined benefit plan, the term does not mean an annuity.

23 (b) in the case of the defined contribution plan, a benefit as defined in subsection ~~(10)(b)~~ (11)(b).

24 ~~(44)~~(45)"Retirement plan" or "plan" means either a defined benefit plan or a defined contribution plan
25 under one of the public employee retirement systems enumerated in 19-2-302.

26 ~~(45)~~(46)"Retirement system" or "system" means one of the public employee retirement systems
27 enumerated in 19-2-302.

28 ~~(46)~~(47)"Service" means employment of an employee in a position covered by a retirement system.

1 ~~(47)~~(48)"Service credit" means the periods of time for which the required contributions have been made
2 to a retirement plan and that are used to calculate retirement benefits or survivorship benefits under a defined
3 benefit retirement plan.

4 ~~(48)~~(49)"Service retirement benefit" means the retirement benefit that the member may receive at
5 normal retirement age.

6 ~~(49)~~(50)"Statutory beneficiary" means the surviving spouse or dependent child or children of a member
7 of the highway patrol officers', municipal police officers', or firefighters' unified retirement system who are
8 statutorily designated to receive benefits upon the death of the member.

9 ~~(50)~~(51)"Supplemental cost" means an element of the total actuarial cost of a defined benefit retirement
10 plan arising from benefits payable for service performed prior to the inception of the retirement plan or prior to
11 the date of contribution rate increases, changes in actuarial assumptions, actuarial losses, or failure to fund or
12 otherwise recognize normal cost accruals or interest on supplemental costs. These costs are included in the
13 unfunded actuarial liabilities of the retirement plan.

14 ~~(51)~~(52)"Survivorship benefit" means payments for life to the statutory or designated beneficiary of a
15 deceased member who died while in service under a defined benefit retirement plan.

16 ~~(52)~~(53)"Termination of employment", "termination from employment", "terminated employment",
17 "terminated from employment", "terminate employment", or "terminates employment" means that:

18 (a) there has been a complete severance of a covered employment relationship by the positive act
19 of either the employee, the employer, or both; and

20 (b) the member is no longer receiving compensation for covered employment, other than any
21 outstanding lump-sum payment for compensatory leave, sick leave, or annual leave.

22 ~~(53)~~(54)"Termination of service", "termination from service", "terminated from service", "terminated
23 service", "terminating service", or "terminates service" means that:

24 (a) there has been a complete severance of a covered employment relationship by the positive act
25 of either the employee, the employer, or both for at least 30 days;

26 (b) no written or verbal agreement exists between employee and employer that the employee will
27 return to covered employment in the future;

28 (c) the member is no longer receiving compensation for covered employment; and

1 (d) the member has been paid all compensation for compensatory leave, sick leave, or annual
 2 leave to which the member was entitled. For the purposes of this subsection ~~(53)~~ (54), compensation does not
 3 mean compensation as a result of a legal action, court order, or settlement to which the board was not a party.

4 ~~(54)~~(55)"Unfunded actuarial liabilities" or "unfunded liabilities" means the excess of a defined benefit
 5 retirement plan's actuarial liabilities at any given point in time over the value of its cash and investments on that
 6 same date.

7 ~~(55)~~(56)"Vested account" means an individual account within a defined contribution plan that is for the
 8 exclusive benefit of a member or the member's beneficiary. A vested account includes all contributions and the
 9 income on all contributions in each of the following accounts:

- 10 (a) the member's contribution account;
 11 (b) the vested portion of the employer's contribution account; and
 12 (c) the member's account for other contributions.

13 ~~(56)~~(57)"Vested member" or "vested" means:

- 14 (a) with respect to a defined benefit plan, except as provided in subsection ~~(56)(b)~~ (57)(b), a
 15 member or the status of a member who has at least 5 years of membership service;
 16 (b) with respect to a member of the highway patrol officers' retirement system established in Title
 17 19, chapter 6, who was hired on or after July 1, 2013, a member or the status of a member who has at least 10
 18 years of membership service; or
 19 (c) with respect to the defined contribution plan, a member or the status of a member who meets
 20 the minimum membership service requirement of 19-3-2116.

21 ~~(57)~~(58)"Written application" or "written election" means a written instrument, prescribed by the board
 22 or required by law, properly signed and filed with the board, that contains all required information, including
 23 documentation that the board considers necessary.

24 ~~(58)~~(59)"Written instrument" includes an electronic record containing an electronic signature, as defined
 25 in 30-18-102."

27 **Section 3.** Section 19-2-406, MCA, is amended to read:

28 **"19-2-406. Disability retirement -- application -- determination -- benefit conversion -- rules. (1)**

1 (a) An active or inactive member may apply for disability retirement in a manner prescribed by the board.
 2 However, an application may also be filed on the member's behalf by the head of the office or department in
 3 which the member is or was last employed, by any other individual, or by the board.

4 (b) The application must be filed within ~~4 months~~ 6 months after the member's termination from
 5 employment ~~unless the member is disabled continuously from the date of termination from employment to the~~
 6 ~~date of the application.~~

7 (2) The board shall determine whether a member has become disabled. In the discharge of its duty
 8 regarding determinations, the board, any member of the board, or any authorized representative of the board
 9 may order medical examinations, conduct hearings, administer oaths and affirmations, take depositions, certify
 10 to official acts and records, and issue subpoenas to compel the attendance of witnesses and the production of
 11 books, papers, correspondence, memoranda, and other records considered necessary as evidence in
 12 connection with a claim for disability retirement. Subpoenas must be issued and enforced pursuant to 2-4-104
 13 of the Montana Administrative Procedure Act.

14 (3) The board shall adopt rules requiring employers to identify and explain the essential elements
 15 of a member's position, any accommodations that were or can be made in compliance with the Americans With
 16 Disabilities Act of 1990 (42 U.S.C. 12101, et seq.), and the effectiveness of the accommodations.

17 (4) The board shall retain medical personnel to advise it in assessing the nature and extent of
 18 disabling conditions while reviewing claims for disability retirement.

19 (5) The disability retirement benefit paid to a member of the defined benefit plan provided for in
 20 Title 19, chapter 3, 9, or 13, must be converted to a service retirement benefit, without recalculation of the
 21 monthly benefit amount, when the member ~~has attained~~ attains normal retirement age. The board shall notify
 22 the member in writing as to the change in status.

23 (6) The disability retirement benefit paid to a member of the defined benefit plan provided for in
 24 Title 19, chapter 5, 6, 7, or 8, remains a disability retirement benefit when the member attains normal retirement
 25 age, but the disability retirement benefit is no longer subject to a medical examination of the member."

27 **Section 4.** Section 19-2-506, MCA, is amended to read:

28 **"19-2-506. Payment of contributions by employers -- accompanying reports -- penalty --**

1 **liability.** (1) The board shall prescribe by rule the procedure for payment of retirement contributions for the
2 retirement systems administered by the board. Each employer shall pick up the employee contributions and
3 remit the employer and employee contributions required by the member's retirement system. Payments must
4 be considered delinquent until both the required contributions and the valid payroll report are received by the
5 board.

6 (2) The board may collect payments delinquent under subsection (1) with an interest penalty at the
7 rate of 9% a year or \$10 a day, whichever is greater. The board may, in its discretion, waive the penalty. The
8 collection may be made by either:

9 (a) an action in a court of competent jurisdiction against the employer; or

10 (b) deductions, at the request of the board, from any other money payable to the employer by any
11 agency or fund of the state.

12 (3) (a) The board shall prescribe by rule the procedure for submitting employer reports. The
13 reports must include data about member and nonmember employees who work for the employer.

14 (b) The rules must specify the employee categories to be reported, the data required, the method
15 of reporting, the reporting period, and the frequency of reports needed to meet the demands of the relevant
16 retirement system or plan.

17 (c) The board may establish by rule the penalty fees for noncompliance in reporting any of the

27 for distributing the materials."

2 **"19-2-704. Purchasing service credits allowed -- payroll deduction.** (1) Subject to the rules
3 promulgated by the board, an eligible member may elect to make additional contributions to purchase service

6 applicable limitation, the retiree's benefits must be temporarily reduced \$1 for each \$1 of compensation earned
7 in service beyond the applicable limitation during that calendar year.

8 (3) (a) The employer of a retiree returning to employment covered by the retirement system shall
9 certify to the board the number of hours worked by the retiree and the gross compensation paid to the retiree in
10 that employment during any pay period after retirement. The certification of hours and compensation may be
11 submitted electronically pursuant to rules adopted by the board.

12 (b) An employer that fails to timely or accurately report the employment of, time worked by, or
13 compensation paid to a retired member as required under subsection (3)(a) is jointly and severally liable with
