19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

21 **Section 1.** Section 31-1-202, MCA, is amended to read:

22 **"31-1-202. Definitions -- scope.** (1) Unless the context requires otherwise, in this part the following
23 definitions apply:

24 (a) "Cash sale price" means the price stated in a retail installment contract or in a sales slip or other
25 memorandum furnished by a retail seller to a retail buyer under or in connection with a retail charge account
26 agreement for which the seller would have sold or furnished to the buyer and the buyer would have bought or
27 obtained from the seller the goods or services that are the subject matter of the retail installment transaction, if
28 the sale had been a sale for cash. The cash sale price may include any taxes, registration, certificate of title,
29 license, and official fees and cash sale prices for services, if any, and for accessories and their installation and
30 for delivering, servicing, repairing, or improving the goods.

1 (b) "Department" means the department of administration provided for in Title 2, chapter 15, part 10.

2 (c) "Finance charge" means the amount, as limited by 31-1-241, in addition to the principal balance,
3 agreed upon between the buyer and the seller, to be paid by the buyer for the privilege of purchasing goods or
4 services to be paid for by the buyer in one or more deferred installments.

5 (d) "Goods" means all chattels personal, including motor vehicles and merchandise certificates or
6 coupons exchangeable for chattels personal but not including money, ~~or things in action, or dwellings as defined~~
7 in 15 U.S.C. 1602(v). ~~The term includes goods that, at the time of the sale or subsequently, are to be so affixed~~
8 ~~to realty as to become a part of the realty, whether or not severable from it.~~

9 (e) "Holder" means:

10 (i) the retail seller of the goods or services under the retail installment contract or retail charge account
11 agreement or a person who establishes and administers retail charge account agreements with retail buyers;

12 (ii) the assignee, if the retail installment contract or the retail charge account agreement or the balance
13 in the account under either has been sold or otherwise transferred; or

14 (iii) any other person entitled to the rights of the retail seller under any retail installment contract or any
15 retail charge account agreement.

16 (f) "Manufactured structure" means any structure, transportable in one or more sections, designed to be
17 used as a single-family dwelling or commercial building with or without a permanent foundation when connected
18 to the required utilities and includes the plumbing, heating, air-conditioning, and electrical systems contained in
19 the structure.

20 (g) (i) "Motor vehicle" means any new or used automobile, motorcycle, quadricycle, truck, trailer,
21 semitrailer, truck tractor, and all vehicles with any power, other than muscular power, primarily designed or used
22 to transport persons or property on a public highway.

23 (ii) The term does not include any vehicle that runs only on rails or tracks or in the air.

24 (iii) The term does not include a dwelling as defined in 15 U.S.C. 1602(v).

25 (h) "Official fees" means:

26 (i) the fees prescribed by law for filing, recording, or otherwise perfecting and releasing or satisfying any
27 title or lien retained or taken by a seller in connection with a retail installment transaction; or

28 (ii) the premium for insurance in lieu of filing, recording, or otherwise perfecting any title or lien retained
29 or taken by a seller in connection with a retail installment transaction to the extent that the premium does not
30 exceed the fees that would otherwise be payable for filing, recording, or otherwise perfecting and releasing or

1 satisfying any title or lien retained or taken by a seller in connection with a retail installment transaction.

2 (i) "Person" means an individual, partnership, corporation, association, and any other group, however
3 organized.

4 (j) "Principal balance" means the cash sale price of the goods or services that are the subject matter of
5 a retail installment transaction plus the amounts, if any, included in the sale, if a separate identified charge is
6 made and stated in the contract, for insurance and other benefits and official fees, minus the amount of the
7 buyer's downpayment in money or goods.

8 (k) "Recreational vehicle" means a vehicular type unit that either has its own motor power or is mounted
9 on or drawn by another vehicle, primarily designed as temporary living quarters for recreational, camping, or
10 travel use.

11 (l) "Retail buyer" or "buyer" means a person who buys goods or obtains services from a retail seller in
12 a retail installment transaction and not for the purpose of resale.

13 (m) "Retail charge account agreement" means an instrument in writing prescribing the terms of retail
14 installment transactions that may be made under it from time to time under which a retail seller gives to a retail
15 buyer the privilege of using a credit card issued by the retail seller or any other person or other credit confirmation
16 or identification for the purpose of purchasing goods or services from the retail seller, from the retail seller and
17 any other person, or from a person licensed or franchised by the retail seller and under the terms of which a
18 finance charge may be computed in relation to the buyer's average daily balance in the account during the billing
19 cycle or the buyer's balance from time to time.

20 (n) "Retail installment contract" or "contract" means an agreement evidencing a retail installment
21 transaction entered into in this state under which a buyer promises to pay in one or more deferred installments
22 the time sale price of goods or services, or both. The term includes a chattel mortgage, a conditional sales
23 contract, and a contract for the bailment or leasing of goods by which the bailee or lessee contracts to pay as
24 compensation for its use a sum substantially equivalent to or in excess of its value and by which it is agreed that
25 the bailee or lessee is bound to become, or for no further or a merely nominal consideration has the option of
26 becoming, the owner of the goods upon full compliance with the provisions of the contract.

27 (o) "Retail installment transaction" means a written contract to sell or furnish, or the sale or furnishing
28 of, goods or services by a retail seller to a retail buyer pursuant to a retail charge account agreement or under
29 a retail installment contract.

30 (p) "Retail seller" or "seller" means a person who sells goods or furnishes services to a retail buyer in

1 a written retail installment contract or written retail installment transaction.

2 (q) (i) "Sales finance company" means a person engaged, in whole or in part, in the business of
3 purchasing retail installment contracts from one or more sellers. The term includes but is not limited to a bank,
4 trust company, investment company, or savings and loan association, if engaged in purchasing retail installment
5 contracts.

6 (ii) The term does not include a person who makes only isolated purchases of retail installment contracts
7 that are not being made in the course of repeated and successive purchases of retail installment contracts from
8 the same seller.

9 (r) "Services" means work, labor, and services furnished in the delivery, installation, servicing, repair,
10 or improvement of goods.

11 (s) "Time sale price" means the total of the cash sale price of the goods or services and the amount, if
12 any, included for insurance and other benefits, if a separate identified charge is made for insurance and benefits,
13 and the amounts of the official fees and the finance charge.

14 (2) (a) This part does not apply to the lending of money by banks or other lending institutions and
15 securing loans by chattel mortgages of goods in the ordinary course of lending by those banks or other lending
16 institutions.

17 (b) This part applies to the extension of credit by those banks or other lending institutions under retail
18 installment contracts or credit cards issued by those banks or other lending institutions.

19 ~~(c) This part does not apply to a person who is licensed pursuant to TRANSACTION GOVERNED BY Title 32,~~
20 ~~chapter 9, part 1, as a mortgage broker, mortgage lender, or mortgager servicer and who is in compliance with~~
21 ~~the provisions of Title 32, chapter 9, part 1."~~

23 **Section 2.** Section 32-5-102, MCA, is amended to read:

24 **"32-5-102. Definitions.** Unless the context requires otherwise, in this chapter, the following definitions
25 apply:

26 (1) "Balloon payment" means any repayment option in which the borrower is required to repay the entire
27 amount of any outstanding balance as of a specific date or at the end of a specified term and the aggregate
28 amount of the required minimum periodic payments would not fully amortize the outstanding balance by the
29 specific date or at the end of the loan term.

30 (2) (a) "Consumer loan" means credit offered or extended to an individual primarily for personal, family,

1 or household purposes, including loans for personal, family, or household purposes that are not primarily secured
2 by a mortgage, deed of trust, trust indenture, or other security interest in real estate.

3 (b) Consumer loans do not include:

4 (i) deferred deposit loans provided for in Title 31, chapter 1, part 7; ~~or~~

5 (ii) title loans provided for in Title 31, chapter 1, part 8; or

6 (iii) residential mortgage loans as defined in 32-9-103.

7 (3) "Department" means the department of administration provided for in Title 2, chapter 15, part 10.

8 (4) "Interest" means the compensation allowed by law or fixed by the parties for the use or forbearance
9 or detention of money and includes loan origination fees, points, and prepaid finance charges, as defined in 12
10 CFR 226.2.

11 (5) "License" means a license provided for by this chapter.

12 (6) "Licensee" means the person holding a license.

13 (7) "Person" means individuals, partnerships, associations, corporations, and all legal entities."
14

15 **Section 3.** Section 32-7-103, MCA, is amended to read:

16 **"32-7-103. Exemptions.** (1) The provisions of this part do not apply to the following:

17 (a) a person licensed by this state pursuant to Title 37, chapter 61, as an attorney at law who is not
18 actively engaged in the escrow business;

19 (b) a person licensed by this state pursuant to Title 37, chapter 50, as a public accountant who is not
20 actively engaged in the escrow business;

21 (c) a person whose principal business is that of preparing abstracts or making searches of title that are
22 used as a basis for the issuance of any title insurance policy by a company doing business under the laws of this
23 state relating to insurance companies and the person is regulated by the commissioner of insurance;

24 (d) a person licensed pursuant to Title 32, chapter 9, part 1, as a mortgage broker, mortgage lender, or
25 mortgage servicer;

26 ~~(d)~~(e) a financial institution, as defined in 32-6-103, that has its escrow accounts regularly audited or
27 examined. The financial institution shall supply a copy of the most recently prepared audit or examination to the
28 director upon the director's request.

29 ~~(e)~~(f) except as provided in subsection (2), any broker licensed by the Montana board of realty regulation
30 if the broker is performing an act:

1 (i) in the course of or incidental to a single real estate transaction; and

2 (ii) for which a real estate license is required; and

3 ~~(f)~~(g) any person furnishing escrow services under the order of a court.

4 (2) A trust account of a broker licensed by the Montana board of realty regulation is not an escrow
5 account within the meaning of this part."

7 **Section 4.** Section 32-9-101, MCA, is amended to read:

8 **"32-9-101. Short title and purpose.** (1) This part may be cited as the "Montana Mortgage ~~Broker,~~
9 ~~Mortgage Lender, and Mortgage Loan Originator Licensing Act~~".

10 (2) The legislature recognizes that buying or financing a home is one of the largest, most complicated,
11 and vitally important decisions facing consumers in Montana. Therefore, the legislature finds it desirable to license
12 certain persons in the residential mortgage industry that are outside of the traditional banking industry and that
13 have a direct involvement in consumers' financial welfare, including mortgage brokers, mortgage lenders,
14 mortgage servicers, and mortgage loan originators, to promote honesty, education, and professionalism, to
15 ensure the availability and diversity of residential mortgage funding, and to protect Montana consumers and the
16 stability of Montana's economy.

17 (3) The legislature finds that it is necessary to implement the federal Secure and Fair Enforcement for
18 Mortgage Licensing Act of 2008 and, together with the residential mortgage industry, recognizes the importance
19 of statewide participation in the nationwide mortgage licensing system and registry. (See compiler's comment
20 regarding contingent suspension.)"

22 **Section 5.** Section 32-9-102, MCA, is amended to read:

23 **"32-9-102. License requirement -- registration.** (1) Unless exempt under 32-9-104, a person may not
24 act as a mortgage broker, mortgage lender, mortgage servicer, or mortgage loan originator with respect to any
25 residential ~~real estate~~ mortgage loan located in Montana unless licensed under the provisions of this part.

26 (2) ~~Any~~ A person acting as a mortgage broker, mortgage lender, mortgage servicer, or mortgage loan
27 originator under this part is required to be licensed ~~and through~~, registered with, and maintain a valid unique
28 identifier issued by the nationwide mortgage licensing system and registry ~~by the date set forth in 32-9-105(4).~~
29 (See compiler's comment regarding contingent suspension.)"

30

1 **Section 6.** Section 32-9-103, MCA, is amended to read:

2 **"32-9-103. Definitions.** As used in this part, the following definitions apply:

3 (1) "Administrative or clerical tasks" mean the receipt, collection, and distribution of information common
4 for the processing or underwriting of a residential mortgage loan and communication with a consumer to obtain
5 information necessary for the processing or underwriting of a residential mortgage loan to the extent that the
6 communication does not include offering or negotiating loan rates or terms or counseling consumers about
7 residential mortgage loan rates or terms.

8 (2) "Approved education course" means any course approved by the nationwide mortgage licensing
9 system and registry.

10 (3) "Approved test provider" means any test provider approved by the nationwide mortgage licensing
11 system and registry.

12 (4) "Bona fide third party" means a person that provides services relative to the origination of a residential
13 mortgage loan transactions. The term includes but is not limited to real estate appraisers and credit reporting
14 agencies.

15 (5) "Borrower" means a person seeking a residential mortgage loan or an obligor on a residential
16 mortgage loan.

17 (6) "Branch office" means a location at which a licensee conducts business other than a licensee's
18 principal place of business. The location is considered a branch office if:

19 (a) the address of the location appears on business cards, stationery, or advertising used by the entity;

20 (b) the entity's name or advertising suggests that mortgages are made at the location;

21 (c) the location is held out to the public as a licensee's place of business due to the actions of an
22 employee or independent contractor of the entity; or

23 (d) the location is controlled directly or indirectly by the entity.

24 (7) (a) "Control" means the power, directly or indirectly, to direct the management or policies of an entity,
25 whether through ownership of securities, by contract, or otherwise.

26 (b) A person is presumed to control an entity if that person:

27 (i) is a director, general partner, or executive officer;

28 (ii) directly or indirectly has the right to vote 10% or more of a class of a voting security or has the power
29 to sell or direct the sale of 10% or more of a class of voting securities;

30 (iii) in the case of a limited liability company, is a managing member; or

1 (iv) in the case of a partnership, has the right to receive upon dissolution or has contributed 10% or more
2 of the capital.

3 (8) "Department" means the department of administration provided for in 2-15-1001, acting through its
4 division of banking and financial institutions.

5 (9) "Depository institution" has the meaning provided in section 3 of the Federal Deposit Insurance Act,
6 12 U.S.C. 1813(c), and includes any credit union.

7 (10) "Designated manager" means a mortgage loan originator with at least 3 years of experience as a
8 mortgage loan originator or registered mortgage loan originator who is designated by an entity as the individual
9 responsible for the operation of a particular location that is under the designated manager's full management,
10 supervision, and control.

11 (11) "Dwelling" has the meaning provided in 15 U.S.C. 1602(v).

12 ~~(11)~~(12) "Entity" means a business organization, including a sole proprietorship.

13 ~~(12)~~(13) "Escrow account" means a depository account with a financial institution that provides deposit
14 insurance and that is separate and distinct from any personal, business, or other account of the mortgage lender
15 or mortgage servicer and is maintained solely for the holding and payment of escrow funds.

16 ~~(13)~~(14) "Escrow funds" means funds entrusted to a mortgage lender or mortgage servicer by a borrower
17 for payment of taxes, insurance, or other payments to be made in connection with the servicing of a loan.

18 ~~(14)~~(15) "Federal banking agency" means the board of governors of the federal reserve system, the
19 comptroller of the currency, the director of the office of thrift supervision, the national credit union administration,
20 or the federal deposit insurance corporation.

21 ~~(15)~~(16) "Immediate family member" means a spouse, child, sibling, grandparent, grandchild, stepchild,
22 stepbrother, or stepsister and includes parent, grandparent, child, grandchild, and sibling relationships based
23 upon adoptive relationships.

24 ~~(16)~~(17) "Individual" means a natural person.

25 ~~(17)~~(18) "Licensee" means a person authorized pursuant to this part to engage in activities regulated by
26 this part. The term does not include an individual who is a registered mortgage loan originator.

27 ~~(18)~~(19) "Loan commitment" means a statement transmitted in writing or electronically by a mortgage
28 lender setting forth the terms and conditions upon which the mortgage lender is willing to make a particular
29 residential mortgage loan to a particular borrower.

30 ~~(19)~~(20) "Loan processor or underwriter" means an individual who performs administrative or clerical

1 tasks as an employee, subsequent to the receipt of a residential mortgage loan application, at the direction of and
 2 subject to the supervision of a licensed mortgage loan originator or registered mortgage loan originator.

3 ~~(20)~~(21) "Mortgage" means a consensual interest in real property located in Montana, including
 4 improvements, securing a debt evidenced by a mortgage, trust indenture, deed of trust, or other lien on real
 5 property.

6 ~~(24)~~(22) (a) "Mortgage broker" means an entity that obtains, attempts to obtain, or assists in obtaining
 7 a mortgage loan for a borrower from a mortgage lender in return for consideration or in anticipation of
 8 consideration.

9 (b) For purposes of this subsection ~~(24)~~ (22), attempting to or assisting in obtaining a mortgage loan
 10 includes referring a borrower to a mortgage lender or mortgage broker, soliciting or offering to solicit a mortgage
 11 loan on behalf of a borrower, or negotiating or offering to negotiate the terms or conditions of a mortgage loan
 12 with a mortgage lender on behalf of a borrower.

13 ~~(22)~~(23) "Mortgage lender" means an entity that closes a residential mortgage loan, advances funds,
 14 offers to advance funds, or commits to advancing funds for a mortgage loan applicant.

15 ~~(23)~~(24) (a) "Mortgage loan originator" means an individual who for compensation or gain or in the
 16 expectation of compensation or gain:

17 (i) takes a residential mortgage loan application; or

18 (ii) offers or negotiates terms of a residential mortgage loan.

19 (b) The term does not include an individual:

20 (i) engaged solely as a loan processor or underwriter, except as provided in 32-9-129; or

21 (ii) involved solely in extensions of credit relating to timeshare plans, as that term is defined in 11 U.S.C.
 22 101(53D).

23 ~~(24) "Mortgage servicer loss mitigation specialist" means a person who on behalf of the person making~~
 24 ~~the residential mortgage loan works with a borrower who is in default or in a foreseeable likelihood of a default~~
 25 ~~to modify or refinance either temporarily or permanently the borrower's obligations in order to avoid foreclosure~~
 26 ~~or otherwise to finalize collection through the foreclosure process:~~

27 (25) "Mortgage servicer" means an entity that:

28 (a) engages, for compensation or gain from another or on its own behalf, in the business of receiving
 29 any scheduled periodic payment from a borrower pursuant to the terms of a residential mortgage loan, residential
 30 mortgage servicing documents, or a residential mortgage servicing contract; or

1 (b) meets the definition of "servicer" in 12 U.S.C. 2605(i)(2) with respect to residential mortgage loans.

2 ~~(25)(26)~~ "Nationwide mortgage licensing system and registry" means a mortgage licensing system
3 developed and maintained by the conference of state bank supervisors and the American association of
4 residential mortgage regulators for the registration of state-licensed mortgage brokers, state-licensed mortgage
5 lenders, state-licensed mortgage servicers, state-licensed mortgage loan originators, and registered mortgage
6 loan originators.

7 ~~(26)(27)~~ "Nontraditional mortgage product" means any mortgage product other than a 30-year, fixed-rate
8 mortgage.

9 ~~(27)(28)~~ "Person" means an individual, sole proprietorship, corporation, company, limited liability
10 company, partnership, limited liability partnership, trust, or association.

11 ~~(28)(29)~~ "Real estate brokerage activities" means activities that involve offering or providing real estate
12 brokerage services to the public, including:

13 (a) acting as a real estate salesperson or real estate broker for a buyer, seller, lessor, or lessee of real
14 property;

15 (b) bringing together parties interested in the sale, purchase, lease, rental, or exchange of real property;

16 (c) negotiating, on behalf of any party, any portion of a contract relating to the sale, purchase, lease,
17 rental, or exchange of real property other than in connection with providing financing with respect to the
18 transaction;

19 (d) engaging in any activity for which a person is required to be licensed as a real estate salesperson
20 or real estate broker under Montana law; or

21 (e) offering to engage in any activity or act in any capacity described in subsections ~~(28)(a)~~ (29)(a)
22 through ~~(28)(d)~~ (29)(d).

23 ~~(29)(30)~~ "Registered mortgage loan originator" means an individual who:

24 (a) meets the definition of mortgage loan originator and is an employee of:

25 (i) a depository institution;

26 (ii) a subsidiary that is owned and controlled by a depository institution and regulated by a federal banking
27 agency; or

28 (iii) an institution regulated by the farm credit administration; and

29 (b) is registered with and maintains a unique identifier through the nationwide mortgage licensing system
30 and registry.

1 ~~(30)~~(31) "Residential mortgage loan" means a loan primarily for personal, family, or household use
 2 secured by a mortgage, deed of trust, or other equivalent consensual security interest on a dwelling, ~~as defined~~
 3 ~~in section 103(v) of the Truth in Lending Act, 15 U.S.C. 1602(v)~~, or on residential real estate located in Montana.

4 ~~(34)~~(32) "Residential real estate" means any real property located in the state of Montana upon which
 5 is constructed a dwelling or upon which a dwelling is intended to be built within a 2-year period, subject to 24 CFR
 6 3500.5(b)(4). The borrower's intent to construct a dwelling is presumed unless the borrower has submitted a
 7 written, signed statement to the contrary.

8 ~~(32)~~(33) "Trust account" means a depository account with a financial institution that provides deposit
 9 insurance that is separate and distinct from any personal, business, or other account of the mortgage broker or
 10 the mortgage lender and that is maintained solely for the holding and payment of bona fide third-party fees.

11 (34) "Trust account funds" means money entrusted to a mortgage lender or mortgage broker during the
 12 origination of a mortgage loan for the payment of services provided by a bona fide third party, which does not
 13 include the services of a mortgage broker, mortgage lender, or mortgage loan originator. The term includes
 14 appraisal fees, credit report fees, and other fees required for the mortgage loan origination.

15 ~~(33)~~(35) "Ultimate equity owner" means an individual who, directly or indirectly, owns or controls an
 16 ownership interest in a corporation, a foreign corporation, an alien business organization, or any other form of
 17 business organization, regardless of whether the individual owns or controls an ownership interest, individually
 18 or in any combination, through one or more persons or one or more proxies, powers of attorney, nominees,
 19 corporations, associations, partnerships, trusts, joint-stock companies, or other entities or devices.

20 ~~(34)~~(36) "Unique identifier" means a number or other identifier assigned by protocols established by the
 21 nationwide mortgage licensing system and registry. (See compiler's comment regarding contingent suspension.)"

23 **Section 7.** Section 32-9-104, MCA, is amended to read:

24 **"32-9-104. Exemptions -- proof of exemption.** (1) The provisions of this part do not apply to:

25 (a) an entity that is an agency of the federal, state, or municipal government;

26 (b) an entity described in 32-9-103~~(29)(a)(i)~~(30)(a)(i) through ~~(29)(a)(iii)~~ (30)(a)(iii);

27 (c) a registered mortgage loan originator when acting for an entity described in
 28 32-9-103~~(29)(a)(i)~~(30)(a)(i) through ~~(29)(a)(iii)~~ (30)(a)(iii);

 8 purposes. Confidential material is not subject to public inspection, subpoena, or discovery. To the extent that
 9 examination reports, work papers, and other confidential material contain personal financial information and
 10 personal identification information of individuals, those individuals retain a reasonable expectation of privacy in
 11 their personal financial or personal identification information, subject to the licensee's and any uninvolved
 12 person's reasonable expectation of privacy and; although filed with the department as provided in this part, are
 13 that information is not subject to public inspection, subpoena, or discovery except as directed by a court of law.

14 (6) This section does not apply to information or material relating to the employment history of and
 15 publicly adjudicated disciplinary and enforcement actions against mortgage lenders, mortgage servicers,
 16 mortgage brokers, and mortgage loan originators included in the nationwide mortgage licensing system and
 17 registry that is available for public access. (See compiler's comment regarding contingent suspension.)"

 19 **NEW SECTION. Section 38. Repealer.** The following sections of the Montana Code Annotated are
 20 repealed:

21 32-9-114. Provisional licenses and previously licensed persons.
 22 32-9-127. Compliance of current mortgage brokers, mortgage lenders, and mortgage loan originator
 23 licensees with background check and minimum standards -- renewals.

 25 **NEW SECTION. Section 39. Codification instruction.** [Sections 8, 21, 22, 24, 25, and 34] are
 26 intended to be codified as an integral part of Title 32, chapter 9, part 1, and the provisions of Title 32, chapter 9,
 27 part 1, apply to [sections 8, 21, 22, 24, 25, and 34].
