15	the previous 6 years; or				
16	(b)	a lawyer, THE LAWYER'S LAW FIRM, or party to the proceeding has made one or more			
17	contributions directly or indirectly to a political committee or other entity that engaged in independent				
18	expenditures that supported the judicial officer or opposed the judicial officer's opponent in an election that was				
19	held within the previous 6 years if the total combined amount of the contributions exceeds the maximum				
20	amount that would otherwise be allowed under 13-37-216 if the contributions had been made directly to the				
21	judicial candidate \$10,000 FOR A CANDIDATE FOR A SUPREME COURT OFFICE OR \$5,000 FOR A CANDIDATE FOR ANY
