4	A BILL FOR AN ACT ENTITLED: "AN ACT REDUCING FROM 5 DAYS TO 48 HOURS THE PERIOD OF TIME

6	BEFORE THE VEHICLE MAY BE TAKEN INTO CUSTODY; AND AMENDING SECTION 61-12-401, MCA."

8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	Section 1. Section 61-12-401, MCA, is amended to read:
11	"61-12-401. Taking vehicle into custody. (1) The following law enforcement agencies may take into
12	custody any motor vehicle found abandoned for a period of 48 hours or more on the right-of-way of a public
13	highway or on private property or for a period of 5 days or more on a city street, or public property, or private
14	<del>property</del> :
15	(a) the Montana highway patrol if the vehicle is <del>upon</del> on the right-of-way of any public highway other than
16	a county road;
17	(b) the sheriff of the county if the vehicle is <del>upon</del> on the right-of-way of any county road;
18	(c) the city police if the vehicle is <del>upon</del> on a city street.
19	(2) The Montana highway patrol, sheriff of the county, or city police may use their personnel, equipment,
20	and facilities for the removal and storage of the vehicle or may hire other personnel, equipment, and facilities for
21	those purposes.
22	(3) If the Montana highway patrol, the sheriff of the county, or the chief of police of the city in which the
23	vehicle is being stored has hired other personnel, equipment, and facilities to remove and store a vehicle, the
24	Montana highway patrol, sheriff, or chief of police shall either:
25	(a) pay the person hired to remove the vehicle an amount not to exceed the amount for a removal charge
26	established by rules adopted by the department of environmental quality and may request reimbursement of the
27	hired removal charge from the motor vehicle recycling and disposal program of the department of environmental
28	quality in an amount and manner established by rules adopted by the department of environmental quality for this
29	purpose; or
30	(b) authorize the person hired to remove the vehicle to submit directly to the department of environmental

1 quality a claim for payment to be made directly to the person hired to remove the vehicle.

(4) (a) At the request of the owner or person in lawful possession or control of the private property, the sheriff of the county in which the vehicle is located or the city police of the city in which the vehicle is located may remove and hold it in the manner and upon the conditions provided in subsections (1) and (2).

(b) A private landowner owning property considered to be part of ways of this state open to the public, as defined in 61-8-101, who can demonstrate meeting the 5-day 48-hour waiting period in subsection (1) by calling one of the law enforcement agencies listed in subsection (1) at the start of the 5-day 48-hour period may remove the abandoned vehicle within the conditions provided for in subsections (1) and (2)."
