11	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

13	Section 1. Section 41-5-2003, MCA, is amended to read:
14	"41-5-2003. Establishment of program department duties office of court administrator duties.
15	(1) There is a juvenile delinquency intervention program. Each judicial district shall participate in the program.
16	(2) The department and the judicial district shall monitor the judicial district's annual allocation provided
17	for in 41-5-130 to ensure that the judicial district does not exceed its allocation.
18	(3) The department shall provide technical assistance to each judicial district for the monitoring of its
19	annual allocation.
20	(4) The office of court administrator shall assist each youth court in developing placement alternatives
21	and community intervention and prevention programs and services.
22	(5) (a) Each Except as provided in subsection (6), each fiscal year, the office of court administrator shall
23	select out-of-home placements, programs, and services to be evaluated for their effectiveness in achieving the
24	purposes provided in 41-5-2002. The cost containment review panel shall provide recommendations to the office
25	on out-of-home placements, programs, and services to be evaluated and on the scope of the evaluation. Before
26	conducting any evaluation, the office shall obtain approval from the district court council established in 3-1-1602.
27	(b) The office shall report the results of any evaluation conducted under subsection (5)(a) each year to
28	the department, cost containment review panel, district court council, and law and justice interim committee.
29	(6) On or before June 30, 2011 IN FISCAL YEARS 2011 THROUGH 2013, the office of court administrator
30	shall transfer \$25,000 IN EACH FISCAL YEAR from the youth court intervention and prevention account to the general
