1 A BILL TO BE ENTITLED  
2 AN ACT TO ALLOW CERTAIN LOCAL SCHOOL ADMINISTRATIVE UNITS TO ALIGN  
3 THE SCHOOL CALENDARS OF THOSE UNITS WITH LOCAL COMMUNITY  
4 COLLEGES.

5 Whereas, the State-mandated, late-August start date creates barriers to dual  
6 enrollment by putting high schools out of alignment with community colleges, which typically  
7 begin the first semester earlier in August, and begin the second semester two or three weeks  
8 before high school students complete the fall semester; and

9 Whereas, academic alignment would benefit all students in local school  
10 administrative units who are enrolled in classes through a local community college by allowing  
11 them to align their fall and spring semesters with the fall and spring semesters of the local  
12 community colleges; and

13 Whereas, academic alignment would allow local school administrative units to work  
14 with local community colleges to meet workforce development needs more effectively by  
15 helping high school and college students develop the skills necessary for business and industry;  
16 Now, therefore,

17 The General Assembly of North Carolina enacts:

18 **SECTION 1.** G.S. 115C-84.2(d) reads as rewritten:

19 "(d) Opening and Closing Dates. – Local boards of education shall determine the dates of  
20 opening and closing the public schools under subdivision (a)(1) of this ~~section~~section in  
21 accordance with the following requirements:

22 (1) ~~Except for year-round schools, the~~The opening date for students shall be no  
23 earlier than the Monday closest to August 26, and the closing date for students  
24 shall be no later than the Friday closest to ~~June 11~~June 11, except in the  
25 following circumstances:

- 26 a. The school is a year-round school.  
27 b. The school's calendar is aligned so that it is no earlier than the opening  
28 date of a community college serving the county in which the school  
29 unit is located, in whole or in part.

30 (2) On a showing of good cause, the State Board of Education may waive the  
31 requirement that the opening date for students be no earlier than the Monday  
32 closest to August 26 and may allow the local board of education to set an  
33 opening date no earlier than the Monday closest to August 19, to the extent  
34 that school calendars are able to provide sufficient days to accommodate  
35 anticipated makeup days due to school closings. ~~A local board may revise the~~



1 ~~scheduled closing date if necessary in order to comply with the minimum~~  
2 ~~requirements for instructional days or instructional time.~~ For purposes of this  
3 ~~subsection, subdivision,~~ the term "good cause" means that schools in any local  
4 school administrative unit in a county have been closed eight days per year  
5 during any four of the last 10 years because of severe weather conditions,  
6 energy shortages, power failures, or other emergency situations.

7 (3) A local board may revise the scheduled closing date if necessary in order to  
8 comply with the minimum requirements for instructional days or instructional  
9 time.

10 ~~The required opening and closing dates under this subsection shall not apply to any school~~  
11 ~~that a local board designated as having a modified calendar for the 2003-2004 school year or to~~  
12 ~~any school that was part of a planned program in the 2003-2004 school year for a system of~~  
13 ~~modified calendar schools, so long as the school operates under a modified calendar."~~

14 **SECTION 2.** This act applies only to Chatham County Schools, Edgecombe County  
15 Schools, Elkin City Schools, Martin County Schools, Mt. Airy City Schools, Surry County  
16 Schools, and Union County Public Schools.

17 **SECTION 3.** This act is effective when it becomes law and applies beginning with  
18 the 2021-2022 school year.
