ENGROSSED HOUSE BILL NO. 1019

Introduced by

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state board for
2 career and technical education; to create and enact sections 15-20.1-26 and 15-20.1-27 of the
3 North Dakota Century Code, relating to the meetings, compensation, powers, and duties of the
4 educational technology council; to amend and reenact section 15-19-06 of the North Dakota
5 Century Code, relating to the center for distance education operating fund; and to repeal
6 sections 54-59-17 and 54-59-18 of the North Dakota Century Code, relating to the meetings,
7 compensation, powers, and duties of the educational technology council.

8 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

9 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
10 as may be necessary, are appropriated out of any moneys in the general fund in the state
11 treasury, not otherwise appropriated, and from special funds derived from federal funds and
12 other income, to the state board for career and technical education for the purpose of defraying
13 the expenses of the state board for career and technical education, for the biennium beginning
14 July 1, 2019, and ending June 30, 2021, as follows:

7 **SECTION 2. ONE-TIME FUNDING.** The following amounts reflect the one-time funding
8 items approved by the sixty-fifth legislative assembly for the 2017-19 biennium:

15 **SECTION 3. AMENDMENT.** Section 15-19-06 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **15-19-06. Special funds - Deposit of collections - Transfers from general fund**
18 **appropriations.**

19 1. A special operating fund for the center for distance education must be maintained
20 within the state treasury and all income and fees collected by the center for distance
21 education from any source must be remitted monthly by the director to the state
22 treasurer and credited to the special operating fund. All expenditures from the fund
23 must be within the limits of legislative appropriations and must be made upon
24 vouchers, signed and approved by the ~~technology director appointed by the~~
25 ~~educational technology council of the department of career and technical education.~~
26 Upon approval of the vouchers by the office of the budget, warrant-checks must be
27 prepared by the office of management and budget. The state treasurer shall make
28 periodic transfers upon order of the director of the office of management and budget
29 from the center for distance education general fund appropriation to the special
30 operating fund whenever its balance falls so low as to require supplementation.

1 2. The educational technology council may establish an administrative operational fund,
2 of not to exceed ten thousand dollars, out of the special operating fund for the center
3 for distance education. The administrative operational fund must be deposited in the
4 Bank of North Dakota and may be drawn upon by the state director of the center for
5 distance education for the payment of necessary expenses in the administration and
6 operation of the center for distance education within the limits and rules prescribed by
7 the educational technology council. The director shall submit a full, minute, and
8 itemized statement of every expenditure made during the month to the council in
9 accordance with the rules adopted by the council, and thereafter the council may
10 periodically authorize additional transfers to the administrative operational fund, but
11 the balance in the fund may never exceed ten thousand dollars, and any
12 unencumbered balance at the end of any biennium must revert to the state treasury.
13 The administrative operational fund may not be used to pay salaries or expenses of
14 the director.

15 3. The educational technology council may establish a scholarship fund to provide
16 financial grants to students enrolled in courses offered through the center for distance
17 education. The scholarship fund may consist only of those funds specifically
18 appropriated by the legislative assembly and property received by the council or the
19 center for distance education as a gift, devise, or bequest. Any gift, devise, or bequest
20 of property received by the council or center for distance education which is
21 designated by the council and donor for the scholarship fund must be deposited in the
22 scholarship fund at the Bank of North Dakota. The state director of the center for
23 distance education may draw only on the interest earned by the scholarship fund for
24 the award of scholarships within the limits and rules adopted by the educational
25 technology council. The interest earned by the scholarship fund is appropriated to the
26 center for distance education.

27 **SECTION 4.** Section 15-20.1-26 of the North Dakota Century Code is created and enacted
28 as follows:

29 **15-20.1-26. Educational technology council - Meetings - Compensation.**

30 1. The educational technology council is responsible for coordinating educational
31 technology initiatives for elementary and secondary education.

- 1 2. The educational technology council consists of:
- 2 a. The chief information officer.
- 3 b. The superintendent of public instruction or the superintendent's designee.
- 4 c. The commissioner of higher education or the commissioner's designee.
- 5 d. A representative appointed by the state board for career and technical education.
- 6 e. A representative appointed by the governor from a list of three nominees
- 7 submitted by the North Dakota association of technology leaders.
- 8 f. A representative appointed by the governor from a list of three nominees
- 9 submitted by the North Dakota council of educational leaders.
- 10 g. A representative appointed by the governor from a list of three nominees
- 11 submitted by the North Dakota school boards association.
- 12 h. A representative appointed by the governor from a list of three nominees
- 13 submitted by the North Dakota association of special education directors.
- 14 i. A school district representative who is appointed by the governor and who
- 15 represents a school district that has an enrollment in kindergarten through grade
- 16 twelve of fewer than four hundred.
- 17 j. A school district representative who is appointed by the governor, who is licensed
- 18 to teach by the educational standards and practices board, and who is employed
- 19 by a public school district in this state as a classroom teacher.
- 20 k. The director of technology for the department of public instruction.
- 21 l. A representative appointed by the governor from a list of three nominees
- 22 submitted by the state association of nonpublic schools.
- 23 3. The council shall select a chairman from among its members.
- 24 4. The term of office for the members appointed by the governor is four years.
- 25 5. The members of the educational technology council appointed by the governor are
- 26 entitled to receive as compensation sixty-two dollars and fifty cents per day and
- 27 reimbursement of expenses as provided by law for state officers while attending
- 28 meetings of the council.

29 **SECTION 5.** Section 15-20.1-27 of the North Dakota Century Code is created and enacted
30 as follows:

1 **15-20.1-27. North Dakota educational technology council - Powers and duties.**

2 The educational technology council shall:

3 1. Coordinate the use of technology and the development of technology systems to
4 enhance educational opportunities for elementary and secondary education.

5 2. Cooperate with state agencies and other organizations to develop statewide
6 educational technology systems.

7 3. Adopt bylaws for the conduct of its affairs.

8 4. Publish the informational material it deems necessary.

9 5. Conduct a continuing study to assess the needs, resources, and facilities that are
10 available or which may be required to establish educational technology systems
11 throughout the state.

12 6. Solicit and receive moneys from public and private sources and expend the moneys
13 for educational technology.

14 7. Appoint a technology director who shall serve at the will of the council.

15 8. Hire the director of the center for distance education.

16 **SECTION 6. REPEAL.** Sections 54-59-17 and 54-59-18 of the North Dakota Century Code
17 are repealed.
