3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. There is appropriated out of any moneys in the general	
fund in the state treasury, not otherwise appropriated, the sums as hereinafter provided or so	
much of the sums as may be necessary, and from special funds derived from the disaster relief	
fund in the state treasury. These sums increase the general fund and special fund authority	
enacted by the sixty-third legislative assembly to the stated departments and institutions of the	
state of North Dakota for the purpose of defraying their expenses, for the period beginning	
January 1, 2015, and ending June 30, 2015, as follows:
