**FIRST ENGROSSMENT
with Conference Committee Amendments
ENGROSSED SENATE BILL NO. 2023**

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of various state
2 departments and institutions; to provide for a transfer; to provide an exemption; and to declare
3 an emergency.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** There is appropriated out of any moneys in the general
6 fund in the state treasury, not otherwise appropriated, the sums as hereinafter provided or so
7 much of the sums as may be necessary, and from special funds derived from the disaster relief
8 fund in the state treasury. These sums increase the general fund and special fund authority
9 enacted by the sixty-third legislative assembly to the stated departments and institutions of the
10 state of North Dakota for the purpose of defraying their expenses, for the period beginning
11 January 1, 2015, and ending June 30, 2015, as follows:

1 **SECTION 2. ADJUTANT GENERAL - VALLEY STATE UNIVERSITY - STATE DISASTER**

2 **RELIEF FUND.** The operating expenses line item in subdivision 9 of section 1 of this Act
3 includes \$5,000,000 from the state disaster relief fund. The capital assets line item in
4 subdivision 6 of section 1 of this Act includes \$3,000,000 from the state disaster relief fund.

5 **SECTION 3. EXEMPTION - TRANSFER - EMERGENCY COMMISSION CONTINGENCY**

6 **FUND TO COMMISSION ON LEGAL COUNSEL FOR INDIGENTS.** Notwithstanding the
7 provisions of section 54-16-04 and 54-16-09, which require emergency commission and budget
8 section approval, the office of management and budget shall transfer spending authority of
9 \$200,000 from the state contingencies appropriation in the emergency commission contingency
10 fund line item in section 1 of chapter 15 of the 2013 Session Laws to the commission on legal
11 counsel for indigents for the period beginning with the effective date of this Act and ending
12 June 30, 2015.

13 **SECTION 4. EMERGENCY.** This Act is declared to be an emergency measure.
