- 1 A BILL for an Act to amend and reenact subsection 15 of section 27-20-02, sections 27-20-30.1
- 2 and 27-20-38 of the North Dakota Century Code, relating to the definition of permanency
- 3 hearing, a foster care agreement with an agency or tribal council of a recognized Indian
- 4 reservation in North Dakota, and the rights and duties of legal custodian.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 SECTION 1. AMENDMENT. Subsection 15 of section 27-20-02 of the North Dakota 7 Century Code is amended and reenacted as follows:
- 8 "Permanency hearing" means a hearing, conducted with respect to a child who is in 15. 9 foster care, to determine the permanency plan for the child which includes:
  - Whether and, if applicable, when the child will be returned to the parent: a.
  - b. Whether and, if applicable, when the child will be placed for adoption and the state will file a petition for termination of parental rights;
    - C. Whether and, if applicable, when a fit and willing relative or other appropriate individual will be appointed as a legal guardian;
    - Whether and, if applicable, to place siblings in the same foster care, relative, d. guardianship, or adoptive placement, unless it is determined that the joint placement would be contrary to the safety or well-being of any of the siblings;
    - Whether and, if applicable, in the case of siblings removed from their home who e. are not jointly placed, to provide for frequent visitation or other ongoing interaction between the siblings, unless it is determined to be contrary to the safety or well-being of any of the siblings;
    - In cases in which a compelling reason has been shown that it would not be in the child's best interests to return home, to have parental rights terminated, to be placed for adoption, to be placed with a fit and willing relative, or to be placed

Section 27-20-38 of the North Dakota Century Code is 6 amended and reenacted as follows: 7 27-20-38. Rights and duties of legal custodian. 8 A custodian to whom legal custody has been given by the court under this chapter has: 9 The right to the physical custody of the child and the right to determine the nature of 10 the care, placement, and treatment of the child, including ordinary medical care as well 11 as medical or surgical treatment for a serious physical condition or illness which in the 12 opinion of a licensed physician requires prompt treatment, except for any limits the 13 court may impose. 14 2.
