

**SECOND ENGROSSMENT
with House Amendments
REENGROSSED SENATE BILL NO. 2089**

(At the request of the Department of Mineral Resources)

1 A BILL for an Act to create and enact section 54-17.6-06.1 of the North Dakota Century Code,
2 relating to clean natural gas capture and emissions reduction; and to provide for a transfer.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1.** Section 54-17.6-06.1 of the North Dakota Century Code is created and
5 enacted as follows:

6 **54-17.6-06.1. Clean natural gas capture and emissions reduction program.**

7 1. The clean natural gas capture and emissions reduction program shall provide an
8 incentive for natural gas capture and utilization systems on an oil or gas well site or
9 gathering pipeline facility which collect or utilizes over fifty percent of propane and
10 heavier hydrocarbons from an oil and gas well site for beneficial use by:

11 a. Compressing or liquefying gas for artificial lift, uses as fuel, or for nonpipeline
12 transport to a processing facility;

13 b. Conversion to liquid fuels;

14 c. Conversion to electricity for onsite use or supply to the electrical grid;

15 d. Conversion to computational power;

16 e. Collection of tank vapors for beneficial use or transport to a processing facility;

17 f. Temporary gas injection into producing wells in lieu of flaring or shutting in wells;
18 or

19 g. Other value-added processes as approved by the industrial commission.

20 2. The commission is granted all the powers necessary and appropriate to effectuate the
21 provisions of this chapter.

22 3. The commission:

23 a. May make grants or loans or provide other forms of financial assistance as

24 necessary or appropriate to qualified entities for activities under subsection 1;

- 1 **b.** Shall keep accurate records of all financial transactions performed under this
2 chapter;
- 3 **c.** May accept donations, grants, federal funds, contributions, and gifts from any
4 public or private source and deposit such in the natural gas capture and
5 utilization incentive fund;
- 6 **d.** May make and explore orders, rules, and policies necessary to effectuate the
7 purpose of this chapter; and
- 8 **e.** Shall consult with the council in matters of policy affecting the administration of
9 the clean natural gas capture and emissions reduction program.

10 **SECTION 2. TRANSFER - STRATEGIC INVESTMENT AND IMPROVEMENTS FUND TO**

11 **OIL AND GAS RESEARCH FUND.** The office of management and budget shall transfer the
12 sum of \$1,000,000 from the strategic investment and improvements fund to the oil and gas
13 research fund under section 57-51.1-07.3, during the biennium beginning July 1, 2023, and
14 ending June 30, 2025.
