## ENGROSSED SENATE BILL NO. 2286

1 A BILL for an Act to amend and reenact sections 53-01-02, 53-01-07, and 53-01-09 of the North  
2 Dakota Century Code, relating to the duties of the state combative sports commissioner.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 53-01-02 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **53-01-02. Administration by secretary of state - Appointment of athletic advisory**  
7 **board and mixed fighting style advisory board**~~athletic advisory board~~**combative sports commission.**

8 The secretary of state shall act as state ~~athletic~~combative sports commissioner and  
9 administer this chapter. The secretary of state may appoint an ~~athletic advisory board~~a  
10 combative sports commission to assist and advise the secretary of state in matters relating to  
11 the regulation of boxing, kickboxing, mixed fighting style competition, and sparring. ~~The~~  
12 ~~secretary of state also may appoint a mixed fighting style advisory board whose members may~~  
13 ~~include one or more members of the athletic advisory board.~~ The secretary of state shall define  
14 the duties of each ~~board~~the commission. ~~Board~~Commission members are not entitled to  
15 compensation, except for reimbursement for actual and necessary expenses at the same rate  
16 as allowed state employees incurred in performing their official duties.

17 **SECTION 2. AMENDMENT.** Section 53-01-07 of the North Dakota Century Code is  
18 amended and reenacted as follows:

19 **53-01-07. Duties of state** ~~athletic~~combative sports **commissioner.**

20 The secretary of state shall supervise all boxing, kickboxing, mixed fighting style  
21 competitions, or sparring exhibitions held in the state and may:

- 22 1. Adopt, at any time, combined rules governing the conduct of boxing, kickboxing, mixed  
23 fighting style competitions, and sparring exhibitions. In lieu of adopting combined rules  
24 the secretary of state may regulate the conduct of any boxing, kickboxing, mixed

1           fighting style, or sparring match, competition, or exhibition through the use of the most  
2           recent uniform rules of boxing and the unified rules of mixed martial arts published by  
3           the association of boxing commissions.

4           2. Establish license fees for all boxers, kickboxers, mixed style fighters, boxing,  
5           kickboxing, and mixed fighting style competition promoters, managers, judges,  
6           timekeepers, cornerpersons, knockdown counters, matchmakers, and referees or  
7           other participants.

8           3. Establish a fee based on the percentage of gross revenues from any boxing,  
9           kickboxing, mixed fighting style competition, or sparring exhibition held in this state to  
10          pay for the expenses of members of the ~~athletic advisory board or the mixed fighting~~  
11          ~~style advisory board~~combative sports commission. A fee established under this  
12          subsection may not exceed three percent of the gross revenues of the exhibition from  
13          any and all sources including cable television and pay-per-view telecasts of the event,  
14          exclusive of any federal tax thereon, but in no event may the fee be less than five  
15          hundred dollars.

16          **SECTION 3. AMENDMENT.** Section 53-01-09 of the North Dakota Century Code is  
17          amended and reenacted as follows:

18          **53-01-09. Fees paid into special fund - Continuing appropriation.**

19          All fees collected by the secretary of state pursuant to this chapter must be deposited in a  
20          special fund maintained in the state treasury. All money deposited in the fund is appropriated as  
21          a continuing appropriation to the secretary of state for administering this chapter and for the  
22          compensation and expenses of members of the ~~athletic advisory board and the mixed fighting~~  
23          ~~style advisory board~~combative sports commission.
