LB 1195 introduces several key changes to the legal framework in Nebraska. Firstly, it revises the definition of what constitutes a legal profession shortage area.

Additionally, the bill brings about modifications in the provisions concerning county attorneys and public defenders. These modifications encompass various aspects such as their employment practices, compensation structures, and limitations on their ability to engage in private practice.

LB1195 addresses the financial aspects related to these roles by stipulating the payment procedures for expenses incurred by county attorneys, public defenders, coroners, and attorneys working in these offices. The bill aims to harmonize various provisions within the existing legal statutes and repeals the original sections that are being amended.

There is no fiscal impact for the state.

Explanation of Estimate:

LB 1195 would increase the definition of designated legal profession shortage area from 15,000 to 75,000 under the Legal Education for Public Service and Rural Practice Loan Repayment Assistance Act; provide that the education and licensure requirements for county attorneys and public defenders would be included in their budgets; transfer funds within the State Settlement Cash Fund for Legal Education for Public Service and Rural Practice Loan Repayment Assistance Fund.

There is not expected to be a significant annual fiscal impact to counties as a result of proposed changes.
