LEGISLATIVE BILL 1206

Committee:

- 1 A BILL FOR AN ACT relating to appropriations; to appropriate federal
- funds to the Board of Trustees of the Nebraska State Colleges; and
- 3 to declare an emergency.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) The Legislature hereby finds and declares that:
- 2 (a) The COVID-19 public health emergency significantly impacted how
- 3 <u>the Nebraska State Colleges operate and emphasized the need to make</u>
- 4 investments that will result in a significant return on investment for
- 5 Nebraska by (i) generating a long-term reduction in costs, (ii)
- 6 strengthening workforce and economic development, and (iii) improving
- 7 student success and safety;
- 8 (b) Investing in energy efficiency upgrades presents an opportunity
- 9 to generate long-term cost savings for students and Nebraska. Expanding
- 10 <u>the geothermal, solar energy, and natural gas footprint at each Nebraska</u>
- 11 <u>state college aligns with existing infrastructure investments and</u>
- 12 provides an avenue for more efficient and healthy air handling systems
- 13 <u>for students;</u>
- 14 (c) The public health emergency has increased the need for
- 15 <u>investments</u> in key workforce shortage areas in the state where program
- 16 <u>expansion in these critical areas seeks to increase student enrollment in</u>
- 17 these essential workforce areas;
- 18 <u>(d) Investments in state-of-the-art equipment improve the</u>
- 19 <u>educational experience for new and existing students; and</u>
- 20 <u>(e) An evolution in the teaching and learning process requires new</u>
- 21 instructional technologies to foster student access due to the pandemic.
- 22 Expanding controlled access of key access points increases security for
- 23 <u>students and staff. Additionally, increased cybersecurity threats to</u>
- 24 faculty, staff, and student data warrant critical investments in common
- 25 cybersecurity infrastructure to protect these data into the future.
- 26 (2) There is hereby appropriated \$44,300,000 from Federal Funds for
- 27 <u>FY2022-23 to the Board of Trustees of the Nebraska State Colleges for the</u>
- 28 purposes described in subsection (3) of this section. The Federal Funds
- 29 appropriated in this section are from the funds allocated to the State of
- 30 Nebraska from the federal Coronavirus State Fiscal Recovery Fund pursuant
- 31 to the federal American Rescue Plan Act of 2021, Public Law 117-2,

- 1 Subtitle M, Sec. 9901.
- 2 (3) The Board of Trustees of the Nebraska State Colleges shall use
- 3 the funds appropriated in this section for the following purposes:
- 4 (a) Improvement to air quality and energy efficiency;
- 5 (b) Improvement to information technology infrastructure and
- 6 <u>cybersecurity;</u>
- 7 (c) Acquisition of instructional equipment;
- 8 (d) Enhancement of instructional facilities to support workforce
- 9 programs to address workforce shortages in Nebraska; and
- 10 <u>(e) Upgrades to water and sewer infrastructure.</u>
- 11 Sec. 2. Since an emergency exists, this act takes effect when
- 12 passed and approved according to law.
