- 18 38-129 (1) No individual shall be issued a credential under the
- 19 Uniform Credentialing Act until the individual he or she has furnished
- 20 satisfactory evidence to the department that the individual:
- 21 <u>(a) Is</u> he or she is of good character;
- 22 (b) Has and has attained the age of nineteen years except as
- 23 otherwise specifically provided by statute, rule, or regulation; and -
- 24 (c) Except as provided in subsection (2) of section 3 of this act,
- 25 beginning October 1, 2024, has completed implicit bias or diversity,
- 26 equity, and inclusion training as defined in section 3 of this act.
- 27 (2) A credential may only be issued to (a) a citizen of the United
- 28 States, (b) an alien lawfully admitted into the United States who is
- 29 eligible for a credential under the Uniform Credentialing Act, (c) a
- 30 nonimmigrant lawfully present in the United States who is eligible for a
- 31 credential under the Uniform Credentialing Act, or (d) a person who

- 1 submits (i) an unexpired employment authorization document issued by the
- 2 United States Department of Homeland Security, Form I-766, and (ii)
- 3 documentation issued by the United States Department of Homeland
- 4 Security, the United States Citizenship and Immigration Services, or any
- 5 other federal agency, such as one of the types of Form I-797 used by the
- 6 United States Citizenship and Immigration Services, demonstrating that
- 7 such person is described in section 202(c)(2)(B)(i) through (x) of the
- 8 federal REAL ID Act of 2005, Public Law 109-13. Such credential shall be
- 9 valid only for the period of time during which such person's employment
- 10 authorization document is valid.
- 11 Sec. 3. (1) Except as provided in subsection (2) of this section,
- 12 beginning with the first credential renewal period which begins on or
- 13 <u>after October 1, 2024, every person holding a credential under the</u>
- 14 Uniform Credentialing Act shall annually complete implicit bias or
- 15 <u>diversity</u>, equity, and inclusion training.
- 16 (2) This section and subdivision (1)(c) of section 38-129 do not
- 17 apply to persons credentialed to engage in the practice of asbestos
- 18 abatement, inspection, project design, and training; athletic training;
- 19 body art; cosmetology; electrology; esthetics; funeral directing and
- 20 embalming; hearing instrument dispensing and fitting; lead-based paint
- 21 <u>abatement</u>, inspection, project design, and training; nail technology;
- 22 radon detection, measurement, and mitigation; or veterinary medicine and
- 23 surgery or to a registered environmental health specialist.
- 24 (3)(a) For purposes of this section, implicit bias or diversity,
- 25 equity, and inclusion training means a program designed to increase
- 26 <u>awareness of prejudices or partialities, provide tools that facilitate</u>
- 27 <u>positive interpersonal and intergroup interaction, reduce prejudice and</u>
- 28 <u>discrimination</u>, and afford all individuals the opportunity to interact
- 29 <u>fully and effectively in medical settings, thereby reducing inequitable</u>
- 30 <u>health treatments and outcomes.</u>
- 31 (b) The department may approve implicit bias training or diversity,

1 equity, and inclusion training provided by a national or state medical

- 2 <u>association to qualify as implicit bias training under this section.</u>
