1 Section 1. Section 71-401, Revised Statutes Cumulative

- 2 Supplement, 2012, is amended to read:
- 3 71-401 Sections 71-401 to 71-468 <u>and sections 2 and 3 of</u>
- 4 this act shall be known and may be cited as the Health Care Facility
- 5 Licensure Act.
- 6 Sec. 2. (1) The Department of Health and Human Services
- 7 shall develop and maintain a dedicated stable Internet web page on
- 8 the web site of the Department of Health and Human Services to
- 9 provide the information described in this section and section
- 10 28-327.01. No information regarding who uses the web page shall be
- 11 collected or maintained. The department shall monitor the web page on
- 12 <u>a regular basis to prevent and correct tampering and shall</u>
- 13 immediately notify health care facilities which provide abortions as
- 14 <u>defined in section 28-326 of any change in the location of the</u>
- 15 <u>material on the web page.</u>
- 16 (2) The department shall ensure that the web page:
- 17 (a) Uses enhanced, user-friendly search capabilities to
- 18 ensure that the information described in this section and section
- 19 28-327.01 is easily accessible and is searchable by keywords and
- 20 phrases, specifically to ensure that entering the terms "abortion"
- 21 and "abortion information" yields the information described in this
- 22 section and section 28-327.01, regardless of how such information is
- 23 <u>labeled;</u>
- 24 (b) Allows for the printing of such information other
- 25 <u>than videos;</u>

(c) Gives clear, prominent instructions on how to obtain 1 2 the information in printed form; and 3 (d) Is accessible to the public without requiring 4 registration or use of a user name, a password, or another user 5 identification. 6 (3) The department shall include a link on the web page 7 developed under subsection (1) of this section to the web site of The 8 Endowment for Human Development, which contains video of ultrasound 9 images, using the best available ultrasound technology, of a fetus at 10 two-week gestational increments. 11 Sec. 3. If a health care facility which provides 12 abortions as defined in section 28-326 has a web site, the health 13 care facility shall place on the home page of the web site a direct 14 link to the web page developed pursuant to section 2 of this act which contains the materials described in section 2 of this act. The 15 16 language of the link shall be maintained at a minimum resolution of seventy dots per inch. All letters on the link shall be a minimum of 17 fourteen-point font. The link shall read as follows: "The Nebraska 18 Department of Health and Human Services maintains a web page 19 20 containing objective, nonjudgmental, scientifically accurate 21 information about the development of the unborn child, as well as a 22 link to videos of ultrasound images of the unborn child at various stages of development. The web page also has information on 23 alternatives to abortion and a comprehensive list on where to obtain 24 an ultrasound free of charge. The web page can be reached by clicking 25
