1 FOR AN ACT relating to state aid to schools; to amend section 79-1007.17, Reissue Revised Statutes of Nebraska, and 2 3 sections 77-3446, 79-1003, 79-1003.01, 79-1007.07, 79-1007.09, 79-1007.11, 79-1007.18, 79-1007.23, 79-1007.25, 79-1015.01, and 79-1028.01, Revised Statutes 5 Cumulative Supplement, 2012; to redefine a term; to 6 change provisions relating to the base limitation, 7 8 allowances, reports, calculation of formula need, 9 adjustments, and local system formula resources; to harmonize provisions; to repeal the original sections; 10 and to declare an emergency. 11

12 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 77-3446, Revised Statutes Cumulative

- 2 Supplement, 2012, is amended to read:
- 3 77-3446 Base limitation means the budget limitation rate
- 4 applicable to school districts and the limitation on growth of
- 5 restricted funds applicable to other political subdivisions prior to
- 6 any increases in the rate as a result of special actions taken by a
- 7 supermajority of any governing board or of any exception allowed by
- 8 law. The base limitation is two and one-half percent until adjusted,

- 11 certified in the budget statement adopted pursuant to the Nebraska
- 12 Budget Act, except that for purposes of the limitation imposed in

- 9 number of students with limited English proficiency in a district
- 10 from the most recent data available on November 1 of the school
- 11 fiscal year preceding the school fiscal year in which aid is to be
- 12 paid plus the difference of such students with limited English
- 13 proficiency minus the average number of limited English proficiency
- 14 students for such district, prior to such addition, for the three
- 15 immediately preceding school fiscal years if such difference is
- 16 greater than zero;
- 17 (27) Local system means a learning community for purposes
- 18 of calculation of state aid for the second full school fiscal year
- 19 after becoming a learning community and each school fiscal year
- 20 thereafter, a unified system, a Class VI district and the associated
- 21 Class I districts, or a Class II, III, IV, or V district and any
- 22 affiliated Class I districts or portions of Class I districts. The
- 23 membership, expenditures, and resources of Class I districts that are

- 13 years of age residing in the district as derived from income tax

- 15 (30) Most recently available complete data year means the
- 16 most recent single school fiscal year for which the annual financial
- 17 report, fall school district membership report, annual statistical
- 18 summary, Nebraska income tax liability by school district for the
- 19 calendar year in which the majority of the school fiscal year falls,
- 20 and adjusted valuation data are available;
- 21 (31) Poverty students means the number of low-income
- 22 students or the number of students who are free lunch and free milk
- 23 students in a district plus the difference of the number of low-
- 24 income students or the number of students who are free lunch and free
- 25 milk students in a district, whichever is greater, minus the average

1 number of poverty students for such district, prior to such addition,

2 for the three immediately preceding school fiscal years if such

3 difference is greater than zero;

(32) Qualified early childhood education average daily 4 5 membership means the product of the average daily membership for school fiscal year 2006-07 and each school fiscal year thereafter of 6 7 students who will be eligible to attend kindergarten the following 8 school year and are enrolled in an early childhood education program approved by the department pursuant to section 79-1103 for such 9 school district for such school year multiplied by the ratio of the 10 actual instructional hours of the program divided by one thousand 11 12 thirty-two if: (a) The program is receiving a grant pursuant to such 13 section for the third year; (b) the program has already received grants pursuant to such section for three years; or (c) the program 14 15 has been approved pursuant to subsection (5) of section 79-1103 for 16 such school year and the two preceding school years, including any such students in portions of any of such programs receiving an 17 18 expansion grant;
