- FOR AN ACT relating to the Barber Act; to amend sections 71-202.01 and 71-208.01, Reissue Revised Statutes of Nebraska; to define a term; to harmonize provisions; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 71-202.01, Reissue Revised Statutes of

- 3 71-202.01 For purposes of the Barber Act, unless the
- 4 context otherwise requires:
- 5 (1) Barber shall mean any person who engages in the
- 6 practice of any act of barbering;
- 7 (2) Barber pole shall mean a cylinder or pole with
- 8 alternating stripes of red, white, and blue or any combination of
- 9 them which run diagonally along the length of the cylinder or pole;
- 10 (2)—(3) Barber shop shall mean an establishment or place
- 11 of business properly licensed as required by the act where one or
- 12 more persons properly licensed are engaged in the practice of
- 13 barbering but shall not include barber schools or colleges;
- 14 (3) (4) Barber school or college shall mean an
- 15 establishment properly licensed and operated for the teaching and
- 16 training of barber students;
- 17 (4)—(5) Board shall mean the Board of Barber Examiners;
- 18 (5) (6) Manager shall mean a licensed barber having
- 19 control of the barber shop and of the persons working or employed
- 20 therein;
- 21 $\frac{(6)}{(7)}$ License shall mean a certificate of registration
- 22 issued by the board;
- (7) Barber instructor shall mean a teacher of the
- 24 barber trade as provided in the act;
- 25 (8) (9) Assistant barber instructor shall mean a teacher

- (9) Registered or licensed barber shall mean a
- 4 person who has completed the requirements to receive a certificate as
- 5 a barber and to whom a certificate has been issued;
- 6 (10)-(11) Secretary of the board shall mean the director
- 7 appointed by the board who shall keep a record of the proceedings of
- 8 the board; and
- 9 $\frac{(11)-(12)}{(12)}$ Student shall mean a person attending an
- 10 approved, licensed barber school or college, duly registered with the
- 11 board as a student engaged in learning and acquiring any and all of
- 12 the practices of barbering, and who, while learning, performs and
- 13 assists any of the practices of barbering in a barber school or
- 14 college.
- Sec. 2. Section 71-208.01, Reissue Revised Statutes of
- 16 Nebraska, is amended to read:
- 17 71-208.01 No school or college of barbering shall be
- 18 approved by the Board of Barber Examiners which shall pay any wages,
- 19 commissions, or gratuities of any kind to barber students for barber
- 20 work while in training or while enrolled as students in such school
- 21 or college. No barber shop as defined in subdivision (2) of section
- 22 71-202.01 shall be operated by or in connection with any barber
- 23 school or college.
- 24 Sec. 3. Original sections 71-202.01 and 71-208.01,
- 25 Reissue Revised Statutes of Nebraska, are repealed.
