- 1 A BILL FOR AN ACT relating to motor vehicles; to amend section 60-4,115,
- 2 Revised Statutes Cumulative Supplement, 2022; to change the
- 3 allocation of fees for operators' licenses and state identification
- 4 cards as prescribed; to provide an operative date; to repeal the
- 5 original section; and to declare an emergency.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-4,115, Revised Statutes Cumulative Supplement,
2 2022, is amended to read:

3 60-4,115 (1) Fees for operators' licenses and state identification
4 cards shall be collected by department personnel or the county treasurer
5 and distributed according to the table in subsection (2) of this section,
6 except for the ignition interlock permit and associated fees as outlined
7 in subsection (4) of this section and the 24/7 sobriety program permit
8 and associated fees as outlined in subsection (5) of this section. County
9 officials shall remit the county portion of the fees collected to the
10 county treasurer for placement in the county general fund. All other fees
11 collected shall be remitted to the State Treasurer for credit to the
12 appropriate fund.

13 (2) The fees provided in this subsection in the following dollar
14 amounts apply for operators' licenses and state identification cards.

4 (3) If the department issues an operator's license or a state
5 identification card and collects the fees, the department shall remit the
6 county portion of the fees to the State Treasurer for credit to the
7 Department of Motor Vehicles Cash Fund.

8 (4)(a) The fee for an ignition interlock permit shall be forty-five
9 dollars. Five dollars of the fee shall be remitted to the State Treasurer
10 for credit to the Department of Motor Vehicles Cash Fund. Forty dollars
11 of the fee shall be remitted to the State Treasurer for credit to the
12 Department of Motor Vehicles Ignition Interlock Fund.

13 (b) The fee for a replacement ignition interlock permit shall be
14 eleven dollars. Two dollars and seventy-five cents of the fee shall be
15 remitted to the county treasurer for credit to the county general fund.
16 Eight Six dollars and twenty-five cents of the fee shall be remitted to
17 the State Treasurer for credit to the Department of Motor Vehicles Cash
18 Fund. ~~Two dollars and twenty-five cents of the fee shall be remitted to~~
19 ~~the State Treasurer for credit to the General Fund.~~

20 (c) The fee for adding, changing, or removing a class, endorsement,
21 or restriction on an ignition interlock permit shall be five dollars. The
22 fee shall be remitted to the State Treasurer for credit to the Department
23 of Motor Vehicles Cash Fund.

24 (5)(a) The fee for a 24/7 sobriety program permit shall be forty-
25 five dollars. Forty Twenty-five dollars of the fee shall be remitted to
26 the State Treasurer for credit to the Department of Motor Vehicles Cash
27 Fund. ~~Fifteen dollars of the fee shall be remitted to the State Treasurer~~
28 ~~for credit to the General Fund.~~ Five dollars of the fee shall be remitted
29 to the county treasurer for credit to the county general fund.

30 (b) The fee for a replacement 24/7 sobriety program permit shall be
31 eleven dollars. Two dollars and seventy-five cents of the fee shall be

1 remitted to the county treasurer for credit to the county general fund.
2 Eight Six dollars and twenty-five cents of the fee shall be remitted to
3 the State Treasurer for credit to the Department of Motor Vehicles Cash
4 Fund. ~~Two dollars and twenty-five cents of the fee shall be remitted to~~
5 ~~the State Treasurer for credit to the General Fund.~~

6 (c) The fee for adding, changing, or removing a class, endorsement,
7 or restriction on a 24/7 sobriety program permit shall be five dollars.
8 The fee shall be remitted to the State Treasurer for credit to the
9 Department of Motor Vehicles Cash Fund.

10 (6) The department and its agents may collect an identity security
11 surcharge to cover the cost of security and technology practices used to
12 protect the identity of applicants for and holders of operators' licenses
13 and state identification cards and to reduce identity theft, fraud, and
14 forgery and counterfeiting of such licenses and cards to the maximum
15 extent possible. The surcharge shall be in addition to all other required
16 fees for operators' licenses and state identification cards. The amount
17 of the surcharge shall be determined by the department. The surcharge
18 shall not exceed eight dollars. The surcharge shall be remitted to the
19 State Treasurer for credit to the Department of Motor Vehicles Cash Fund.

20 Sec. 2. This act becomes operative on July 1, 2023.

21 Sec. 3. Original section 60-4,115, Revised Statutes Cumulative
22 Supplement, 2022, is repealed.

23 Sec. 4. Since an emergency exists, this act takes effect when
24 passed and approved according to law.
