- 23 authorized and directed to draw his or her warrants upon the funds in the
- 24 state treasury enumerated in this act, in favor of the several
- 25 <u>beneficiaries named in this act for the amount set opposite their</u>
- 26 respective names, upon the presentation of proper vouchers therefor. The
- 27 several amounts appropriated in this act shall be in full payment of any
- 28 and all claims, rights, causes of action, damages, and demands of every
- 29 character and kind owing by or against the State of Nebraska, its
- 30 officers, agents, and employees, and their successors and assigns with
- 31 respect to each of the beneficiaries respectively in whose favor the

- 1 appropriations are made. The director shall not deliver any warrant for
- 2 any items appropriated in this act until a receipt and release in full,
- 3 releasing the State of Nebraska, its officers, employees, and agents, and
- 4 their successors and assigns, has been filed by each of the beneficiaries
- 5 <u>respectively. Upon presentation of the warrants, the State Treasurer is</u>
- 6 hereby directed to pay the same out of money in the General Fund or out
- 7 of money in other funds indicated in this act not otherwise appropriated.
