1	FOR AN ACT relating to schools; to amend section 79-725, Reissue
2	Revised Statutes of Nebraska, and sections 79-318 and
3	79-724, Revised Statutes Cumulative Supplement, 2012; to
4	prohibit rules and regulations requiring teachers to lead
5	students in the pledge of allegiance; to harmonize
6	provisions; and to repeal the original sections.
7	Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-318, Revised Statutes Cumulative

- 2 Supplement, 2012, is amended to read:
- 3 79-318 The State Board of Education shall:
- 4 (1) Appoint and fix the compensation of the Commissioner
- 5 of Education;
- 6 (2) Remove the commissioner from office at any time for
- 7 conviction of any crime involving moral turpitude or felonious act,
- 8 for inefficiency, or for willful and continuous disregard of his or
- 9 her duties as commissioner or of the directives of the board;
- 10 (3) Upon recommendation of the commissioner, appoint and
- 11 fix the compensation of a deputy commissioner and all professional
- 12 employees of the board;
- 13 (4) Organize the State Department of Education into such
- 14 divisions, branches, or sections as may be necessary or desirable to
- 15 perform all its proper functions and to render maximum service to the
- 16 board and to the state school system;
- 17 (5) Provide, through the commissioner and his or her
- 18 professional staff, enlightened professional leadership, guidance,
- 19 and supervision of the state school system, including educational
- 20 service units. In order that the commissioner and his or her staff
- 21 may carry out their duties, the board shall, through the
- 22 commissioner: (a) Provide supervisory and consultation services to
- 23 the schools of the state; (b) issue materials helpful in the
- 24 development, maintenance, and improvement of educational facilities
- 25 and programs; (c) establish rules and regulations which govern

standards and procedures for the approval and legal operation of all 1 2 schools in the state and for the accreditation of all schools 3 requesting state accreditation. All public, private, denominational, or parochial schools shall either comply with the accreditation or 4 5 approval requirements prescribed in this section and section 79-703 or, for those schools which elect not to meet accreditation or 6 7 approval requirements, the requirements prescribed in subsections (2) 8 through (6) of section 79-1601. Standards and procedures for approval and accreditation shall be based upon the program of studies, 9 guidance services, the number and preparation of teachers in relation 10 11 to the curriculum and enrollment, instructional materials 12 equipment, science facilities and equipment, library facilities and materials, and health and safety factors in buildings and grounds. 13 14 Rules and regulations which govern standards and procedures for private, denominational, and parochial schools which elect, pursuant 15 to the procedures prescribed in subsections (2) through (6) of 16 17 section 79-1601, not to meet state accreditation or approval requirements shall be as described in such section; (d) institute a 18 statewide system of testing to determine the degree of achievement 19 20 and accomplishment of all the students within the state's school systems if it determines such testing would be advisable; (e) 21 prescribe a uniform system of records and accounting for keeping 22 23 adequate educational and financial records, for gathering and reporting necessary educational data, and for evaluating educational 24 progress; (f) cause to be published laws, rules, and regulations 25

governing the schools and the school lands and funds with explanatory 1 2 notes for the guidance of those charged with the administration of 3 the schools of the state; (g) approve teacher education programs 4 conducted in Nebraska postsecondary educational institutions designed 5 for the purpose of certificating teachers and administrators; (h) approve certificated-employee evaluation policies and procedures 6 7 developed by school districts and educational service units; and (i) approve general plans and adopt educational policies, standards, 8 9 rules, and regulations for carrying out the board's responsibilities 10 and those assigned to the State Department of Education by the Legislature; 11 12 (6) Adopt and promulgate rules and regulations for the 13 guidance, supervision, accreditation, and coordination of educational service units. Such rules and regulations for accreditation shall 14 15 include, but not be limited to, (a) a requirement that programs and 16 services offered to school districts by each educational service unit shall be evaluated on a regular basis, but not less than every seven 17 years, to assure that educational service units remain responsive to 18 school district needs and (b) guidelines for the use and management 19 20 of funds generated from the property tax levy and from other sources 21 of revenue as may be available to the educational service units, to assure that public funds are used to accomplish the purposes and 22 23 goals assigned to the educational service units by section 79-1204. 24 The State Board of Education shall establish procedures to encourage the coordination of activities among educational service units and to 25

1 encourage effective and efficient educational service delivery on a

- 2 statewide basis;
- 3 (7) Submit a biennial report to the Governor and the
- 4 Clerk of the Legislature covering the actions of the board, the
- 5 operations of the State Department of Education, and the progress and
- 6 needs of the schools and recommend such legislation as may be
- 7 necessary to satisfy these needs. The report submitted to the Clerk
- 8 of the Legislature shall be submitted electronically;
- 9 (8) Prepare and distribute reports designed to acquaint
- 10 school district officers, teachers, and patrons of the schools with
- 11 the conditions and needs of the schools;
- 12 (9) Provide for consultation with professional educators
- 13 and lay leaders for the purpose of securing advice deemed necessary
- 14 in the formulation of policies and in the effectual discharge of its
- 15 duties;
- 16 (10) Make studies, investigations, and reports and
- 17 assemble information as necessary for the formulation of policies,
- 18 for making plans, for evaluating the state school program, and for
- 19 making essential and adequate reports;
- 20 (11) Submit to the Governor and the Legislature a budget
- 21 necessary to finance the state school program under its jurisdiction,
- 22 including the internal operation and maintenance of the State
- 23 Department of Education;
- 24 (12) Interpret its own policies, standards, rules, and
- 25 regulations and, upon reasonable request, hear complaints and

1 disputes arising therefrom;

2 (13) With the advice of the Department of Motor Vehicles, 3 adopt and promulgate rules and regulations containing reasonable standards, not inconsistent with existing statutes, governing: (a) 4 5 The general design, equipment, color, operation, and maintenance of any vehicle with a manufacturer's rated seating capacity of eleven or 6 7 more passengers used for the transportation of public, private, 8 denominational, or parochial school students; and (b) the equipment, operation, and maintenance of any vehicle with a capacity of ten or 9 less passengers used for the transportation of public, private, 10 11 denominational, or parochial school students, when such vehicles are 12 owned, operated, or owned and operated by any public, private, 13 denominational, or parochial school or privately owned or operated 14 under contract with any such school in this state, except for 15 vehicles owned by individuals operating a school which elects pursuant to section 79-1601 not to meet accreditation or approval 16 requirements. Similar rules and regulations shall be adopted and 17 promulgated for operators of such vehicles as provided in section 18 79-607; 19 20 (14) Accept, on behalf of the Nebraska Center for the Education of Children who are Blind or Visually Impaired, devises of 21 22 real property or donations or bequests of other property, or both, if 23 in its judgment any such devise, donation, or bequest is for the best interest of the center or the students receiving services from the 24 25 center, or both, and irrigate or otherwise improve any such real

1 estate when in the board's judgment it would be advisable to do so;

- 2 (15) Accept, in order to administer the Interstate
- 3 Compact on Educational Opportunity for Military Children, any devise,
- 4 donation, or bequest received by the State Department of Education
- 5 pursuant to section 79-2206; and
- 6 (16) Upon acceptance of any devise, donation, or bequest
- 7 as provided in this section, administer and carry out such devise,
- 8 donation, or bequest in accordance with the terms and conditions
- 9 thereof. If not prohibited by the terms and conditions of any such
- 10 devise, donation, or bequest, the board may sell, convey, exchange,
- 11 or lease property so devised, donated, or bequeathed upon such terms
- 12 and conditions as it deems best and remit all money derived from any
- 13 such sale or lease to the State Treasurer for credit to the State
- 14 Department of Education Trust Fund.
- 15 Each member of the Legislature shall receive an
- 16 electronic copy of the report required by subdivision (7) of this
- 17 section by making a request for it to the commissioner.
- 18 None of the duties prescribed in this section shall
- 19 prevent the board from exercising such other duties as in its
- 20 judgment may be necessary for the proper and legal exercise of its
- 21 obligations, except that nothing in this section authorizes the State
- 22 Board of Education to adopt and promulgate rules or regulations
- 23 requiring teachers in the public schools to lead students in
- 24 recitation of the pledge of allegiance to the United States flag. Any
- 25 <u>such rule or regulation adopted by the board before the effective</u>

- 1 date of this act is hereby declared null and void.
- 2 Sec. 2. Section 79-724, Revised Statutes Cumulative
- 3 Supplement, 2012, is amended to read:
- 4 79-724 An informed, loyal, just, and patriotic citizenry
- 5 is necessary to a strong, stable, just, and prosperous America. Such
- 6 a citizenry necessitates that every member thereof be fully
- 7 acquainted with the nation's history and that he or she be in full
- 8 accord with our form of government and fully aware of the liberties,
- 9 opportunities, and advantages of which we are possessed and the
- 10 sacrifices and struggles of those through whose efforts these
- 11 benefits were gained. Since youth is the time most susceptible to the
- 12 acceptance of principles and doctrines that will influence men and
- 13 women throughout their lives, it is one of the first duties of our
- 14 educational system to conduct its activities, choose its textbooks,
- 15 and arrange its curriculum in such a way that the love of liberty,
- 16 justice, democracy, and America will be instilled in the hearts and
- 17 minds of the youth of the state.
- 18 (1) Every school board shall, at the beginning of each
- 19 school year, appoint from its members a committee of three, to be
- 20 known as the committee on Americanism. The committee on Americanism
- 21 shall:
- 22 (a) Carefully examine, inspect, and approve all textbooks
- 23 used in the teaching of American history and civil government in the
- 24 school. Such textbooks shall adequately stress the services of the
- 25 men and women who achieved our national independence, established our

1 constitutional government, and preserved our union and shall be so

- 2 written to include contributions by ethnic groups as to develop a
- 3 pride and respect for our institutions and not be a mere recital of
- 4 events and dates;
- 5 (b) Assure themselves as to the character of all teachers
- 6 employed and their knowledge and acceptance of the American form of
- 7 government; and
- 8 (c) Take all such other steps as will assure the carrying
- 9 out of the provisions of this section.
- 10 (2) All American history courses approved for grade
- 11 levels as provided by this section shall include and adequately
- 12 stress contributions of all ethnic groups (a) to the development and
- 13 growth of America into a great nation, (b) to art, music, education,
- 14 medicine, literature, science, politics, and government, and (c) to
- 15 the war services in all wars of this nation.
- 16 (3) All grades of all public, private, denominational,
- 17 and parochial schools, below the sixth grade, shall devote at least
- 18 one hour per week to exercises or teaching periods for the following
- 19 purpose:
- 20 (a) The recital of stories having to do with American
- 21 history or the deeds and exploits of American heroes;
- 22 (b) The singing of patriotic songs and the insistence
- 23 that every pupil memorize the Star-Spangled Banner and America; and
- 24 (c) The development of reverence for the flag and
- 25 instruction as to proper conduct in its presentation, except that

1 nothing in this section authorizes the State Board of Education to

- 2 adopt and promulgate rules and regulations requiring teachers in the
- 3 public schools to lead students in recitation of the pledge of
- 4 allegiance to the United States flag. Any such rule or regulation
- 5 adopted by the board before the effective date of this act is hereby
- 6 <u>declared null and void</u>.
- 7 (4) In at least two of the three grades from the fifth
- 8 grade to the eighth grade in all public, private, denominational, and
- 9 parochial schools, at least three periods per week shall be set aside
- 10 to be devoted to the teaching of American history from approved
- 11 textbooks, taught in such a way as to make the course interesting and
- 12 attractive and to develop a love of country.
- 13 (5) In at least two grades of every high school, at least
- 14 three periods per week shall be devoted to the teaching of civics,
- 15 during which courses specific attention shall be given to the
- 16 following matters:
- 17 (a) The United States Constitution and the Constitution
- 18 of Nebraska;
- 19 (b) The benefits and advantages of our form of government
- 20 and the dangers and fallacies of Nazism, Communism, and similar
- 21 ideologies; and
- 22 (c) The duties of citizenship, including active
- 23 participation in the improvement of a citizen's community, state,
- 24 country, and world and the value and practice of civil discourse
- 25 between opposing interests.

1 (6) Appropriate patriotic exercises suitable to the

- 2 occasion shall be held under the direction of the superintendent in
- 3 every public, private, denominational, and parochial school on
- 4 Lincoln's birthday, Washington's birthday, Flag Day, Memorial Day,
- 5 and Veterans Day, or on the day preceding or following such holiday,
- 6 if the school is in session.
- 7 (7) Every school board, the State Board of Education, and
- 8 the superintendent of each school district in the state shall be held
- 9 directly responsible in the order named for carrying out this
- 10 section, and neglect thereof by any employee or appointed official
- 11 shall be considered a dereliction of duty and cause for dismissal.
- 12 Sec. 3. Section 79-725, Reissue Revised Statutes of
- 13 Nebraska, is amended to read:
- 14 79-725 Each teacher employed to give instruction in any
- 15 public, private, parochial, or denominational school in the State of
- 16 Nebraska shall arrange and present his or her instruction to give
- 17 special emphasis to common honesty, morality, courtesy, obedience to
- 18 law, respect for the national flag, the United States Constitution,
- 19 and the Constitution of Nebraska, respect for parents and the home,
- 20 the dignity and necessity of honest labor, and other lessons of a
- 21 steadying influence which tend to promote and develop an upright and
- 22 desirable citizenry. Nothing in this section authorizes the State
- 23 Board of Education to adopt and promulgate rules and regulations
- 24 requiring teachers in the public schools to lead students in
- 25 recitation of the pledge of allegiance to the United States flag. Any

1 such rule or regulation adopted by the board before the effective

- 2 <u>date of this act is hereby declared null and void.</u>
