## **LEGISLATIVE BILL 676**

### Committee:

- 1 A BILL FOR AN ACT relating to certified nurse midwives; to amend sections 2 38-206, 38-601, 38-603, 38-604, 38-606, 38-607, 38-608, 38-610, 3 38-611, and 44-2803, Reissue Revised Statutes of Nebraska; to 4 provide, change, and eliminate definitions; to eliminate practice agreements; to change and eliminate provisions relating to the 5 6 authorized scope of practice; to provide for applicability of the 7 Nebraska Hospital-Medical Liability Act; to harmonize provisions; to 8 repeal the original sections; and to outright repeal sections 38-609, 38-613, and 38-614, Reissue Revised Statutes of Nebraska. 9
- 10 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 38-206, Reissue Revised Statutes of Nebraska, is

- 3 38-206 The board shall:
- 4 (1) Establish standards for integrated practice agreements between
- 5 collaborating physicians and certified nurse midwives;
- 6 (1) (2) Monitor the scope of practice by certified nurse midwives,
- 7 certified registered nurse anesthetists, clinical nurse specialists, and
- 8 nurse practitioners;
- 9 (2) (3) Recommend disciplinary action relating to licenses of
- 10 advanced practice registered nurses, certified nurse midwives, certified
- 11 registered nurse anesthetists, clinical nurse specialists, and nurse
- 12 practitioners;
- 13 (3) (4) Engage in other activities not inconsistent with the
- 14 Advanced Practice Registered Nurse Practice Act, the Certified Nurse
- 15 Midwifery Practice Act, the Certified Registered Nurse Anesthetist
- 16 Practice Act, the Clinical Nurse Specialist Practice Act, and the Nurse
- 17 Practitioner Practice Act; and
- 18 (4) (5) Adopt rules and regulations to implement the Advanced
- 19 Practice Registered Nurse Practice Act, the Certified Nurse Midwifery
- 20 Practice Act, the Certified Registered Nurse Anesthetist Practice Act,
- 21 the Clinical Nurse Specialist Practice Act, and the Nurse Practitioner
- 22 Practice Act, for promulgation by the department as provided in section
- 23 38-126. Such rules and regulations shall also include: (a) Approved
- 24 certification organizations and approved certification programs; and (b)
- 25 professional liability insurance.

- 16 the State of Nebraska. Nothing in the Certified Nurse Midwifery Practice
- 17 Act is intended to restrict the practice of other health care providers
- 18 registered nurses.

- 21 38-607 Collaboration means a process and relationship in which a
- 22 certified nurse midwife works together with other health care providers
- 23 professionals to deliver health care within the scope of practice of
- 24 certified nurse midwifery as provided in the Certified Nurse Midwifery
- 25 Practice Act. The collaborative relationship between the physician and
- 26 the nurse midwife shall be subject to the control and regulation of the
- 27 board.
- Sec. 7. Consultation means a process whereby a certified nurse
- 29 <u>midwife seeks the advice or opinion of a physician or another health care</u>
- 30 provider.

- 9 38-610 Referral means a process whereby a certified nurse midwife

- 12 Supervision means the ready availability of a collaborating licensed
- 13 practitioner for consultation and direction of the activities of the
- 14 certified nurse midwife related to delegated medical functions as
- 15 outlined in the practice agreement.
- 16 Sec. 10. Section 38-611, Reissue Revised Statutes of Nebraska, is
- 17 amended to read:
- 18 38-611 (1) A certified nurse midwife may provide health care
- 19 <u>services within the midwife's specialty area. A certified nurse midwife</u>
- 20 shall function by establishing collaborative, consultative, and referral
- 21 <u>networks as appropriate with other health care professionals. A certified</u>
- 22 nurse midwife shall refer a patient who requires care beyond the scope of
- 23 practice of the certified nurse midwife to an appropriate health care
- 24 <u>provider</u>.
- 25 (2) The practice of a certified nurse midwife may include, but is
- 26 not limited to:
- 27 (a) Providing preconception, prenatal, intrapartum, and postpartum
- 28 <u>care;</u>
- 29 <u>(b) Providing gynecological services;</u>
- 30 <u>(c) Providing primary care for females;</u>
- 31 (d) Providing care for a newborn immediately following birth through

- 1 <u>twenty-eight days of age;</u>
- 2 <u>(e) Assessing patients, ordering diagnostic tests and therapeutic</u>
- 3 treatments, synthesizing and analyzing data, and applying advanced
- 4 nursing principles;
- 5 (f) Dispensing sample medications that are provided by the
- 6 manufacturer and are provided at no charge to the patient;
- 7 (g) Prescribing therapeutic measures and medications relating to
- 8 <u>health conditions within the scope of practice of a certified nurse</u>
- 9 midwife; and
- (h) Pronouncing death and completing and signing a death certificate
- and any other form if such activities are within the scope of practice of
- 12 the certified <u>nurse midwife and are not otherwise prohibited by law.</u>
- 13 A certified nurse midwife may, under the provisions of a practice
- 14 agreement, (1) attend cases of normal childbirth, (2) provide prenatal,
- 15 intrapartum, and postpartum care, (3) provide normal obstetrical and
- 16 gynecological services for women, and (4) provide care for the newborn
- 17 immediately following birth. The conditions under which a certified nurse
- 18 midwife is required to refer cases to a collaborating licensed
- 19 practitioner shall be specified in the practice agreement.

- 27 registered nurse anesthetists, or certified nurse midwives; (5) (4) a

- 29 30-2209 who is successor or assignee of any health care provider
- designated in subdivisions (1) through (5) (4) of this section.
